Dear Board of Supervisors Rules Committee,

Please accept this letter as a supplement to my application for the vacant tenant position (seat 9) on the SRO Task Force. Since October 2015, I have been a resident of a hotel managed by the Tenderloin Housing Clinic. I have been an active voice in tenant meetings, and have frequently been engaged with the issues facing the hotel. One organizing victory that I am proud of is that I led the campaign to remove gender-specific signage from the (single-occupancy) shower rooms, thus creating a safer space for transgender and disabled tenants.

Since February of 2016, I have served as a volunteer tenant leader in the Mission SRO Collaborative's leadership academy. I entered the Peer Outreach Program (or POP), an intensive six month program where I learned about tenant rights, organizing, city government, and more. I received a Certificate of Honor from the Board of Supervisors upon graduation, and in late 2016, came back for MSROC's year-long Tenants Are Rising program, focusing on facilitation, outreach, public speaking, and other advanced leadership skills. Highlights include teach-ins on ableism, accessibility, and non-profits as well as speaking at the press conference for Supervisor Aaron Peskin's amendments to the Hotel Conversion Ordinance, which passed in February 2017.

It is through MSROC that I continue to grow as an advocate for the rights of SRO tenants, especially those who are marginalized. In December 2014, I came to San Francisco from Pennsylvania homeless due to lack of services, much less culturally competent for disabled transwomen. The organization has helped me get back on track and realize my potential, and I would not be seeking to serve on the SRO Task Force if my MSROC mentors didn't highly recommend me to do so. (See attached letter of recommendation)

Independently, I have been a frequent speaker at board committees concerning issues around tenant, housing, and homeless rights in the city. Furthermore, I am in discussions with several supervisors concerning potential action to improve the lives of SRO tenants (especially those with disabilities), and those who are living in non-profit hotels, who often face similar health, safety, and building issues to those living in private hotels, but face a lack of legal protections and infantilizing policies, such as the inability for tenants like myself to pay rent by check and frequent elevator malfunctions, which hopefully will be addressed in the coming months.

Lastly, I would like to clarify that I have not been able to attend any meetings of the SRO Task Force, due to the fact that meetings restarted only a month ago after a gap of several years. However, I have reviewed minutes of past meetings and understand the functions of the task force as well as the general meeting structure, and would be able to meet the attendance policies.

The SRO Task Force consists of a total of thirteen (13) members. The Board of Supervisors appoints nine (9) voting members of the Task Force:

- > Seat 1 shall be held by a current tenant of an SRO.
- > Seat 2 shall be held by owners or operators of SROs.
- > Seat 3 shall be held by owners or operators of SROs.
- > Seat 4 shall be held by an employee or officer of a nonprofit organization that owns or operates an SRO.
- > Seat 5 shall be held by an employee or officer of the Mission SRO Collaborative,
- > Seat 6 shall be held by an employee or officer of the Central City SRO Collaborative.
- > Seat 7 shall be held by an employee or offlicer of the Chinatown SRO Collaborative.
- > Seat 8 shall be held by an employee or o(licer of the Families SRO Collaborative.
- > Seat 9 shall be held by a current tenant of an SRO.

In addition to the above nine (9) members, four (4) voting members shall be appointed to the Task Force by the heads of each of the following San Francisco departments/agencies:

- > Seat 10 shall be held by an employee of the Human Services Agency, appointed by the Director of the Human Services Agency.
- > Seat 11 shall be held by an employee of the Department of Building Inspection, appointed by

the Director of the Department of Building Inspection.

- > Seat 12 shall be held by an employee of the Department of Public Health working in the Housing and Urban Health Section, appointed by the Director of the Department of Public Health.
- > Seat 13 shall be held by an employee of the Department of Public Health working in the Environmental Health Section, appointed by the Director of the Department of Public Health.

Term of Office: Each member shall serve at the pleasure of the member's appointing authority, and

shall serve for the life of the Task Force unless removed by the appointing authority.

The Task Force shall assist the Board of Supervisors, the Mayor, and all City departments in achieving two primary goals:

- (1) that all SRO hotels in the City are safe, accessible, and stable places to reside, and
- (2) that affordable, healthy, and appropriate housing options are available in the City so that extremely low-income families do not have to raise their children in SRO hotels.

To achieve those goals, the Task Force shall identify and provide training and consultation; develop and recommend legislation, regulations, policies, and/or procedures; monitor compliance with relevant laws, regulations, policies, and/or procedures; recommend strategies to move families out of SROs and into permanent housing; advocate goals for assuring housing is affordable to extremely low-income

families; and advocate strategies to prevent families from losing their housing.

Reports: The SRO Task Force shall develop and recommend legislation, regulations, policies, and/or procedures to the Board of Supervisors, the Mayor, and City departments.

Sunset Date: The SRO Task Force shall sunset on December 31, 2018.
