[Liquor License - 2340 Chestnut Street]

Resolution determining that the issuance of a Type 40 on-sale beer license to Frank Lee, Jr., dba Presidio Theatre, located at 2340 Chestnut Street (District 2), will serve the public convenience or necessity of the City and County of San Francisco in accordance with California Business and Professions Code, Section 23958.4, and recommending that the California Department of Alcoholic Beverage Control impose conditions on the issuance of the license.

WHEREAS, Frank Lee, Jr., dba Presidio Theatre, is seeking the issuance of a Type 40 on-sale beer license, located at 2340 Chestnut Street (District 2); and

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

WHEREAS, The Police Department has filed zero (0) protests and zero (0) letters of support with the Department of Alcoholic Beverage Control under California Business and Professions Code, Section 24013, and recommends that the Department of Alcoholic Beverage Control issue the liquor license with conditions; and

WHEREAS, The conditions recommended by the Police Department are the following: 1) sales, service and consumption of alcoholic beverages shall be permitted between the hours of 10:00 a.m. and 1:00 a.m. each day of the week; 2) all sales of alcoholic beverages in the general spectator seating areas shall be made only from concession stands and shall not be sold, served, or delivered to customers by individual ambulatory venders, more commonly known as "hawkers"; 3) point of sale of alcoholic beverages shall not be maintained within the theater auditoriums; 4) guest shall have a valid ticket to a movie showing to purchase alcoholic beverage drinks for in-auditorium

consumption; 5) no more than two (2) alcoholic beverage shall be sold or served to any one (1) person during any transaction; 6) the sale of alcoholic beverages for off-sale consumption is strictly prohibited; 7) alcoholic beverages shall be served in containers which significantly differ in appearance from those containers utilized for non-alcoholic beverages; containers for alcoholic beverage shall not exceed 16 ounces; 8) at all times when the premises are exercising the privileges of their licenses, an employee of the premises shall enter and monitor the activity within the theater on a regular basis; 9) loitering (defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257; 10) the petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises and all parking lots under the control of the licensee within 72 hours following the beginning of the next weekday; now, therefore, be it







This letter is in response to Alcoholic Beverage License and Liquor License Review referral requests received by the Planning Department. Such applications are referred to the Planning Department to ensure that the proposed use is consistent with San Francisco's zoning regulations. At this time, the Planning Department cannot provide a recommendation for the zoning referrals.

According to Planning Department records, there is an open Code Enforcement Violation on the subject property (see attached Complaint ID 13358_ENF). The property owner is required to abate this open violation prior to a recommendation for the referrals. The referrals will be placed on hold until the violation is abated.

Please contact Zoning and Compliance planner Matthew Dito at (415) 575-9164 to address and abate the violation.

Notify me after the violation has been abated to resume review of your proposal to add on-sale beer with ABC License Type 40 (bar, tavern). A written description of the bar use must also be provided.

According to Planning Department records, the authorized use of the subject site is a theater use. Application for this type of alcoholic beverage license constitutes a bar.

Bar use is permitted in the applicable NC-2 Zoning District but it is considered a <u>change of use</u>, which requires that you file a <u>Building Permit Application</u>. Change of use proposals in the NC-2 Zoning District require that notice be provided to neighbors and property owners. This involves a 30-day notification period for neighborhood review and comment to the Planning Department. See our website and the attached Neighborhood Notification handout for more information.
