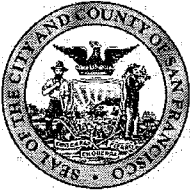
3 **Resolution approving Terminal 3 Boarding Area F Food and Beverage Concession**

9 WHEREAS, Upon the completion of a request for proposals process, the Airport
10 Commission awarded Terminal 3 Boarding Area F Food and Beverage Concession Lease
11 No. 16-0312 to the highest-ranking responsive and responsible proposer, Amoura
12 International, Inc., by Airport Commission Resolution No. 16-0312 adopted
13 December 6, 2016; and

14 WHEREAS, Terminal 3 Boarding Area F Food and Beverage Concession Lease
15 No. 16-0312 has a term of six years with two options to extend of one year each for a post-
16 security concession, and an initial Minimum Annual Guarantee of \$250,000; now, therefore,
17 be it

18 RESOLVED, That this Board of Supervisors hereby approves Terminal 3 Boarding
19 Area F Food and Beverage Concession Lease No. 16-0312, a copy of which is on file with the
20 Clerk of the Board of Supervisors in File No. 170259; and, be it

21 FURTHER RESOLVED, That within thirty days of the Lease being fully-executed by all
22 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
23 inclusion into the official file.
