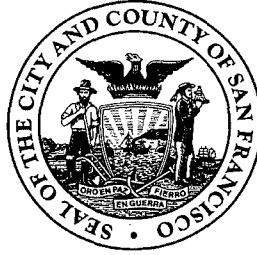

16 Business and Professions Code, Section 24013, and recommends that the Department  
17 of Alcoholic Beverage Control issue the liquor license with conditions; and

18 WHEREAS, The condition recommended by the Police Department is as follows:  
19 1) sales of alcoholic beverages shall be permitted only between the hours of 7:00 a.m.  
20 to 10:00 p.m. each day of the week; now, therefore, be it

22 **Section 23958.4, the Board of Supervisors of the City and County of San Francisco**  
23 **hereby determines that the transfer of a Type 20 off-sale beer and wine license to**

25 **convenience or necessity of the City and County of San Francisco; and, be it**






