# Re: Reappointment to the SF Police Commission

Dear Ms. Calvillo:

I am an attorney and a current member of the SF Police Commission. During my legal career I have represented low income individuals at California Rural Legal Assistance, Mission Community Legal Defense, and the San Francisco Public Defender's office. At Kazan, McClain, Satterley & Greenwood, I represent workers, bystanders, and their families who are ill or have died from exposure to asbestos.

As a Commissioner for the San Francisco Police Commission, I worked on a variety of issues. The highlights of which include, the election of the first transgender president of the Commission; approval of Language Access Service for Limited English Proficient Persons; the most comprehensive General Order to guarantee access of police services for all community members; approval of strict Policies and Procedures for Juvenile Detention, Arrest and Custody, to protect the rights of juveniles; modification of the Vehicle Towing Procedures for unlicensed drivers; and voting to develop and implement the first mental health crisis team in the Police Department.

Officer involved shootings and racist text messages in the last 18 months have been challenging for the Commission, the Department and San Francisco's communities of color. But these serious issues have provided the Commission an opportunity to collaborate with the communities most impacted by officer involved shootings to fundamentally change an officer's mindset surrounding the Use of Force. The Commission established a working group and held community meetings with advocacy groups, the command staff, the POA, and a consortium of legal groups associated with the San Francisco Bar Association in order to develop a new vision for the Department. The Commission ultimately re-engineered the Use of Force, General Order, to shift the focus on preserving life, creating time and distance, using critical thinking and the use

of proportional force. The Commission also approved the General Order for the implementation of body-worn cameras for all officers.

Further, the Department of Justice, COPS division reviewed the Department's General Orders, its procedures and culture for potential bias and then made numerous recommendations. The Commission is in the process of overseeing the execution of the DOJ's proposed recommendations. Lastly, the Commission was tasked to work with the community and develop criteria for selecting a new Chief of Police. I am honored to have participated in the selection of Chief William Scott and am confident that he will be an asset for all of our communities.

I am looking forward to implementing the DOJ's recommendations and providing support for Chief Scott during the next four years. I respectfully seek reappointment to this important Commission.

I write to encourage you to reappoint Petra DeJesus to the Police Commission.

I am the former Director of the Police Practices Project for the ACLU of Northern California. I have worked on law enforcement policy and accountability issues for decades. Both in my ACLU capacity and more recently throughout 2016 and 2017 now as a retiree and resident deeply concerned over problems in the SFPD and Department of Police Accountability (DPA, formerly OCC), I have appeared before and worked closely with a number of current and former police commissioners on a variety of issues of concern. The ACLU does not support or oppose candidates for appointed or elected office but, now that I can speak for myself rather than the ACLU, I am very pleased to be able to support Commissioner DeJesus's reappointment.

Commissioner DeJesus has proven — time and again — to be an important and persistent voice in favor of a variety of much-needed reforms in the SFPD as well as a champion of greater transparency and accountability. Not all police commissioners — especially those who serve a number of terms — remain rooted to the cause of improving the agencies they are charged with overseeing. Commissioner DeJesus has. It may sound simple but an unwavering desire to make things better is not something that can be taken for granted and her track record demonstrates the durability of her commitment. Incumbents have no particular right to reappointment. Reappointments should be be earned. Commissioner DeJesus has earned it.

She has earned it by speaking out and, where necessary and constructive, asking tough questions. The SFPD is not unique as a police institution in the defensiveness it sometimes displays in the face of controversies and problems. The overarching goal is a police department aligned as closely and as consistently as possible — in culture, policy and action — with the values of San Francisco. More than ever, that must be the Police Commission's "north star." I believe Commissioner DeJesus not only reflects those values but has consistently spoken up for and represented them in her commission service to date.



Dear Rules Committee and the Clerk of the Committee:

I am writing in support of Petra DeJesus's candidacy for reappointment to the San Francisco Police Commission. I am an attorney practicing primarily criminal defense in state and federal courts throughout Northern California. I was also a recent candidate for a vacancy on the Police Commission in late 2016. Both of those roles inform my strong endorsement of Petra DeJesus for reappointment to the Police Commission.

Our City has been through a great trauma arising out of the oft-fraught relationship between the San Francisco Police Department and the community. We are healing, but our status can be considered in intensive care, at best. It is crucial at this time, that we have competent, skilled and knowledgeable commissioners. Our police department, made up of many fine officers, has lacked the leadership and culture needed to bring our department in line with principles of 21st century policing.

The Police Commission has not always been the strongest forum for reform until relatively recently. Long viewed as a toothless oversight agency, that has changed gradually over the last five years. Commissioner DeJesus has been one of the strongest voices for reform on the Commission. Even when the votes have been stacked against reform, she has stood up for the community, our City and our police.

With the recent resignations of San Francisco Police Commission President Suzy Loftus and Commissioner Victor Hwang, aside from Commissioner DeJesus, the Commission is now completely lacking in commissioners with substantial criminal justice and policing background, training, and experience. Whether this is by design or accident, there are no other commissioners speaking from ground-level expertise in policing and criminal justice. As a criminal defense attorney practicing in San Francisco, I know all too well the dangers of a police department unchecked by strong oversight. We have witnessed it time and again in this city. On behalf of Neighbors United, I write to express our strong support of Petra DeJesus for re-appointment to the San Francisco Police Commission, and to ask that you undertake the critically important task of assuring that the Board stays committed to meaningful police reform. 

Dear Supervisors:

We are writing to request that you retain Petra de Jesus on the San Francisco Police Commission.

Petra's roots in the Mission District have made her a strong and credible voice for much needed police reform. Local people trust her because she listens well and understands the problems so many of us have faced at the hands of SFPD. As an accomplished attorney, she combines that understanding with an equally deep familiarity with San Francisco's law enforcement systems. She can effectively navigate within those systems to bring about changes demanded by San Franciscan communities of color.

SFPD is at a critical juncture of review and reform supervised by the Police Commission after receiving over 400 recommendations last year across five independent assessments. SFPD's credibility and even legitmacy suffers over a continued real and perceived lack of accountability for performing according to standards deemed biased and unfair by our communities in the Mission District, particularly after the killings at the hands of police officers of Alex Nieto, Amilcar Perez Lopez and Luis Góngora Pat have resulted in not the slightest consequence.

Petra de Jesus has a proven track record of listening to our community members and pursuing progressive minded reform, including her advocacy for community policing, helping elect the Commission 's first transgender president; her participation in the review of SFPD's policy on the use of Tasers; guaranteeing language access to police services for all community members; protecting the rights of juveniles; and helping implement SFPD's first mental health crisis team.

The over 400 recommendations, including the bulk by the COPS division of the DOJ, require an innovative, open minded, and progressive approach to policing.

Because of her roots in our communities and her proven track record on prior similar reforms, we ask that you retain her in this important position on the Commission at this critical juncture of reform. Without her presence on the Commission, we are certain that the recommended reforms will fail and so will the Board of Supervisors in their duty to ensure that SFPD meet best practices and standards in policing and reorganizing police forces in the country.

For the record, I apologize for the delay in writing this, but I am in support of Petra DeJesus for another term on the Police Commission. Ms. DeJesus is a Latina queer woman who not only adds to the diversity of the commission, but has a record of getting things done, including body cameras, firings of rogue and bigoted officers, use of force reforms, and galvanizing the movement to stop tasers, among others. She always follows the community's recommendations and wants the best practices implemented.

As a transgender and autistic woman, I am often at risk for abuse by police officers and Ms. DeJesus is somebody who serves with compassion and competence, and would be a voice I can trust when lives are on the line. I also have been heartbroken by the police violence against black and Latinx folk, and we need an independent voice to make sure the police are being held responsible for misdeeds.

Furthermore, I currently serve as the Tenant Representative on the Single Room Occupancy Task Force\*. SRO Tenants include many people of color, immigrants, trans, queer, disabled, seniors, youth, and poor people, and those who live in residential hotels are often subject to harassment and mistreatment by the police, and have an understandable lack of trust that Petra DeJesus is helping to address.

The police commission has gone with a vacancy for too long, and although I am glad Ms. Miranda withdrew her application, there is another applicant who is a straight white male corporate attorney who has little experience with this issue, and he must not be allowed to replace Ms. DeJesus on the police commission. Furthermore, I am dismayed at the pettiness that has delayed DeJesus' reappointment, the Rules committee needs to make appointment decisions based on qualifications, experience, diversity, and temperament, not on politics.

#### **Board Qualifications:**

The Police Commission shall consist of seven (7) members:

- > Three (3) members shall be nominated by the Rules Committee of the Board of Supervisors; and
- > Four (4) members nominated by the Mayor, at least one (1) shall be a retired judge or an attorney with trial experience.

Each nomination shall be subject to confirmation by the Board of Supervisors. The Mayor's nominations shall be the subject of a public hearing and vote within 60 days. If the Board of Supervisors rejects the Mayor's nomination to fill the seat designated for a retired judge or attorney with trial experience, the Mayor shall nominate a different person with such qualifications. If the Board of Supervisors fails to act on a mayoral nomination within 60 days from the date the nomination is transmitted to the Clerk of the Board of Supervisors, the nominee shall be deemed confirmed.

To stagger the terms of the seven members, of the first four members nominated by the Mayor, two members shall serve two year terms and two members shall serve terms of four years; and of the three members nominated by the Rules Committee, one member shall serve a term of one year, one member shall serve a term of two years, and one member shall serve a term of three years. The Clerk of the Board of Supervisors shall designate such initial terms by lot. All subsequent appointments to the commission shall be for four-year terms.

# San Francisco BOARD OF SUPERVISORS

The tenure of each member shall terminate upon the expiration of the member's term. The Mayor shall transmit a nomination or re-nomination to the Clerk of the Board of Supervisors no later than 60 days prior to the expiration of the term of a member nominated by the Mayor. For vacancies occurring for reasons other than the expiration of a member's term, within 60 days following the creation of such vacancy, the Mayor shall nominate a member to fill such vacancy if the vacancy is for a seat filled by nomination of the Mayor.

The District Attorney, Sheriff, and Public Defender may recommend persons to the Mayor and Board of Supervisors for nomination or appointment to the Commission.

The Mayor, with the consent of the Board, may remove a member the Mayor has nominated. The Board of Supervisors may remove a member the Rules Committee has nominated.

The Police Commission oversees the Police Department and the Office of Citizen Complaints (OCC). The OCC investigates complaints of police misconduct and neglect of duty. The Director of the OCC may verify and file disciplinary charges with the Police Commission against members of the Police Department arising out of citizen complaints that are sustained by the OCC after meeting and conferring with the Chief of Police.
