WHEREAS, The Drunken Monkey, Inc., dba Docs Clock is seeking the transfer of a Type 48 on-sale general public premises license located at 2417 Mission Street (District 9); and

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

service and self-service of alcoholic beverages is strictly prohibited; 5) the petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control; 6) loitering (defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee; 7) the exterior of the premises shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the premises; additionally, the position of such lighting shall not disturb the normal privacy and use of any neighboring residences; and 8) graffiti shall be removed from the premises and all parking lots under the control of the licensee(s) within 72 hours of application; if the graffiti occurs on a Friday or weekend day, or on a holiday, the licensee(s) shall remove the graffiti within 72 hours following the beginning of the next weekday; now, therefore, be it

RESOLVED, That in accordance with California Business and Professions Code, Section 23958.4, the Board of Supervisors of the City and County of San Francisco hereby determines that the transfer of a Type 48 on-sale general public premises license to The Drunken Monkey, Inc., dba Docs Clock located at 2417 Mission Street (District 9), will serve the public convenience or necessity of the City and County of San Francisco; and, be it
