9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Raymond Choy v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-546044 by the
13 payment of \$30,000. The lawsuit involves an alleged civil rights violation.

14 Section 2. The above-named action was filed in San Francisco Superior Court on May
15 28, 2015, and the following parties were named in the lawsuit: plaintiff: Raymond Choy;
16 defendants: City and County of San Francisco and Sam Yuen.
