

1 [Grant Agreement - California Department of Public Health - Naloxone Distribution Grant  
2 Program - \$102,480]

3 **Resolution retroactively authorizing the Department of Public Health to execute Grant**  
4 **Agreement No. 16-11026 with the California Department of Public Health, to receive**  
5 **\$102,480 worth of naloxone product through the Naloxone Distribution Grant Program,**  
6 **for the term of June 1, 2017, through June 30, 2019; and authorizing the Health Officer**  
7 **for the City and County of San Francisco to sign said agreement.**

9 WHEREAS, Drug overdose is the leading cause of accidental death in the United  
10 States and in San Francisco there were 105 deaths attributable to opioid overdose in 2016;  
11 and

12 WHEREAS, Fatal overdoses are preventable with the provision of naloxone (brand  
13 name Narcan), an opioid antagonist that can be safely administered by laypeople; and

14 WHEREAS, In collaboration with Department of Public Health (SFDPH), the Drug  
15 Overdose Prevention Education Project has trained over 8,000 laypeople to administer  
16 naloxone since 2003 and, as a result, over 3,000 overdose reversals have been reported; and

17 WHEREAS, Through its Naloxone Distribution Grant Program, the California  
18 Department of Public Health (CDPH) aims to reduce accidental overdose deaths by providing  
19 naloxone to local Health Departments in California so that it may be distributed to programs  
20 serving individuals at high risk of overdose; and

21 WHEREAS, SFDPH submitted an application, on April 20, 2017, to CDPH to apply for  
22 \$102,480 worth of naloxone product (2,602 doses) through the Naloxone Distribution Grant  
23 Program; and

1           WHEREAS, On June 19, 2017, CDPH approved SFDPH's application and forwarded a  
2 Grant Agreement (No. 16-11026), on file with the Clerk of the Board of Supervisors in File No.  
3 170800, which is hereby declared to be a part of this resolution as if set forth fully herein; and

4           WHEREAS, CDPH requires a resolution, order, motion, or ordinance from the Board of  
5 Supervisors, which authorizes the execution of the agreement; now, therefore, be it

6           RESOLVED, That SFDPH is hereby authorized to enter into Grant Agreement No.16-  
7 11026 with CDPH for the term of June 1, 2017, through June 30, 2019, to receive \$102,480  
8 worth of naloxone product for distribution; and, be it

9           FURTHER RESOLVED, That the Health Officer for the City and County of San  
10 Francisco is hereby authorized to sign said agreement with CDPH; and, be it

11           FURTHER RESOLVED, That within thirty (30) days of the agreement being fully  
12 executed by all parties the Health Officer shall provide the file to the Clerk of the Board for  
13 inclusion into the official file.


