Be it ordained by the People of the City and County of San Francisco:

Section 1. The Board of Supervisors hereby adopts the rate determined by the Controller, pursuant to Business and Tax Regulations Code Article 12B-1, Section 1032, as the percentage ceiling that a taxpayer may designate for deposit in the Neighborhood Beautification and Graffiti Clean-up Fund. Said determination is on file with the Clerk of the Board of Supervisors in File No. 170676, and is incorporated herein by reference. For the 2017 tax year, the designation ceiling shall be 3.4% of a taxpayer's payroll expense tax and gross receipts tax liability for the year.

The Treasurer and Tax Collector shall post the designation ceiling to the website of the Treasurer and Tax Collector.

Section 2. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the

ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
