3 **Resolution approving a modification of the contract between the City and County of**
4 **San Francisco and Allied Universal Security, for the provision of Security Services for**
5 **the period of February 1, 2014, through January 31, 2018, with no change to the term, to**
6 **increase the amount by \$3,016,919 resulting in a total contract amount of \$22,802,311.**

8 WHEREAS, The City and County of San Francisco, wishes to engage security services
9 to provide a safe and protected environment for its employees, clients and the general public;
10 and

11 WHEREAS, The Human Services Agency, conducted a Request for Proposals for
12 provision of security services in August 2013; and

13 WHEREAS, Allied Universal Security submitted a responsive and responsible proposal
14 and was awarded the security services contract for the total amount of \$19,785,392 in
15 February 2014; and

16 WHEREAS, A modification of the Allied Universal Security contract in the amount of
17 \$3,016,919 resulting in a new total amount of \$22,802,311 was requested in May 2017; and

18 WHEREAS, The Human Services Agency Commission approved this modification to
19 the Allied Universal Security contract at its meeting of May 25, 2017; now, therefore be it

20 RESOLVED, That the Board of Supervisors hereby approves modification of the
21 contract with Allied Universal Security in the amount of \$3,016,919, resulting in a new total
22 amount of \$22,802,311 for the period of February 1, 2014, through January 31, 2018; and, be
23 it

1 FURTHER RESOLVED, That within thirty (30) days of the modification being fully
2 executed by all parties, the Human Services Agency shall provide the final contract to the
3 Clerk of the Board for inclusion into the official file.




