9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Linda Chen v. San Francisco Police
11 Department, et al., San Francisco Superior Court, Case No. CGC 14-542604 by the payment
12 of \$350,000. The lawsuit involves an employment dispute.

15 November 7, 2014, and the following parties were named in the lawsuit: Plaintiff: Linda Chen;


