10	Be it ordained by the People of the City and County of San Francisco:
11	
12	Section 1. The Administrative Code is hereby amended by revising Sections 23.14
13	and 23.15, to read as follows:
14	SEC. 23.14. DIRECTOR OF PROPERTY'S REPORT.
15	Within 30 days after the receipt of the request required by Section 23.13, the Director
16	of Property shall prepare a report for the Mayor and the requesting department of the
17	estimated fair market value of the Real Property, the character of the improvements thereon,
18	and an evaluation as to whether, in the opinion of the Director of Property, the Real Property
19	can be advantageously used by the requesting department for the purposes specified in the
20	request. If the Director of Property determines the estimated fair market value of Real
21	Property exceeds \$10,000, the Director of Property shall obtain an Appraisal for the Real
22	Property: provided, however, the Director of Property shall not be required to obtain an Appraisal
23	when the requesting department (a) is not an Enterprise Department, as defined in Administrative Code
24	Section 23A.4, and (b) will use the Real Property for 100% Affordable Housing, as defined in
25	Administrative Code Section 23A.4; provided further that such 100% Affordable Housing requirement

Supervisor Peskin BOARD OF SUPERVISORS 1 <u>shall not exclude other ancillary uses of the Real Property that benefit the Affordable Housing on the</u>

<u>Real Property or benefit the community</u>. If the Appraisal determines the fair market value of the
Real Property exceeds \$200,000, the Director of Property shall obtain an Appraisal Review for
such Appraisal. Any Appraisal and Appraisal Review shall have an effective date of value that
is not earlier than nine months before the date any legislation for the proposed transfer is
submitted to the Board of Supervisors. <u>The Appraisal requirement in this Section 23.14 shall not</u>
*apply to any jurisdictional transfers under Administrative Code Chapter 23A.*

## 8 SEC. 23.15. MAYOR'S CONSENT TO TRANSFER; CONSENT OF DEPARTMENT 9 HAVING JURISDICTION.

If, on receipt of the Director of Property's report, the Mayor believes that the 10 department requesting the transfer can advantageously use the Real Property, the Mayor 11 12 shall request the department under whose jurisdiction it is to consent to the transfer of the 13 Real Property to the department desiring the transfer. If the second-mentioned department 14 consents to the transfer within 30 days, the Mayor shall recommend to the Board of 15 Supervisors that it order the Real Property transferred, sending to the Board with the request 16 such data regarding the Real Property as he or she has received from the Director of 17 Property. No Real Property shall be transferred from one department to another without the 18 consent of the department having jurisdiction over the Real Property, except as provided by Section 253.18 below. 19

20 Section 2. Effective Date. This ordinance shall become effective 30 days after 21 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the 22 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board 23 of Supervisors overrides the Mayor's veto of the ordinance.

24 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors 25 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,

1	numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
2	Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
3	additions, and Board amendment deletions in accordance with the "Note" that appears under
4	the official title of the ordinance.
