6 **Xuong Lu, et al.; the lawsuit involves alleged personal injury from vehicle collision;**
7 **other material terms of the settlement are co-defendants to pay \$60,000.**

9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Peter Firestone v. Xuong Lu, et al.,
12 San Francisco Superior Court, Case No. CGC-14-542359 by the payment of \$50,000 and co-
13 defendants to pay \$60,000. The lawsuit involves alleged personal injury from vehicle
14 collision.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 October 24, 2014, and the following parties were named in the lawsuit: Plaintiff: Peter


