Ordinance amending the Administrative, Business and Tax Regulations, Health, and 3 4 Police Codes to comprehensively regulate commercial activities relating to the cultivation, manufacture, distribution, testing, sale, and delivery of medicinal and adult 5 use cannabis by, among other things: 1) requiring businesses that engage in 6 7 commercial cannabis activities to obtain a permit from the Office of Cannabis; 2) requiring the Director of the Office of Cannabis to establish implement an Equity 8 9 Program to promote equitable ownership and employment opportunities in the 10 cannabis industry by providing priority permitting for Equity Applicants and Equity 11 Incubators, as defined; 3) defining eligibility for temporary and permanent cannabis 12 business permits; 4) establishing priorities for the review of cannabis business permit applications; 5) establishing operating standards for cannabis businesses; 6) 13 14 establishing criteria for granting, denying, suspending, and revoking cannabis 15 business permits; 7) requiring all cannabis businesses to ensure that 50% of work hours are performed by San Francisco residents, and cannabis businesses with 10 or 16 17 more employees to adopt labor peace agreementsincorporating state law governing 18 commercial cannabis activities into local law for enforcement purposes; 8) authorizing 19 the imposition of fines and penalties for violation of local and state laws governing cannabis businesses, and establishing procedures by which cannabis businesses may 20 appeal a fine or permit penalty; 9) prohibiting the smoking and vaping of cannabis on 21 22 the premises of all cannabis businesses, except select Medicinal Cannabis Retailers 23 and Cannabis Retailers, as authorized by the Department of Public Health;9) allowing 24 pre-existing non-conforming cannabis operators to register with the Office of Cannabis and apply for cannabis business permits in 2018; 10) prohibiting the consumption of 25

1 cannabis and cannabis products, other than by smoking or vaping, on the premises of 2 all cannabis businesses, except Storefront Cannabis Retailers and Cannabis 3 Microbusinesses that obtain consumption permits from the Department of Public Health; 11) prohibiting until January 1, 2019, tours of cannabis cultivators, 4 manufacturers, and cannabis microbusinesses, and authorizing the Director of 5 Cannabis to extend the prohibition on tours, or establish guidelines for the operation of 6 7 tours; 12) prohibiting the acceptance of new applications for medical cannabis 8 dispensary permits, starting January 1, 2018; 13) allowing medical cannabis dispensaries to sell adult use cannabis for a period of 120 days, starting January 1, 9 2018, and prohibiting medical cannabis dispensaries from cultivating cannabis under 10 the authority of a medical cannabis dispensary permit, starting April 1, 2018; 14) 11 12 establishing a sunset date of December 31, 2018, for Article 33 of the Health Code 13 ("Medical Cannabis Act"); 15) requiring the Department of Public Health to implement an ongoing public health education campaign about the safe consumption and health 14 benefits of cannabis; 16) requiring the Controller to submit a report to the Board of 15 Supervisors within one year of the effective date of Article 16 recommending whether 16 the issuance of cannabis business permits should be subject to any limits; 17) 17 18 establishing an Equity Operator Fund to receive any monies appropriated for the purpose of assisting Equity Operators; and 185) eliminating the duty of the Clerk of the 19 20 Board of Supervisors to send letters annually to state and federal officials requesting that cannabis be regulated and taxed; and affirming the Planning Department's 21 determination under the California Environmental Quality Act. 22 23 NOTE: Unchanged Code text and uncodified text are in plain Arial font. 3	Be it ordained by the People of the City and County of San Francisco:
4	Section 1. The Planning Department has determined that the actions contemplated in
5	this ordinance comply with the California Environmental Quality Act (California Public
6	Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the
7	Board of Supervisors in File No. 171042 and is incorporated herein by reference. The Board
8	affirms this determination.
9	
10	Section 2. The Police Code is hereby amended by adding Article 16, consisting of
11	Sections 1600 to 163 <u>9</u> 8, to read as follows:
12	ARTICLE 16: REGULATION OF CANNABIS
13	
14	SEC. 1600. FINDINGS AND PURPOSE.
15	(a) In 1996, the voters of California approved Proposition 215, The Compassionate Use Act,
16	allowing persons in need of cannabis for specified medical purposes to obtain and use cannabis.
17	(b) In 2001, the City adopted Resolution No. 955-01, declaring San Francisco to be a
18	"sanctuary for medical cannabis." In 2005, the City enacted Ordinance No. 275-05, Health Code
19	Article 33, known as the Medical Cannabis Act, which implemented a local regulatory scheme for
20	Medical Cannabis Dispensaries operating in San Francisco.
21	(c) In 2006, the City enacted Ordinance No. 297-06, Administrative Code Chapter 96B, making
22	cannabis offenses by adults the lowest law enforcement priority in San Francisco.
23	(d) On August 29, 2013, in response to the number of states seeking to legalize cannabis, the
24	United States Department of Justice issued a memorandum known as the Cole Memo, outlining federal
25	cannabis enforcement priorities and specifying that the federal government would continue to rely on

1	states and local law enforcement agencies to address cannabis activity through enforcement of their
2	own narcotics laws.
3	(e) The federal law enforcement priorities articulated in the Cole Memo align with many of San
4	Francisco's priorities including: preventing the distribution of cannabis to minors; preventing
5	cannabis sales revenue from going to criminal enterprises, gangs, and cartels; preventing the diversion
6	of cannabis from states where it is legal to other states; preventing state-authorized cannabis activity
7	from being used as a cover or pretext for the trafficking of other illicit drugs or activity; preventing
8	violence and use of firearms in the cultivation and distribution of cannabis; preventing drugged driving
9	and the exacerbation of other adverse public health consequences associated with cannabis use;
10	preventing the cultivation of cannabis on public lands and the attendant public safety and
11	environmental dangers posed by cannabis production on public lands; and preventing cannabis
12	possession or use on federal property.
13	(f) On October 9, 2015, Governor Brown signed into law the Medical Marijuana Regulation
14	and Safety Act ("MMRSA"), effective January 1, 2016, which established a comprehensive state
15	licensing and regulatory framework for the cultivation, manufacturing, testing, distribution,
16	transportation, dispensing, and delivery of medicinal cannabis, and which recognized the authority of
17	local jurisdictions to prohibit or impose additional restrictions on commercial activities relating to
18	medicinal cannabis. On June 27, 2016, Governor Brown signed into law Senate Bill 837, which
19	amended MMRSA and renamed it the Medical Cannabis Regulation and Safety Act ("MCRSA").
20	(g) On November 8, 2016, the voters of California approved Proposition 64, the Control,
21	Regulate, and Tax Adult Use of Marijuana Act (AUMA), which legalized the nonmedicinal use of
22	cannabis for adults 21 years of age and older, created a state regulatory, licensing, and taxation system
23	for non-medicinal cannabis businesses, and reduced penalties for cannabis-related crimes. San
24	Francisco voters approved Proposition 64 at a rate of 74.3%, compared to 57.1% in the state overall.
25	

1	(h) On November 9, 2016, Mayor Lee issued Executive Directive 16-05, entitled "Implementing
2	Prop 64: Adult Use of Marijuana Act," directing the Directors of Planning and Public Health, in
3	collaboration with the San Francisco Cannabis State Legalization Task Force and other stakeholders,
4	to lead the process of drafting the legislation required to fully and responsibly implement Proposition
5	64, including ordinances that address land use, local permitting, safety, and youth access.
6	(i) On June 27, 2017, Governor Brown signed into law the Medicinal and Adult-Use Cannabis
7	Regulations and Safety Act (MAUCRSA), effective immediately, reconciling MCRSA and Proposition
8	64, unifying the adult-use and medicinal cannabis markets within the same regulatory regime, and
9	making explicit the protection of the public to be the highest priority for all state licensing authorities
10	in exercising their licensing, regulatory, and disciplinary functions under MAUCRSA. Under
11	MAUCRSA, local jurisdictions may adopt and enforce ordinances to further regulate cannabis
12	businesses, including zoning and permitting requirements and prohibitions on certain types of
13	businesses.
14	(j) In 2015, the City enacted Ordinance No. 115-15, creating the San Francisco Cannabis State
15	Legalization Task Force ("the Task Force") to advise the Board of Supervisors, the Mayor, and other
16	City departments on matters relating to the potential legalization of adult use cannabis. In December
17	2016, the Task Force submitted its Year I Report, and made recommendations related to Public Safety
18	and Social Environment, Land Use and Social Justice, and Regulation and City Agency Framework for
19	the City's policymakers to consider.
20	(k) The Board of Supervisors intends to establish a comprehensive regulatory framework for
21	medicinal cannabis and adult use cannabis. In furtherance of this goal, the Mayor's FY2017-2018
22	budget, approved by the Board through its enactment of Ordinance No. 156-17, included
23	appropriations for the establishment of an Office of Cannabis to coordinate with City departments and
24	state agencies to develop policies and regulate the local cannabis industry to ensure that local public
25	health, safety, and social justice goals are met. In addition, in July 2017, the City enacted Ordinance

1 No. 168-17, Administrative Code Chapter 2A, Article XXVI, to establish an Office of Cannabis; to
--

- 2 *authorize the Director of the Office of Cannabis to issue permits to cannabis-related businesses; and to*
- 3 <u>require the Director to collect permit application and annual license fees following the enactment of an</u>
- 4 *ordinance establishing the amounts of those fees.*
- 5 (1) The Board of Supervisors is committed to ensuring that the perspectives of communities that
- 6 *have been historically and disproportionately affected by federal drug enforcement policies are*
- 7 *included and considered in all cannabis policy decisions.*
- 8 (m) The Board of Supervisors is committed to fostering equitable access to participation in the
- 9 <u>cannabis industry for San Francisco-based small businesses and individuals by promoting ownership</u>
- 10 *and stable employment opportunities in the industry.*
- 11 (n) Through this Article 16, the Board of Supervisors intends to develop a regulatory
- 12 *framework that: reduces the illegal market for cannabis; minimizes the chances of social harm by*
- 13 protecting and promoting the health of all San Franciscans; limits youth access and exposure to
- 14 *cannabis and cannabis products; ensures safe consumption; maintains the City's progressive clean air*
- 15 *policies for residents, businesses, and their employees; creates equitable access to opportunities within*
- 16 *the cannabis industry; and creates jobs and tax revenue for the City.*
- 17
- 18 <u>SEC. 1601. ADMINISTRATION AND ENFORCEMENT.</u>
- 19 (a) This Article 16 shall be administered and enforced by the Office of Cannabis. The Director
- 20 *may adopt rules, regulations, and guidelines to carry out the provisions and purposes of this Article,*
- 21 *including, but not limited to: operating guidelines designed to further the goals of reducing the illegal*
- 22 *market for Cannabis and Cannabis Products, protecting and promoting the health of all San*
- 23 Franciscans, limiting youth access and exposure to Cannabis and Cannabis Products, ensuring safe
- 24 *consumption of Cannabis and Cannabis Products, and creating equitable access to opportunities*
- 25 *within the Cannabis industry; hearing procedures; and standards for the imposition of administrative*

1	penalties, permit suspensions and permit revocations. The Director shall adopt rules, regulations,
2	and guidelines to ensure that Storefront Cannabis Retailers and Delivery-Only Cannabis
3	Retailers maintain and Sell an inventory of Medicinal Cannabis and Medicinal Cannabis
4	Products that is sufficient in volume and variety to meet the diverse medical needs of qualified
5	patients, including but not limited to guidelines addressing the availability of Cannabis flowers,
6	and other specific forms of Cannabis or Cannabis Products.
7	(b) The Director is authorized to enter into agreements with State Licensing Authorities to
8	enforce Division 10 of the California Business and Professions Code and its implementing regulations,
9	consistent with Section 26202 of the California Business and Professions Code.
10	
11	SEC. 1602. DEFINITIONS.
12	As used in this Article 16, the following words or phrases shall mean:
13	"A-license" has the meaning set forth in Section 26001 of the California Business and
14	Professions Code, as may be amended from time to time.
15	"A-licensee" has the meaning set forth in Section 26001 of the California Business and
16	Professions Code, as may be amended from time to time.
17	"Adult Use Cannabis" means Cannabis or Cannabis Products intended for adults 21 years of
18	age and over.
19	"Applicant" means an Owner applying for a Cannabis Business Permit under this Article 16.
20	"Bona Fide Order" means an order for the delivery of Cannabis or Cannabis Products to a
21	Customer that includes this information supplied by the Customer: (a) the Customer's name and date of
22	birth; (b) the date Delivery is requested and the address of the real property where the Customer would
23	like the items Delivered; (c) an itemization of the Cannabis items proposed for Delivery and the
24	amount, quantity, and/or volume of each such item; and (d) a statement that the Cannabis or Cannabis
25	Product is not for the purpose of resale.

1	"Bona Fide Proof of Identity and Age" means: (a) a valid document issued by a federal, state,
2	or local government, or subdivision or agency thereof, including, but not limited to, a valid motor
3	vehicle operator's license, that contains the name, date of birth, description of physical characteristics,
4	and photo of the person; (b) a valid passport issued by the United States or by a foreign government; or
5	(c) a valid identification card issued to a member of the United States Armed Forces that includes a
6	date of birth and a photo of the person.
7	"Business Work Hours" means the total hours worked for a Cannabis Business by all
8	workers, whether those workers are employed by the Cannabis Business or any
9	subcontractor.
10	"Cannabis" has the meaning set forth in Section 26001 of the California Business and
11	Professions Code, as may be amended from time to time.
12	"Cannabis Business" means any of the following: Cannabis Cultivation Facility, Cannabis
13	<u>Manufacturing Facility, Cannabis Testing Facility, Cannabis Distributor, Cannabis Microbusiness,</u>
14	<u>Medicinal Cannabis Retailer, Cannabis Retailer, or Delivery-Only Cannabis Retailer.</u>
15	"Cannabis Business Permit" means a permit to operate a specific type of Cannabis Business
16	issued under this Article 16.
17	"Cannabis Business Registration Period" means the period of time during which Persons
18	wishing to apply for Cannabis Business Permits may register with the Office of Cannabis, as set forth
19	in Section 1605 of this Article 16.
20	"Cannabis Cultivation Facility" means a fixed place of business where Cannabis is Cultivated
21	for Commercial purposes.
22	"Cannabis Distributor" means a fixed place of business where Cannabis and/or Cannabis
23	Products are Distributed for Commercial purposes between Cannabis Businesses holding State
24	<u>Cannabis Licenses.</u>

1	<u>"Cannabis Manufacturing Facility" means a fixed place of business where Cannabis Products</u>
2	are Manufactured for Commercial purposes.
3	"Cannabis Microbusiness" means a fixed place of business where Cannabis and/or Cannabis
4	Products are Cultivated, Manufactured, Distributed, and Sold to Customers.
5	"Cannabis Products" has the meaning set forth in Section 26001 of the California Business and
6	Professions Code, as may be amended from time to time.
7	"Cannabis Retailer" means a fixed place of business where Cannabis and/or Cannabis
8	Products are Sold to Customers.
9	"Cannabis Testing Facility" means a fixed place of business where Cannabis and/or Cannabis
10	Products are tested for Commercial purposes.
11	"Canopy" means the designated area(s) at a permitted Premises that will contain Mature
12	<u>Plants.</u>
13	"City" means the City and County of San Francisco.
14	"Commercial" means undertaken for Compensation.
15	"Commercial Cannabis Activity" includes the cultivation, possession, manufacture, processing,
16	storing, laboratory testing, labeling, transporting, distribution, or sale of Cannabis or Cannabis
17	Products for Compensation, as provided for in this Article 16.
18	"Commercial Vehicle" has the meaning set forth in Section 260 of the California Vehicle Code,
19	as may be amended from time to time.
20	"Compensation" means money or anything of value made as a payment, loan, advance,
21	donation, contribution, deposit, forgiveness of debt, or gift.
22	"Consuming" or "Consumption" means Smoking, eating, drinking, chewing, applying
23	<u>topically, or otherwise ingesting</u> , but does not include Smoking.
24	"Cultivation" has the meaning set forth in Section 26001 of the California Business and
25	Professions Code, as may be amended from time to time.

1	"Customer" has the meaning set forth in Section 26001 of the California Business and
2	Professions Code, as may be amended from time to time.
3	"Delivery" has the meaning set forth in Section 26001 of the California Business and
4	Professions Code, as may be amended from time to time.
5	"Delivery-Only Cannabis Retailer" means a fixed place of business from which Cannabis
6	and/or Cannabis Products are Delivered and Sold to Customers.
7	"Director" means the Director of the Office of Cannabis, or his or her designee.
8	"Distribution" or "Distribute" has the meaning set forth in Section 26001 of the California
9	Business and Professions Code, as may be amended from time to time.
10	"Hazardous material" has the meaning set forth in Section 1102 of the Health Code, as may be
11	amended from time to time.
12	"Hazardous materials plan" has the meaning set forth in Section 1102 of the Health Code, as
13	may be amended from time to time.
14	"Labor Peace Agreement" has the meaning set forth in Section 26001 of the California
15	Business and Professions Code, as may be amended from time to time.
16	<u>"Local Resident" means an individual who is domiciled, as defined by Section 349(b) of</u>
17	the California Elections Code, within the City for at least seven days immediately prior to
18	commencing work for a Cannabis Business.
19	"M-license" has the meaning set forth in Section 26001 of the California Business and
20	Professions Code, as may be amended from time to time.
21	"M-licensee" has the meaning set forth in Section 26001 of the California Business and
22	Professions Code, as may be amended from time to time.
23	"Manufacture" has the meaning set forth in Section 26001 of the California Business and
24	Professions Code, as may be amended from time to time.
25	"Mature Plant" means a Cannabis plant that is flowering.

1	"Medicinal Cannabis" has the meaning set forth in Section 26001 of the California Business
2	and Professions Code, as may be amended from time to time.
3	"Medical Cannabis Dispensary" means a cooperative or collective operating under the
4	authority of a permit issued by the Director of Health under Article 33 of the Health Code.
5	"Medicinal Cannabis Retailer" means a fixed place of business where Medicinal Cannabis
6	and/or Medicinal Cannabis Products are Sold to individuals who qualify under California Health and
7	Safety Code Sections 11362.7 et seq. to use Medicinal Cannabis.
8	"Office" means the Office of Cannabis or any successor office or agency.
9	"Owner" means any of the following:
10	(a) A Person with an aggregate ownership interest of 20% or more in the Person
11	applying for a Cannabis Business Permit or a Permittee, unless the interest is solely a security, lien, or
12	encumbrance;
13	(b) The chief executive officer of a nonprofit or other entity;
14	(c) A member of the board of directors of a nonprofit; or
15	(d) An individual who will be participating in the direction, control, or management of
16	the Person applying for a permit.
17	"Permittee" means any Person to whom a Cannabis Business Permit is issued under this
18	Article 16, and any authorized agent or designee of such Person.
19	"Person" includes any individual, firm, partnership, joint venture, association, corporation,
20	limited liability company, estate, trust, business trust, receiver, syndicate, or any other entity, or other
21	group or combination acting as a unit. Person includes both the plural and singular.
22	"Physician's Recommendation" has the meaning set forth in Section 26001 of the California
23	Business and Professions Code, as may be amended from time to time.
24	
25	

1	<u>"Pre-Existing Non-Conforming Operator" means a Cannabis Business that engaged in</u>
2	Commercial Cannabis Activities as of September 26, 2017, in a location where such activities
3	were not authorized by or consistent with the Planning Code.
4	"Premises" has the meaning set forth in Section 26001 of the California Business and
5	Professions Code, as may be amended from time to time.
6	"Processing" means the drying, curing, trimming, or packaging of Cannabis. "Processing"
7	does not include the growing, planting, or harvesting of Cannabis.
8	"Referring Department" means any City department, agency, office, board, or commission that
9	is required by this Article 16, or its implementing regulations, to review an Applicant's application for
10	a Cannabis Business Permit prior to issuance of such permit by the Director.
11	"Security Guard" has the meaning set forth in Section 1060 of the Police Code, as may be
12	amended from time to time.
13	"Security Plan" means a plan that adequately addresses the safety of persons and property at
14	Cannabis Businesses, developed in consultation with the Police Department, and approved as a
15	condition of the Cannabis Business Permit by the Director.
16	"Sell," "sale," and "to sell" have the meaning set forth in Section 26001 of the California
17	Business and Professions Code, as may be amended from time to time.
18	"Smoke" or "Smoking" has the meaning set forth in Section 11362.3 of the California Health
19	and Safety Code, as may be amended from time to time.
20	"State Cannabis License" means a license to engage in a Commercial Cannabis Activity, issued
21	pursuant to Division 10 of the California Business and Professions Code.
22	"State Licensing Authority" means the state agency responsible for the issuance, renewal, or
23	reinstatement of a State Cannabis License.
24	"Storefront Cannabis Retailer" means either of the following: Medicinal Cannabis Retailer or
25	<u>Cannabis Retailer.</u>

1	"Temporary Medicinal-Cannabis Business Permit" means a Permit issued by the Director
2	under Section 1605 of this Article 16 authorizing the Temporary Permit holder to engage in time-
3	limited Commercial Activities-relating to Medicinal Cannabis and Medicinal Cannabis Products.
4	"Tobacco Products" has the meaning set forth in Section 19H.2 of the Health Code, as may be
5	amended from time to time.
6	"Volatile Solvent" has the meaning set forth in Section 26130(b) of the California Business and
7	Professions Code, as may be amended from time to time.
8	
9	<u>SEC. 1603. PERMITS REQUIRED.</u>
10	(a) It shall be unlawful to engage in any Commercial Cannabis Activity or to operate a
11	Cannabis Business within the City without obtaining and maintaining:
12	(1) A permit therefor issued by the Office of Cannabis;
13	(2) A license therefor issued by a State Licensing Authority pursuant to Division 10 of
14	the California Business and Professions Code; and
15	(3) Any such other licenses, permits, certifications, or registrations that may be
16	required by State or City law.
17	(b) It shall be unlawful for any Person to engage in any Commercial Cannabis Activity for
18	which a permit has been granted under this Article 16 if such permit has been revoked, or during any
19	period in which such permit is suspended.
20	(c) If any license, permit, certification, or registration required for the operation of a Cannabis
21	Business is denied, suspended, modified, revoked, or expired, the Cannabis Business and any Referring
22	Department responsible for the action shall notify the Director of such action in writing within two
23	<u>business days.</u>
24	(d) It shall be unlawful for any Person who is required to surrender a permit upon the sale of a
25	Cannabis Business, as required by Section 1608 of this Article 16, to fail to do so.

## <u>SEC. 1604. EQUITY PROGRAM.</u>

3	(a) The Director, in consultation with the Human Rights Commission, shall
4	establishimplement an Equity Program designed to foster equitable access to participation in the
5	cannabis industry, including equitable access to promotional and ownership opportunities in the
6	industry. The Equity Program shall be informed by the findings contained in the Equity Report,
7	prepared in accordance with subsection (b)(5) of Section 2A.420 of the Administrative Code.
8	The Equity Program shall offer priority permit processing and technical assistance to
9	Applicants who meet Equity Criteria ("Equity Applicants") adopted by the Director.
10	(b) Equity Applicants. The Equity Program shall offer priority permit processing, as
11	provided in Section 1606, to an individual who meets the following Equity Criteria ("Equity
12	<u>Applicant"):</u>
13	(1) Is a natural person;
14	(2) During the period 1971-2009, lived for at least five years, either
15	consecutively or in total, in San Francisco census tracts where at least 17% of the households
16	had incomes at or below the federal poverty level, as determined by the Director;
17	(3) At the time of application, has assets, excluding non-liquid assets and
18	retirement accounts, that do not exceed asset limits established by the Director;
19	(4) Submits an application for a Cannabis Business Permit in any of the
20	following capacities:
21	(A) As the sole owner/operator of the Applicant:
22	(B) As an individual with an ownership interest of at least 40% in the
23	corporate Applicant, and who is also the Chief Executive Officer of the corporate Applicant;
24	(C) As an individual with an ownership interest of at least 51% in the
25	corporate Applicant;

1	(D) As the Executive Director or member of the board of directors of a
2	not-for-profit Applicant where a majority of the members of the board of directors satisfy the
3	requirements of subsections (b)(2), (3), and (5) of this Section 1604; or
4	(E) As an individual with a membership interest in an Applicant formed
5	as a cooperative; and
6	(5) Meets two or more of the following additional criteria:
7	(A) At the time of application, is a member of a household that earns no

9	(B) Was arrested or convicted in the state of California during the period
10	<u>1971-2009 for a crime, provided the arrest or conviction meets any of the criteria set forth in</u>
11	subsection (a) of Section 4904 of the Police Coderelating to the sale, possession, use,
12	manufacture, or cultivation of cannabis:
13	(C) Was arrested or convicted in the state of California during the period
14	1971-2009 for a nonviolent crime other than a crime relating to the sale, possession, use,
15	manufacture, or cultivation of cannabis;
16	(DC) Since 1995, experienced housing insecurity in San Francisco, as
17	evidenced by eviction, foreclosure, or revocation of housing subsidy; or
18	(ED) Has a parent, sibling, or child who was convicted in the state of
19	California during the period 1971-2009 for a nonviolent crime, or for a crime relating to the
20	sale, possession, use, manufacture, or cultivation of cannabis-; or
21	(FE) Attended a school under the jurisdiction of the San Francisco
22	Unified School District for 5 years, either consecutively or in total, during the period 1971-
23	<u>2009.</u>
24	(c) Equity Incubators. The Equity Program shall offer priority permit processing, as
25	provided in Section 1606, to Equity Incubators. For purposes of this Article 16, an Equity

1	Incubator is an Applicant that does not qualify as an Equity Applicant, but that submits with its
2	Cannabis Business Permit application a Cannabis Equity Incubator Agreement in which it
3	commits to comply with the following additional operating requirements during its first three
4	vears in operation as a Cannabis Business:
5	(1) Ensure that at least 50% of all Business Work Hours are performed by Local
6	Residents. Business Work Hours performed by residents of states other than California shall
7	not be considered in calculation of the number of Business Work Hours to which this
8	requirement applies;
9	(2) Ensure that at least 50% of the Equity Incubator's employees satisfy the
10	requirements of subsections (b)(2), (3), and (5) of this Section 1604;
11	(3) Provide a community investment plan demonstrating engagement with
12	businesses and residents located within 500 feet of the site of the proposed Cannabis
13	Business; and
14	(4) Comply with one of the following additional operating requirements:
15	(A) Provide technical assistance and business mentoring to Equity
16	<u>Applicants who have been awarded Cannabis Business Permits ("Equity Operators"); or</u>
17	(B) Provide an Equity Operator with rent-free commercial space owned
18	or leased by the Equity Incubator in which the Equity Operator conducts its Cannabis
19	Business. The rent-free commercial space must equal or exceed 800 square feet or the
20	equivalent of 10% of the square footage of the Equity Incubator's Premises.
21	
22	SEC. 1605. TRANSITION PROVISION FOR ACTIVITIES RELATING TO MEDICINAL
23	CANNABIS.
24	(a) Cannabis Business Registration. The Office of Cannabis shall initiate a Cannabis
25	Business Registration Period in order to collect information from Persons wishing to apply for

1	Cannabis Business Permits. During the Cannabis Business Registration Period, such Persons shall
2	have the opportunity to register with the Office of Cannabis, and to provide such information as may be
3	required by the Director, including but not limited to:
4	(1) Information regarding the type(s) of Cannabis Business Permit(s) and State
5	Cannabis License(s) for which they intend to apply in 2018;
6	(2) Information about the location of the proposed Cannabis Business, including but not
7	limited to proof that the property owner has authorized the use of the property as a Cannabis Business;
8	(3) Copies of all applicable licenses, permits, certifications, and registrations issued by
9	the City or the State and held by the Owner of the proposed business, including but not limited to
10	Hazardous materials registrations, site permits, Business Registration Certificates, and/or Seller's
11	Permits; and
12	(4) Such other information, documents, and/or attestations as the Director may deem
13	necessary or appropriate for registration.
14	(b) Registration a Condition of Eligibility for Temporary Medicinal Cannabis Business
15	Permit. Persons that do not register with the Office of Cannabis during the Cannabis Business
16	<u>Registration Period shall not be eligible to apply for or receive a Temporary Medicinal Cannabis</u>
17	Business Permit, as set forth in subsection (d) of this Section 1605.
18	(c) Medical Cannabis Dispensaries.
19	(1) To ensure the continued availability of Medicinal Cannabis for individuals who
20	<u>qualify under California Health and Safety Code Sections 11362.7 et seq. to use Medicinal Cannabis, a</u>
21	Medical Cannabis Dispensary that holds a valid permit to operate from the Department of Public
22	Health as of the effective date of this Article 16 may continue to operate as a Medical Cannabis
23	Dispensary at the location identified in its Medical Cannabis Dispensary permit and consistent with the
24	terms of Article 33 of the Health Code, provided that:
25	

1	(A) The Owner of the Medical Cannabis Dispensary provides the Office of
2	Cannabis with information identifying the type(s) of Cannabis Business Permits and State Cannabis
3	Licenses for which the Owner intends to apply in 2018, and such other information as may be required
4	by the Director;
5	(B) The Owner of the Medical Cannabis Dispensary applies for and obtains a
6	temporary or permanent State Cannabis License;
7	(C) The Owner of the Medical Cannabis Dispensary applies for a Cannabis
8	Business Permit within 30 days of the date that the Office of Cannabis makes such applications
9	available; and
10	(D) The Owner of a Medical Cannabis Dispensary agrees to surrender its
11	Medical Cannabis Dispensary permit to the Department of Public Health upon being awarded a
12	<u>Cannabis Business Permit.</u>
13	(2) A Medical Cannabis Dispensary's permit to operate, as issued under Article 33 of
14	the Health Code, shall expire as a matter of law when it is surrendered to the Department of Public
15	Health, as set forth in subsection (c)(1)(D) of this Section 1605, or upon the sunset of Article 33,
16	whichever occurs sooner.
17	(d) Temporary Medicinal Cannabis Business Permits. The Office of Cannabis shall make
18	applications available for Temporary Medicinal Cannabis Business Permits for all permit categories
19	<u>other than Storefront Cannabis Retailers. In order to be eligible for a Temporary Medicinal Cannabis</u>
20	Business Permit, an Applicant must do all of the following:
21	(1) Submit an application, on a form to be prescribed by the Director;
22	(2) Demonstrate compliance with the Cannabis Business Registration process set forth
23	in subsection (a) of this Section 1605;
24	
25	

1	(3) Demonstrate that as of September 26, 2017, the Applicant was engaging in
2	Commercial Cannabis Activities relating to Medicinal Cannabis in the City and has continued to
3	engage in such activities without interruption;
4	(4) Demonstrate that the proposed Cannabis Business complies with the Planning
5	<u>Code;</u>
6	(5) Authorize and submit to the inspection of the proposed Premises by the Office of
7	Cannabis, the Fire Department, the Department of Building Inspection, the Department of Public
8	Health, and such other City departments, agencies, and offices as may be necessary to confirm that the
9	proposed Cannabis Business will operate in compliance with law and with the applicable interim
10	health and safety standards;
11	(6) Acknowledge the obligation to pay any non-refundable application and/or
12	inspection fees that the Office of Cannabis and/or the Referring Departments may impose in connection
13	with the application for a Temporary Medicinal Cannabis Business Permit; and
14	(7) Demonstrate that the proposed Cannabis Business complies with applicable interim
15	health and safety standards developed by the Director in consultation with the Department of Building
16	Inspection, the Fire Department, the Police Department, and the Department of Public Health. The
17	interim health and safety standards shall be sufficient to protect the health and safety of employees,
18	neighbors, and Customers of the proposed Cannabis Business, and to prohibit unlawful access to
19	Cannabis and Cannabis Products by underage individuals and individuals who do not qualify to
20	use Medicinal Cannabis.
21	(e) Review, award, and denial of Temporary Medicinal-Cannabis Business Permits. The
22	Director shall ensure that the Premises are inspected by all relevant City Departments, and shall
23	review all documentation submitted by the Applicant for the Temporary Medicinal Cannabis Business
24	Permit in support of the application. If the application is incomplete, the Director shall advise the
25	Applicant of the deficiencies, and give the Applicant 30 days in which to correct them. If the

1	application is complete, the Director shall determine whether the Applicant has demonstrated
2	compliance with subsection (d) of this Section 1605, and any implementing regulations. After
3	determining whether the Applicant has met these standards, the Director shall either award, award
4	with conditions, or deny the Temporary Medicinal-Cannabis Business Permit.
5	(f) Appeal of Denial of Application for Temporary Medicinal Cannabis Business Permit.
6	The decision of the Director to award, award with conditions, or deny a Temporary Medicinal
7	Cannabis Business Permit may be appealed to the Board of Appeals in the manner prescribed in
8	Article 1 of the San Francisco Business and Tax Regulations Code.
9	(g) Activities Authorized by Temporary Medicinal-Cannabis Business Permit. A Temporary
10	Medicinal Cannabis Business Permit issued under this Section 1605 shall authorize the Permittee to
11	engage in all of the activities authorized by a Cannabis Business Permit of the same category, as set
12	forth in Sections 1623 - 1629 of this Article 16; provided, however, that a Temporary Medicinal
13	Cannabis Business Permit shall not authorize the Permittee to engage in any Commercial
14	Cannabis Activities relating to Adult Use Cannabis or Adult Use Cannabis Products.
15	(h) Duration. A Temporary Medicinal-Cannabis Business Permit issued under this Section
16	1605 shall be valid for a period of 120 days and may be extended for additional 90-day periods at the
17	discretion of the Director. Notwithstanding the prior sentence, the Director shall not issue a new
18	temporary permit after January 1, 2019, and shall not extend the term of a Temporary Cannabis
19	Business Permit past January 1, 2019.
20	(i) Temporary Medicinal Cannabis Business Permit does not guarantee rights regarding a
21	permanent permit. A Temporary Cannabis Business Permit does not obligate the Director to issue a
22	permanent permit pursuant to Section 1615 of this Article 16, or create a vested right in the holder to
23	either an extension of the temporary permit or to the granting of a subsequent permanent permit.
24	(j) Duty to apply for permanent permit. A Person that is awarded a Temporary Medicinal
25	<u>Cannabis Business Permit under this Section 1605 must apply for a Cannabis Business Permit, as set</u>

1	forth in Section 1606, within 30 days of when the Office of Cannabis makes applications for such
2	permits available. The Director shall not accept applications for Temporary Medicinal Cannabis
3	Business Permits after making applications for Cannabis Business Permits available.
4	(k) Registration of Pre-Existing Non-Conforming Operators. A Pre-Existing Non-
5	Conforming Operator shall be eligible to receive technical assistance and apply for a
6	Cannabis Business Permit, as set forth in Section 1606 of this Article 16, provided it registers
7	with the Office of Cannabis during the Cannabis Business Registration Period and provides
8	the following information and documentation:
9	(1) Information regarding the type(s) of Commercial Cannabis Activities that the
10	operator conducts:
11	(2) Information regarding the type(s) of Cannabis Business Permit(s) and State
12	Cannabis License(s) for which the operator intends to apply in 2018;
13	(3) Demonstration that as of September 26, 2017, the operator was engaging in
14	Commercial Cannabis Activities relating to Medicinal Cannabis in the City:
15	(4) Copies of all applicable licenses, permits, certifications, and registrations
16	issued by the City or the State and held by the Owner of the proposed business, including but
17	not limited to Hazardous materials registrations, site permits, Business Registration
18	Certificates, and/or Seller's Permits;
19	(5) An affidavit or declaration made under penalty of perjury by an Owner
20	certifying that the Pre-Existing Non-Conforming Operator will not engage in Commercial
21	Cannabis Activities in a location where such activities are not authorized by or consistent with
22	the Planning Code; and
23	(6) Such other information, documents, and/or attestations as the Director may
24	deem necessary or appropriate for registration.
25

21	<u>SEC. 1608. TRANSFER OF PERMIT; PORTABILITY OF PERMIT; SALE OF</u>
22	<u>CANNABIS BUSINESS; CHANGE IN OWNERSHIP; INTERIM CANNABIS BUSINESS</u>
23	<u>PERMITS.</u>
24	(a) <b>Permits Nontransferable.</b> No permit issued under this Article 16 shall be transferable
25	under any circumstances, including but not limited to the sale of the Cannabis Business.

1	(b) Permits Portable. A Cannabis Business Permittee that closes its Cannabis
2	Business may retain its Cannabis Business Permit for up to 18 months from the date of
3	closure, and may conduct Commercial Cannabis Activities under that permit at a different
4	Premises provided:
5	(A) There is no change in ownership:
6	(B) The Referring Departments complete all necessary review and inspections
7	of the new Premises, and report their determinations to the Office of Cannabis;
8	(C) The Permittee demonstrates that the new Premises complies with the
9	requirements of this Article 16 and the Planning Code; and
10	(D) The Director finds that there are no grounds for denial of a Cannabis
11	Business Permit, as set forth in subsections (d)-(e) of Section 1615 of this Article 16.
12	(bc) Sale of Cannabis Business. If a Permittee sells the Cannabis Business, the Permittee
13	shall promptly surrender the permit to the Director. This obligation is not dependent on the Director's
14	requesting the surrender, but arises by operation of law on the sale of the Cannabis Business. If the
15	Permittee fails to surrender the permit to the Director, the Director may, after giving the Permittee
16	notice by mail and electronically of the proposed action and an opportunity to respond, revoke the
17	permit.
18	(ed) Change in Ownership. A Permittee may change partners, shareholders, or other Owners
19	of a Cannabis Business provided that: the sale or other transfer of ownership regardless of the form of
20	ownership results in a new Person owning no more than 20% of the Cannabis Business, and the
21	Permittee obtains an amendment to the Permit as provided in subsection ( $ed$ )(2) of this Section 1608.
22	If the sale or other transfer of ownership does not result in any Person (who did not already have such
23	a percentage interest) having an ownership interest of 20% or more, the Permittee is not required to
24	obtain a permit amendment.
25	

1	(1) A Permittee seeking to amend a permit as required under this subsection (ed) shall
2	pay the required filing fee for a permit amendment and that portion of the information required for
3	Applicants under Section 1609, as determined by the Director.
4	(2) The Director shall determine within 30 days of the filing of a complete application
5	for a permit amendment under this subsection (ed) whether to approve it. The Director shall approve
6	the application unless the Director determines that denial is warranted under any of the grounds set
7	forth in Section 1615. The Director shall notify the Permittee of the Director's decision electronically
8	and either by mail or personal delivery.
9	(de) Interim Cannabis Business Permits. Once the Director receives a surrendered Cannabis
10	Business Permit to Operate, as set forth in subsection (b) of this Section 1608, the new Owner of the
11	business may apply to the Director for an Interim Cannabis Business Permit, subject to any required
12	Planning Department approvals, for a period not to exceed 90 days from the date of surrender (an
13	"Interim Permit"). An Interim Permit may not be renewed. The Director may grant an Interim Permit

13	(A) If the Applicant is a corporation, the name of the corporation as shown in its
14	articles of incorporation; the date and place of incorporation; and the name and address of each
15	officer or director;
16	(B) If the Applicant is a Person other than a publicly traded company, the name
17	and address of every Person that directly or indirectly owns or controls 20% or more of the assets,
18	ownership interests, or voting interests in that Person;
19	(3) The name of and contact information for the manager(s) who will, directly or
20	through designees, be on the Premises during hours of operation;
21	(4) The name and address of each Person who appears on the business registration
22	certificate for the Business for which a permit is sought;
23	(5) The name and address of each Person who has or will have authority or control
24	over the Business and a brief statement of the nature and extent of such authority and control, if the
25	Applicant has not otherwise provided this information in the application:

1	(6) The name and address of the Person authorized to accept service of process;
2	(7) For all Applicants, a complete set of fingerprints in the manner required by the
3	Director for the purpose of conducting a criminal background check, and such additional information
4	concerning the criminal histories of Owners, as may be required by the Director;
5	(8) Written verification that the owner of the real property where the Cannabis Business
6	will be located consents to its use as a Cannabis Business. Such written verification must be signed by
7	the property owner or the owner's agent;
8	(9) Where the Applicant leases the Real Property, a copy of the lease;
9	(10) A determination from the Planning Department that the proposed use as a
10	Cannabis Business is in compliance with the Planning Code;
11	(11) An Operations Plan that includes such information as may be required by the
12	Director, including but not limited to:
13	(A) An odor mitigation plan;
14	(B) A Hazardous materials inventory;
15	(C) A power plan;
16	(D) A Security Plan;
17	(E) A track and trace compliance plan;
18	(F) A waste disposal plan; and
19	(G) A water management plan.
20	(12) A copy of the Applicant's business license, as required by Article 2 of the
21	Business and Tax Regulations Code, or where pending, proof of application therefor; For
22	Applicants with 10 or more employees, a statement that the Applicant will enter into, or
23	demonstrate that it has already entered into, and abide by the terms of a Labor Peace
24	Agreement:
25	

1	(13) A copy of the Applicant's business registration certificate, as required by Article
2	12 of the Business and Tax Regulations Code, or where pending, proof of application therefor;
3	(14) A copy of the Applicant's Seller's Permit, as may be required by Section 6067 of
4	the California Revenue and Taxation Code, or where pending, proof of application therefor;
5	(15) A completed Permit Checklist upon a form provided by the Director;
6	(16) A detailed, scaled diagram of the proposed Premises that shows the boundaries of
7	the property and all entrances, exits, interior partitions, walls, rooms, doorways, and common or
8	shared entryways. The diagram must show the areas in which all Commercial Cannabis Activity will
9	take place, including but not limited to areas where access will be limited to employees of the Cannabis
10	Business and Customer access will be prohibited. If the proposed Premises consists of only a portion
11	of property, the diagram shall reflect the Premises used for Cannabis activity and describe the use for
12	the remaining portion of the property;
13	(17) Disclosure of all other previous and current Cannabis-related licenses and permits
14	issued by or sought from the City, the State, and any out-of-state jurisdiction, including the date the
15	permit or license was issued or denied, and the name of the permitting or licensing authority;
16	(18) A signed statement authorizing the Department of the Environment or, where
17	applicable, the Public Utilities Commission to conduct an energy assessment within the first year of
18	operation;
19	(19) A copy of a proposed Good Neighbor Policy, developed in consultation with the
20	Office of Cannabis, under which the Applicant agrees to:
21	(A) Provide to residential and commercial neighbors located within 300 feet of
22	the Cannabis Business the name, phone number, and email address of an onsite manager or community
23	relations staff person who may be contacted concerning any problems associated with operation of the
24	establishment;
25	

1	(B) Maintain the Premises, adjacent sidewalk and/or alley in good condition at
2	all times; and
3	(C) Prohibit loitering in or around the Premises, and post notifications on the
4	Premises advising individuals of this prohibition.
5	(20) A staffing plan that includes an organizational chart, demonstrating the roles and
6	responsibilities of each employee and the reporting structure;
7	(21) A Community Benefits Agreement for consideration by the Director that must, at a
8	<u>minimum:</u>
9	(A) Commit to the development of a First Source Hiring Plan, as set forth in
10	Section 1618 of this Article 16; and
11	(B) Describe the Applicant's employment outreach and recruitment strategies.
12	(22) A Security Plan;
13	(23) A statement signed by the Applicant that the Applicant will not Sell or maintain on
14	the Premises Tobacco Products or alcoholic beverages;
15	(24) Documents demonstrating that the Applicant engaged in a Community Outreach
16	Strategy to advise neighbors of its intent to apply for a Cannabis Business Permit and to solicit input
17	on its proposed Good Neighbor Policy. An Applicant's Community Outreach Strategy must, at a
18	minimum, include written notice to neighbors within 300 feet of the Premises of the Applicant's intent
19	to open a Cannabis Business at that location, information about how neighbors may provide input on
20	the content of the Applicant's Good Neighbor Policy, and sign-in sheets and minutes for meetings held
21	with neighbors. All materials and notices developed and distributed to neighbors by the
22	Applicant as part of its Community Outreach Strategy must be translated into the languages
23	required by the Language Access Ordinance, Administrative Code Chapter 91;

1	(25) For Applicants with 10 or more employees, a statement that the Applicant
2	will enter into, or demonstrate that it has already entered into, and abide by the terms of a
3	Labor Peace Agreement;
4	(2565) Such further information as the Director requires regarding financial and lease
5	arrangements, management authority, operational control of the Business or its Premises, or other
6	matters, when such further information will assist the Director in his/her determination whether to
7	grant or deny the permit; and
8	(2676) A statement signed by the Applicant under penalty of perjury, that the
9	information provided is complete, true, and accurate.
10	(c) Additional Information Required of Applicants for Cannabis Cultivation Facility permits.
11	In addition to the information required under subsection (b) of this Section 1609, an Applicant for a
12	Cannabis Cultivation Facility permit shall also submit as part of its application:

21	(4) Indication on the diagram of the proposed Premises of the location of any
22	Hazardous materials and water storage;
23	(5) For Applicants that will engage in the Cultivation of Cannabis, a Cultivation Plan
24	containing such information as may be required by the Director, including but not limited to:
25	

1	(A) A list of pesticides to be used and quantities of pesticides to be stored on the
2	<u>Premises;</u>
3	(B) A list of fertilizers to be used and quantities of fertilizers to be stored on the
4	<u>Premises;</u>
5	(C) A list of any Hazardous materials to be stored on the Premises, and the
6	<u>quantities thereof</u> ;
7	(D) A copy of the Applicant's Hazardous materials plan; and
8	(E) A list of propagative materials to be used for Cultivation.
9	(6) For Applicants that will engage in the Cultivation of Cannabis, a Water Plan
10	containing such information as may be required by the Director, including but not limited to:
11	(A) Identification of the water source and supplier;
12	(B) Where applicable, the point of diversion;
13	(C) A general description of the area in which the water will be used; and
14	(D) A description of all water conservation measures.
15	(7) For Applicants that will engage in the Processing of Cannabis, an Operations Plan
16	containing such information as may be required by the Director, including but not limited to:
17	(A) Identification of the equipment to be used on the Premises;
18	(B) A list of any Hazardous materials to be stored on the Premises, and the
19	quantities thereof; and
20	(C) A copy of the Applicant's Hazardous materials plan.
21	(8) A Power Plan containing such information as may be required by the Director,
22	including but not limited to:
23	(A) The name of the energy generation provider;
24	(B) An indication of the percentage of electricity supplied from California-
25	eligible renewable and large hydroelectric sources; and

1	(C) A description of all planned energy efficiency measures.
2	(d) Additional Information Required of Applicants for Cannabis Manufacturing Facility
3	permits. In addition to the information required under subsection (b) of this Section 1609, an
4	Applicant for a Cannabis Manufacturing Facility permit shall also submit as part of its application:
5	(1) Copies of all documentation submitted to the State Licensing Authority in support of
6	its application for a State Cannabis License authorizing the Manufacture of Cannabis;
7	(2) A Manufacturing Plan, containing such information as may be required by the
8	Director, including but not limited to:
9	(A) A detailed description of all processes to be used for the extraction,
10	packaging, and/or infusion of Cannabis;
11	(B) A list of any Hazardous materials stored on the Premises, and the quantities
12	thereof;
13	(C) A copy of the Applicant's Hazardous materials plan; and
14	(D) A description of all Cannabis Products that will be Manufactured on the
15	Premises; and
16	(3) A statement signed by the Applicant acknowledging that non-Cannabis products will
17	not be Manufactured on the Premises.
18	(e) Additional Information Required of Applicants for Cannabis Testing Facility permits. In
19	addition to the information required under subsection (b) of this Section 1609, an Applicant for a
20	Cannabis Testing Facility permit shall also submit as part of its application:
21	(1) Copies of all documentation submitted to the State Licensing Authority in support of
22	its application for a State Cannabis Testing Laboratory License;
23	(2) Evidence that the Applicant has obtained or has applied for ISO/IEC 17025
24	accreditation;
0E	

1	(3) A signed statement attesting that the Applicant has no economic interest in any
2	Cannabis Businesses other than testing laboratories, such as the one for which the permit is sought;
3	(4) A Laboratory Operations Plan containing such information as may be required by
4	the Director, including but not limited to:
5	(A) A description of sampling methods to be used; and
6	(B) A description of the chain of custody controls to be used.
7	(f) Additional Information Required of Applicants for Cannabis Distributor permits. In
8	addition to the information required under subsection (b) of this Section 1609, an Applicant for a
9	Cannabis Distributor permit shall also submit as part of its application:
10	(1) Copies of all documentation submitted to the State Licensing Authority in support of
11	its application for a State Distributor License authorizing the Distribution of Cannabis and Cannabis
12	<u>Products;</u>
13	(2) A Distribution Plan containing such information as may be required by the
14	Director, including but not limited to:
15	(A) Information identifying all locations where the Applicant will store
16	<u>Cannabis or Cannabis Products;</u>
17	(B) The Vehicle Information Number for each vehicle that will be used to
18	Distribute Cannabis and Cannabis Products, and proof of insurance therefor.
19	(3) A copy of the Applicant's Cannabis Tax Permit, as may be required by Section
20	34014 of the California Revenue and Taxation Code, as may be amended from time to time, or if
21	pending, proof of application therefor.
22	(g) Additional Information Required of Applicants for Cannabis Microbusiness permits. In
23	addition to the information required under subsection (b) of this Section 1609, an Applicant for a
24	Cannabis Microbusiness permit shall also submit as part of its application:
25	

1	(1) Copies of all documentation submitted to the State Licensing Authority in support of
2	its application for a Cannabis Microbusiness License; and
3	(2) All documentation and information set forth in subsections (c), (d), (f), and (h) of
4	this Section 1609.
5	(h) Additional Information Required of Applicants for Storefront Cannabis Retailer permits.
6	In addition to the information required under subsection (b) of this Section 1609, an Applicant for a
7	Storefront Cannabis Retailer permit shall also submit as part of its application:
8	(1) Copies of all documentation submitted to the State Licensing Authority in support of
9	its application for a Retailer License.
10	(2) For Applicants that have held a valid Medical Cannabis Dispensary permit,
11	documentation demonstrating whether the on-site Smoking of Cannabis was prohibited by the Planning
12	Department or Planning Commission.
13	(3) A Storefront Cannabis Retailer Operations Plan containing such information as
14	may be required by the Director, including but not limited to:
15	(A) A description of the methods to be used to secure against theft or
16	misappropriation Cannabis Products that are not on display in the store; and
17	(B) A description of where and when shipments of Cannabis and Cannabis
18	Products will be received, and the security measures that will be implemented to ensure the safety of
19	the Retailer's employees, and the public, and to protect against the theft of Cannabis and Cannabis
20	<u>Products;</u>
21	(4) A description of how the Applicant will support the needs of Customers who qualify
22	<u>under California Health and Safety Code Sections 11362.7 et seq. to use Medicinal Cannabis,</u>
23	including but not limited to providing space where Customers may speak confidentially with employees
24	of the Cannabis Business, and ensuring a sufficient supply of Medicinal Cannabis and Medicinal
25	<u>Cannabis Products;</u>

1	(5) Indication of whether the Applicant intends to apply for a Cannabis Consumption
2	permit, as set forth in Article 8A of the Health Code, and a description of the type(s) of Consumption
3	that the Applicant proposes to allow on the Premises.
4	(6) If the Applicant intends to Deliver Cannabis or Cannabis Products to Customers,
5	the Applicant shall also provide:
6	(A) Information about the electronic platform, if any, to be used to receive and
7	process orders for Cannabis and/or Cannabis Products;
8	(B) The Vehicle Information Number for each vehicle that will be used to Deliver
9	Cannabis and Cannabis Products, and proof of insurance coverage therefor;
10	(C) A description of how the Applicant will confirm the age and identity of the
11	Customer prior to and/or upon Delivery;
12	(D) A description of how the Applicant will confirm that a Customer is qualified
13	under California Health and Safety Code Sections 11362.7 et seq. to use Medicinal Cannabis, prior to
14	and/or upon Delivery of Medicinal Cannabis or a Medicinal Cannabis Product.
15	(E) A description of how the Applicant will track drivers and Delivery status.
16	(F) A statement signed by the Applicant affirming that the Applicant:
17	(i) Will provide training to all Delivery employees concerning the laws
18	governing Sales and Deliveries of Cannabis and Cannabis Products;
19	(ii) Will take steps to ensure the personal safety of all Delivery
20	employees; and
21	(iii) Understands that the Delivery of Cannabis or Cannabis Products by
22	anyone other than an employee of the Applicant is a violation of this Article 16.
23	(7) If the Applicant intends to operate a Compassion Program, as set forth in
24	subsection (aa) of Section 1618 of this Article 16, a description of the proposed terms and
25	conditions of such program.

1	(i) Additional Information Required of Applicants for Delivery-Only Cannabis Retailer
2	permits. In addition to the information required under subsection (b) of this Section 1609, an
3	Applicant for a Delivery-Only Cannabis Retailer permit shall also submit as part of its application:
4	(1) Copies of all documentation submitted to the State Licensing Authority in support of
5	its application for a license authorizing the Delivery and Sale of Cannabis and/or Cannabis Products
6	to Customers.
7	(2) A description of how the Applicant will support the needs of Customers who qualify
8	under California Health and Safety Code Sections 11362.7 et seq. to use Medicinal Cannabis,
9	including but not limited to ensuring a sufficient supply of Medicinal Cannabis and Medicinal
10	<u>Cannabis Products.</u>
11	(3) A "Delivery-Only Cannabis Retailer Operations Plan" containing such information
12	as may be required by the Director, including but not limited to:
13	(A) Where applicable, a description of the protocols it intends to implement to
14	separately store, sell, and tax Medicinal and Adult Use Cannabis and Cannabis Products;
15	(B) A description of where and when shipments of Cannabis and Cannabis
16	Products will be received, and the security measures that will be implemented to ensure the safety of
17	the Business' employees, and the public, and to protect against the theft of Cannabis and Cannabis
18	<u>Products;</u>
19	(C) Information about the electronic platform, if any, to be used to receive and
20	process orders for Cannabis and/or Cannabis Products;
21	(D) The Vehicle Information Number for each vehicle that will be used to Deliver
22	Cannabis and Cannabis Products, and proof of insurance coverage therefor;
23	(E) A description of how the Applicant will confirm the age and identity of the
24	Customer prior to and/or upon Delivery;
25	

1	(F) A description of how the Applicant will confirm that a Customer is qualified								
2	under California Health and Safety Code Sections 11362.7 et seq. to use Medicinal Cannabis, prior to								
3	and/or upon Delivery of Medicinal Cannabis or a Medicinal Cannabis Product;								
4	(G) A description of how the Applicant will track Delivery employees and								
5	Delivery status; and								
6	(H) A statement signed by the Applicant affirming that the Applicant:								
7	(i) Will provide training to all Delivery employees concerning the laws								
8	governing Sales and Deliveries of Cannabis and Cannabis products;								
9	(ii) Will take steps to ensure the personal safety of all Delivery								
10	employees; and								
11	(iii) Understands that the Delivery of Cannabis or Cannabis Products by								
12	anyone other than an employee of the Applicant is a violation of this Article 16.								
13	(j) Upon receipt of an application for a Medicinal Cannabis Retailer, Cannabis Retailer,								
14	or Delivery-Only Cannabis Retailer permit, the Office of Cannabis shall post the name and								
15	location of the proposed Cannabis Business on its website, and shall update its website with								
16	information about the status of the application until such time as the application has been								
17	approved or denied. The Office of Cannabis shall also cause a notice to be posted on the site								
18	of the Premises associated with the aforementioned permit applications to notify neighbors								
19	that a Cannabis Business Permit is sought at that location.								
20									
21	SEC. 1610. WITHDRAWAL OF APPLICATION.								
22	An Applicant may withdraw an application at any time prior to the Office's issuance or denial								
23	of a Cannabis Business Permit. Requests to withdraw an application shall be submitted to the Office in								
24	writing, dated, and signed by the Person who submitted and signed the application. The Office shall not								
25	refund application fees for a withdrawn application. An Applicant that has withdrawn an application								

1	may reapply and pay a new application fee at any time following the withdrawal of an application, but
2	such application shall not receive priority review as set forth in subsections (c)(1), (2), and (3) of
3	<u>Section 1606.</u>
4	
5	SEC. 1611. PERMITTEE'S RESPONSIBILITY FOR ACTS OF EMPLOYEES AND
6	<u>AGENTS.</u>
7	In construing and enforcing the provisions of this Article 16 and regulations promulgated
8	thereto, any act, omission, or failure of an agent, officer, or other Person acting for or employed by a
9	Cannabis Business, within the scope of his or her employment or agency, shall be deemed the act,
10	omission, or failure of the Cannabis Business.
11	
12	SEC. 1612. INCORPORATION OF REQUIREMENTS OF LOCAL APPROVALS.
13	(a) A violation of the terms and conditions of a Cannabis Business Permit shall be treated as a
14	violation of this Article 16.
15	(b) A violation of the terms and conditions imposed on a Cannabis Business by a Referring
16	Department shall be treated as a violation of this Article 16.
17	
18	<u>SEC. 1613. LIMITS ON PERMITS.</u>
19	(a) A Permittee that holds a Cannabis Testing Facility permit shall be ineligible for and may
20	not be issued a permit to operate any other type of Commercial Cannabis Activity permitted by the
21	City. A Permittee that holds a Cannabis Business Permit other than a Cannabis Testing Facility
22	permit, shall be ineligible for and may not be issued a permit to operate a Cannabis Testing Facility.
23	(b) Except as stated in the first sentence of subsection (a) of this Section 1613, a Person may
24	hold more than one Cannabis Business Permit.
25	

1	(c) The Controller shall track the number of permits that are awarded pursuant to this
2	Article 16. Within one year of the effective date of this Article 16, the Controller shall submit to
3	the Board of Supervisors a report that makes recommendations as to whether the issuance of
4	Cannabis Business Permits should be subject to any numerical, geographical, or other limits.
5	
6	SEC. 1614. REFERRAL OF APPLICATION TO DEPARTMENTS AND AGENCIES.
7	The Director shall send the application to all appropriate Referring Departments. Those
8	departments shall complete all necessary review and inspections and report their determinations to the
9	<u>Office of Cannabis.</u>
10	
11	SEC. 1615. ISSUANCE AND DENIAL OF CANNABIS BUSINESS PERMITS.
12	(a) After reviewing an Applicant's application, the Director shall notify the Applicant in
13	writing that the application is complete and accepted for further review, or incomplete. If the Director
14	deems the application to be incomplete, the Applicant shall supply the information or documentation
15	that is required for the application to be deemed complete. The Applicant shall have 90 days from the
16	date that the Director provides notification that the application is incomplete to provide all required
17	information and/or documentation. If the Applicant does not provide such information within 90 days,
18	the application will be deemed abandoned and will not receive further consideration. Applicants that
19	abandon an application may submit a new one, subject to payment of a new application fee.
20	Applicants that submit an $Aapplication$ following the abandonment of an earlier $Aapplication$ shall not
21	<u>receive priority review, as set forth in subsections (cb)(1), (2), and (3) of Section 1606.</u>
22	(b) Upon review of a complete application and consideration of information provided by the
23	Referring Departments, the Director shall either grant or deny a permit, as specified in more detail in
24	subsections (c) and (d).
25	

1	(c) Approvals. In granting a permit, the Director may impose conditions as are, in his or her
2	judgment, necessary to protect the health and safety of the Permittee's employees, neighbors, and
3	Customers, prevent access to Cannabis and Cannabis Products by underage persons, and reduce any
4	potential adverse impacts of the Cannabis Business on the immediate neighborhood. Such conditions
5	may include, but are not limited to, conditions relating to the hours of operation.
6	(d) Mandatory Grounds for Denial. No Cannabis Business Permit shall be issued if the
7	Director finds that:
8	(1) The Applicant provided materially false information or documents in support of the
9	application.
10	(2) The Applicant failed to provide all information required by this Article 16 and by
11	the Director, in implementing this Article 16.
12	(3) The Applicant has not fully complied with the provisions of this Article 16.
13	(4) The Applicant has not demonstrated eligibility for a permit under this Article 16.
14	(5) The Premises are materially different from the diagram of the Premises submitted
15	by the Applicant.
16	(6) The City has revoked a permit for the operation of a business in the City which
17	permit had been issued to the Applicant or to any other Person who will be engaged in the management
18	of the Cannabis Business unless more than five years have passed between the date of the application
19	and the date of revocation of the other permit.
20	(7) The operation of the Cannabis Business as proposed by the Applicant, if permitted,
21	would not comply with all applicable laws, including but not limited to, the Building, Planning,
22	Housing, Police, Fire, and Health Codes of the City, the provisions of this Article 16 and any
23	regulations promulgated thereto, and the Medicinal and Adult Use Cannabis Regulation and Safety
24	Act, 2017 Cal. Legis. Serv. Ch. 27 (S.B. 94), and its implementing regulations, as may be amended from
25	time to time.

1	(8) The Applicant is employed by any local or state agency responsible for the								
2	regulation of Commercial Cannabis Activities.								
3	(9) The Applicant denied access to the Premises to the Office and/or to any Referring								
4	Department.								
5	(10) The Director finds that the Premises or the Cannabis Business will be or is being								
6	managed, conducted, or maintained in such a manner as to endanger the health and safety of the								
7	employees, Customers or neighbors, or to coerce any employee to engage in illegal conduct.								
8	(11) The Planning Department or Planning Commission determines that the								
9	Applicant engaged in Commercial Cannabis Activities in a location that was not authorized by								
10	or consistent with the Planning Code.								
11	(e) Discretionary Grounds for Denial. The Director may deny an application for a Cannabis								
12	Business Permit if the Director finds that:								
13	(1) The Applicant or Owner has been convicted of an offense that is substantially								
14	related to the qualifications, functions, or duties of the business or profession for which the application								
15	is made, except that if the Director determines that the Applicant or Owner is otherwise suitable to be								
16	issued a permit, and granting the permit would not compromise public safety, the Director shall								
17	conduct a thorough review of the nature of the crime, conviction, circumstances, and evidence of								
18	rehabilitation of the Applicant or Owner, and shall evaluate the suitability of the Applicant or Owner,								
19	to be issued a permit based on the evidence found through the review. For purposes of this subsection								
20	(e)(1), "offenses that are substantially related to the qualifications, functions, or duties of the business								
21	or profession for which the application is made" include, but are not limited to, the following:								
22	(A) A violent felony conviction, as specified in subdivision (c) of Section 667.5 of								
23	the California Penal Code;								
24	(B) A serious felony conviction, as specified in subdivision (c) of Section 1192.7								
25	of the California Penal Code;								

1	(C) A felony conviction involving fraud, deceit, or embezzlement;
2	(D) A felony conviction for hiring, employing, or using a minor in transporting,
3	carrying, selling, giving away, preparing for sale, or peddling, any controlled substance to a minor; or
4	selling, offering to sell, furnishing, offering to furnish, administering, or giving any controlled
5	substance to a minor; and,
6	(E) A felony conviction for drug trafficking with enhancements pursuant to
7	Section 11370.4 or 11379.8 of the California Health and Safety Code.
8	(2) Except as provided in subsections (e)(1)(D)-(E) of this Section 1615, a prior
9	conviction, where the sentence, including any term of probation, incarceration, or supervised release,
10	is completed, for possession of, possession for sale, sale, manufacture, transportation, or cultivation of
11	a controlled substance is not considered substantially related, and shall not be the sole ground for
12	<u>denial of a permit.</u>
13	(3) The Director concludes that there is good cause to deny the permit in accordance
14	with Section 26 of the Business and Tax Regulations Code.
15	(f) In determining whether an Application should be denied on grounds articulated in
16	subsections (d)(1) and (2) of this Section 1615, the Director shall use his or her best efforts to
17	coordinate his or her review of evidence and decision with the State Licensing Authority charged with
18	the review of the Applicant's application for a State Cannabis License.
19	
20	SEC. 1616. PAYMENT OF ANNUAL LICENSE FEE.
21	The license fee for a Cannabis Business Permit shall be paid annually on or before March 31,
22	in accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code. Upon the
23	failure of the Permittee to pay such fees, the permit shall be considered null and void, and therefore
24	inactive as a matter of law, until the Permittee pays the fees and any penalties that might be assessed
25	by the Director.

2	SEC. 1617. COMPLIANCE WITH PERMIT CONDITIONS.
3	(a) No Permittee shall operate a Cannabis Business in a manner inconsistent with any permit
4	condition imposed by the Director or by a Referring Department.
5	(b) A Permittee may request a permit amendment to remove or change a condition imposed by
6	the Director by filing a request with the Office of Cannabis and paying such permit amendment
7	application fee as may be required.
8	(c) The Director shall consider whether the amendment of the permit condition sought by the
9	Permittee would jeopardize the health and safety of the Permittee's employees, neighbors, or
10	Customers, increase access to Cannabis and Cannabis Products by underage persons, or increase any
11	potential adverse impacts of the Cannabis Business on the immediate neighborhood, and shall render a
12	decision to remove, change, or maintain the permit condition(s) on the basis of that evaluation or for
13	any good cause.
14	(d) A decision of the Director to impose a permit condition, or to refuse to remove or amend a
15	permit condition, may be appealed to the Board of Appeals in the manner prescribed in Article 1 of the
16	Business and Tax Regulations Code.
17	
18	SEC. 1618. ELIGIBILITY AND OPERATING STANDARDS APPLICABLE TO ALL
19	CANNABIS BUSINESSES.
20	(a) Every Cannabis Business is required to obtain a business license from the City in
21	compliance with Article 2 of the Business and Tax Regulations Code.
22	(b) Every Cannabis Business is required to obtain a business registration certificate
23	from the City in compliance with Article 12 of the Business and Tax Regulations Code. Every
24	Cannabis Business is required to have paid all outstanding taxes and fees, including any
25	related penalties and interest, owed to the City, and is required to have obtained a business

1	registration certificate from the City in compliance with Article 12 of the Business and Tax								
2	Regulations Code.								
3	(c) Every Cannabis Business is required to obtain a State Cannabis License prior to engaging								
4	in any Commercial Cannabis Activities.								
5	(d) Every Cannabis Business is required to prominently display on its Premises its Cannabis								
6	Business Permit, State Cannabis License, Business Registration, and Seller's Permit, if required to hold								
7	<u>a Seller's Permit.</u>								
8	(e) Every Cannabis Business shall operate within fully enclosed and secure structures that are								
9	inaccessible to underage persons.								
10	(f) It shall be a violation of this Article 16 for a Cannabis Business to sell or maintain alcoholic								
11	beverages and/or Tobacco Products on the Premises of the Cannabis Business.								
12	(g) Every Cannabis Business shall enter into a First Source Hiring Agreement, as defined by								
13	Section 83.4 of the Administrative Code, pursuant to which it agrees to comply with the first source								
14	hiring requirements set forth in subsections (b)(1)-(8) of Section 83.9 of the Administrative Code.								
15	(h) Every Cannabis Business is required to submit a "modification request" to the Office of								
16	Cannabis prior to making any change that would materially or substantially alter the Premises from								
17	the diagram of the Premises on file with the Office of Cannabis, and shall not make the proposed								
18	change absent approval from the Director.								
19	(i) Every Cannabis Business is required to use the business name listed on its Cannabis								
20	Business Permit when applying for any other permits or licenses relating to the operation of the								
21	Cannabis Business, and when applying for a State Cannabis license.								
22	(j) Every Cannabis Business is required to provide identification badges to all employees that								
23	display: (1) the name of the Cannabis Business; (2) the number of the Cannabis Business' Cannabis								
24	Business Permit; and (3) a photo of the employee's face. Such identification badges must be worn by								
25									

1	employees at all times when they are on the Premises of the Cannabis Business, and when acting in the								
2	scope of their employment.								
3	(k) Every Cannabis Business is required to maintain on the Premises a fire proof safe.								
4	(1) A Cannabis Business shall not enter into a sublease for use of any part of the Premises by								
5	another entity without the prior approval of the Director.								
6	(m) A Physician's Recommendation for Medicinal Cannabis may not be sought, issued,								
7	provided, or procured on the Premises of a Cannabis Business.								
8	(n) At any time a Cannabis Business is open for operation, there shall be at least one person on								
9	the Premises who is responsible for the operation of the Cannabis Business and who is readily								
10	available to respond to and interact with all inspecting departments and agencies, the Director, or any								
11	other City employee or official.								
12	(o) No Cannabis Business that is an A-licensee may employ an individual who is not at least								
13	21 years of age. No Cannabis Business that is an M-licensee may employ an individual who is								
14	not at least 18 years of age. Where a Cannabis Business is both an A-licensee and an M-								
15	licensee, it may not employ an individual who is not at least 21 years of age.								
16	(p) Every Cannabis Business is required to comply with all aspects of the state's "Track and								
17	Trace" program, as set forth in Section 26067 of the California Business and Professions Code, as may								
18	be amended from time to time.

4	(2) Alcoholic beverages.
5	(s) Every Cannabis Business shall comply with the terms of its Good Neighbor Policy and
6	<u>Security Plan.</u>
7	(t) Every Cannabis Business is required to keep all garbage, recycling, and compost containers
8	on the Premises and hidden from public view, and placed outside only when being serviced by the
9	disposal company. Trash shall be contained and disposed of pursuant to garbage and recycling
10	receptacle guidelines set forth by the Department of Public Works.
11	(u) The Premises of every Cannabis Business shall be adequately soundproofed or insulated for
12	noise, as may be required by the Planning and/or Building Codes, or by permits issued pursuant to
13	those Codes. Noise generated by fixed-source equipment shall not exceed the decibel levels specified in
14	Article 29 of the Police Code, as may be amended from time to time. Violations of this subsection (u),
15	including noise that exceeds the decibel levels specified in Article 29 of the Police Code, are subject to
16	the penalties set forth in this Article 16.
17	(v) Appropriate odor control equipment shall be installed in conformance with the approved
18	odor plan and maintained to prevent any significant noxious or offensive odors from escaping the
19	<u>Premises.</u>
20	(w) Every Cannabis Business shall maintain the main entrance to the Premises and all
21	sidewalks abutting the subject property in a clean and sanitary condition in compliance with the
22	Department of Public Works' Street and Sidewalk Maintenance Standards.
23	(x) Every Cannabis Business shall comply with signage controls as established in accordance
24	with the Planning Code.
25	

1	(y) Every Cannabis Business shall register with the Office each location within the City where								
2	Cannabis and Cannabis Products will be stored.								
3	(z) Every Cannabis Business shall protect personally identifiable information and protected								
4	health information from unauthorized disclosure, to the extent required by the Health Insurance								
5	Portability and Accountability Act, the California Medical Information Act, Article 1 of the California								
6	Constitution, the California Health and Safety Code and regulations promulgated thereunder, and any								
7	other applicable provision of federal or state law.								
8	(aa) It shall be a violation of this Article 16 for any Cannabis Business to engage in the nonsale								
9	distribution of Cannabis or Cannabis Products, or to permit the nonsale distribution of Cannabis or								
10	Cannabis Products by any Person on the Premises of the Cannabis Business, except as authorized by								
11	state law. Notwithstanding the forgoing, and as authorized by state law, a Storefront Cannabis								
12	Retailer may operate a Compassion Program in which it provides Medicinal Cannabis and/or								
13	Medicinal Cannabis Products at no or nominal cost to low-income individuals who are								
14	qualified under California Health and Safety Code Sections 11362.7 et seq. to use Medicinal								
15	Cannabis. The Director shall adopt rules, regulations and guidelines applicable to

18	of this subsection (aa), "nonsale distribution" means to give Cannabis or Cannabis Products to the								
19	general public or some segment thereof at no cost, or at nominal cost, or to give coupons, coupon								
20	offers, or rebate offers for Cannabis or Cannabis Products to the general public or some segment								
21	thereof at no cost or at nominal cost.								
22	(bb) A Cannabis Business shall conduct an Energy Efficiency Audit Reporting, as may be								
23	required by Chapter 20 of the Environment Code.								
24	(cc) Every Cannabis Business shall ensure that the electrical power used for Commercial								
25	Cannabis Activities shall be procured from or produced by renewable sources, consistent with

17	any Medicinal Cannabis or Medicinal Cannabis Products to any person who is under the age of 18
18	and/or who does not possess a valid Physician's Recommendation.
19	(c) Positive Bona Fide Proof of Identity Required. No Storefront Cannabis Retailer,
20	Cannabis Microbusiness, or Delivery-Only Cannabis Retailer may Sell Cannabis or Cannabis
21	Products to any Customer without first examining the Customer's Bona Fide Proof of Age and Identity
22	to confirm that the Customer is at least the minimum age under state law to purchase and possess the
23	Cannabis or Cannabis Product. Review of a Customer's Bona Fide Proof of Age must be performed by
24	an employee of the Permittee, in the presence of the prospective Customer.
25	

1	(d) <b>Proof of Physician's Recommendation Required.</b> No Storefront Cannabis Retailer,
2	Cannabis Microbusiness, or Delivery-Only Cannabis Retailer may Sell Medicinal Cannabis or
3	Medicinal Cannabis Products to any Customer without first examining verification that the Customer
4	possesses a valid Physician's Recommendation. Review of a Customer's verification of Physician's
5	Recommendation must be performed by an employee of the Permittee, in the presence of the
6	prospective Customer.
7	
8	SEC. 1620. CONSUMPTION AND SMOKING OF CANNABIS AND CANNABIS
9	PRODUCTS ON THE PREMISES OF CANNABIS BUSINESSES.
10	(a) The Consumption and Smoking of Cannabis and Cannabis Products areis prohibited on
11	the Premises of all Cannabis Manufacturing Facilities, Cannabis Cultivation Facilities, Cannabis
12	Testing Facilities, Cannabis Distributors, and Delivery-Only Cannabis Retailers.
13	(b) The Consumption of Cannabis Products is not prohibited on the Premises of Medicinal
14	Cannabis Retailers, Cannabis Retailers, and Cannabis Microbusiness, provided, however, that all of
15	the following conditions are present:
16	(1) The Cannabis Business has received and maintained a valid Cannabis Consumption
17	Permit from the Department of Public Health, as set forth in Article 8A of the Health Code, authorizing
18	onsite Consumption of Cannabis Products;
19	(2) Access to the area where the Consumption of Cannabis Products is allowed is
20	restricted to persons 21 years of age and older, or persons 18 years of age and older, if the Permitted
21	Businesses is authorized to Sell Medicinal Cannabis and Medicinal Cannabis Products;
22	(3) Cannabis Consumption is not visible from any public place or nonage-restricted
23	area; and
24	(4) Sale and Consumption of alcohol or Tobacco Products are not allowed on the

25 <u>Premises.</u>

1	(c) The Smoking of Cannabis and Cannabis Products is prohibited on the Premises of
2	Medicinal Cannabis Retailers, Cannabis Retailers, and Cannabis Microbusinesses, absent
3	authorization from the Director of the Department of Public Health, as set forth in Section
4	1009.23 of the Health Code. Where authorized by the Director of Health, the Smoking of
5	Cannabis and Cannabis Products shall be subject to the limitations on Consumption set forth
6	in subsection (b)(2)-(4) of this Section 1620.
7	(etc) All Cannabis Businesses shall:
8	(1) Post clear and prominent signs at each entrance to the Premises advising
9	Customers that the Smoking of Cannabis is prohibited in public places, including on sidewalks and in
10	the entryways of businesses;
11	(2) Post clear and prominent "No Smoking" signs in any area of the Premises where
12	Smoking is prohibited;
13	(3) Post clear and prominent "No Consuming Cannabis" signs in any area of the
14	Premises where the Consumption of Cannabis and Cannabis Products is prohibited; and
15	(4) Request that any person Smoking or Consuming Cannabis or Cannabis Products
16	where Smoking or Consumption are prohibited refrain from Smoking and/or Consuming.
17	
18	<u>SEC. 1621. TOURS.</u>
19	(a) It shall be a violation of this Article 16 for Cannabis Testing Facilities, Cannabis
20	Distributors, and Delivery-Only Cannabis Retailers to permit a tour to be conducted on the Premises.
21	(b) Prior to January 1, 2019, it shall be a violation of this Article 16 for a Cannabis
22	Manufacturing Facility, a Cannabis Cultivation Facility, or a Cannabis Microbusiness to permit a tour
23	to be conducted on the Premises.
24	(c) For purposes of this Section 1621, a "tour" means an organized or prearranged visit by a
25	member or members of the general public, or segment thereof, whether free or for charge, who wish to

1	view the Premises, learn about its methods of operation, and/or gain insight into the Cannabis industry.
2	<u>A "tour" does not include visits by:</u>
3	(1) Employees of the Cannabis Business;
4	(2) Employees of other Cannabis Businesses licensed by the State of California with
5	which the Permittee is conducting business;
6	(3) Persons authorized to conduct inspections;
7	(4) Persons engaging in law enforcement activities;
8	(5) Persons providing incidental business services, such as repairs or, deliveries; or
9	(6) Persons affiliated with a government agency who have received approval from the
10	Cannabis Business and the Office of Cannabis to conduct a tour of the Cannabis Business.
11	(d) Prior to January 1, 2019, the Director shall adopt rules and regulations governing tours of
12	Cannabis Businesses. The Director is authorized to extend the prohibition on tours set forth in
13	subsection (b) of this Section 1621, or authorize tours, subject to limitations he or she may adopt to
14	protect the health and safety of employees, neighbors and Customers, prohibit access to Cannabis and
15	Cannabis Products by underage persons, preserve the character of the surrounding neighborhood, and
16	mitigate any potential noise and/or traffic congestion.

18	SEC. 1622. DELIVERIES OF CANNABIS AND CANNABIS PRODUCTS TO
19	<u>CUSTOMERS.</u>
20	(a) The Delivery of Cannabis or Cannabis Products to Customers within San Francisco is
21	prohibited except by Storefront Cannabis Retailers and Delivery-Only Cannabis Retailers that are
22	permitted by the Office of Cannabis and receive express authorization to engage in Deliveries from the
23	Director. The Delivery of Cannabis or Cannabis Products within San Francisco by Cannabis
24	Businesses that are located outside of San Francisco is prohibited.

1	(b) Permitted Cannabis Businesses that receive authorization from the Director to engage in
2	Deliveries must comply with such Delivery Standards as may be adopted by the Director, including but

4	(1) Deliveries may only be conducted by employees of the Permitted Cannabis Business.
5	Deliveries may not be conducted by independent contractors.
6	(2) An employee conducting a Delivery must deliver the Cannabis or Cannabis Product
7	to an address associated with real property (e.g. not to a street corner or location within a park).
8	(3) Orders must be completed by individuals aged 21 or over (with valid California
9	driver's license or Identification card).
10	(4) Deliveries must be made during the Cannabis Business' hours of operation.
11	(5) Delivery may only be made to the individual who placed the Bona Fide Order, and
12	to individuals who are 21 years of age or older, unless the Customer provides verification that the
13	Customer, or a patient for whom he or she is a Primary Caregiver, qualifies under California Health
14	and Safety Code Section 11362.7 et seq. to use Medicinal Cannabis.
15	(6) Upon Delivery, the employee performing the Delivery must:
16	(A) Personally review the Bona Fide Proof of Age and Identity of the Customer
17	to confirm that he or she is the same individual who submitted the Bona Fide Order, and is not
18	underage, as set forth in Section 1619 of this Article 16;
19	(B) Where the product being sold is Medicinal Cannabis or a Medicinal
20	Cannabis Product, personally review documentation verifying that the Customer possesses a valid
21	Physician's Recommendation;
22	(C) Require the Customer to sign a document indicating the type and quantity of
23	Cannabis and/or Cannabis Products that were Delivered; and
24	
25	

1	(D) Distribute to each Customer at the time of sale a fact sheet relating to safe
2	Consumption of Cannabis and Cannabis Products, the content of which shall be produced by the
3	Department of Public Health.
4	(7) A Cannabis Business may not Deliver more than 28.5 grams of non-concentrated
5	Cannabis or eight grams of concentrated Cannabis Products to the same real property (e.g. apartment
6	unit or house) in the same business day.
7	(8) Cannabis and Cannabis Products that are Delivered to a Customer must:
3	(A) Comply with the all State and local packaging and labeling rules; and,
	(B) Be placed in an opaque child resistant Delivery receptacle.
)	(9) All Cannabis and Cannabis Products shall be kept in a lock-box securely affixed
	inside the Delivery vehicle.
	(10) A manifest must be created for each Delivery or series of Deliveries prior to
	departure, and the Delivery employee may not make any unnecessary stops between Deliveries or
	deviate substantially from the manifest route, unless a stop is necessary for personal safety.
	(11) A Cannabis Business authorized to engage in the Delivery of Cannabis and/or
	Cannabis Products shall comply with all track and trace requirements imposed by state law, and shall
	document the following information regarding Deliveries pursuant to track and trace:
	(A) The date and time the Bona Fide Order was received by the Cannabis
	<u>Business;</u>
	(B) The date and time the Cannabis and/or Cannabis Products were Delivered;
	(C) A description of the Cannabis and/or Cannabis Products that were
	Delivered, including the weight or volume and price paid by the Customer;
	(D) The name of the Delivery employee who performed the Delivery; and
	(E) The name of the individual to whom the Delivery was made, and the
	Delivery address.

1	(12) A Cannabis Business authorized to engage in Deliveries must Deliver Cannabis
2	and Cannabis Products by Vehicle only. Delivery of Cannabis and Cannabis Products by motorcycles,
3	scooters, drones, human powered vehicles, and unmanned vehicles is prohibited.
4	
5	SEC. 1623. CANNABIS CULTIVATION FACILITIES.
6	(a) Authorized activities. A Cannabis Cultivation Facility Permit authorizes the Permittee to
7	engage in the Commercial Cultivation and Processing of Medicinal Cannabis and Adult Use Cannabis,
8	provided that the Permittee is both an A-licensee and an M-licensee. A Cannabis Cultivation Facility
9	Permittee that holds only an A-license may engage in the Commercial Cultivation and Processing of
10	Adult Use Cannabis only. A Cannabis Cultivation Facility Permittee that holds only an M-License may
11	engage in the Cultivation and Processing of Medicinal Cannabis only.
12	(b) <b>Operating Standards.</b> In addition to the operating requirements set forth in Section 1618 of
13	this Article 16, a Cannabis Cultivation Facility shall comply with the following Cultivation operating
14	standards:
15	(1) The Premises to be used as a Cannabis Cultivation Facility may not exceed 22,000
16	square feet of total Canopy. Canopy shall be calculated on a square foot basis and shall include any
17	vertical growth space, such as shelving.
18	(2) A Cannabis Cultivation Facility may engage in the indoor Cultivation of Cannabis
19	only; the outdoor Cultivation of Cannabis is prohibited. For purposes of this Article 16, "indoor
20	Cultivation" and "outdoor Cultivation" shall have the meaning set forth in regulations promulgated by
21	the California Department of Food and Agriculture pursuant to the Medicinal and Adult Use Cannabis
22	Regulation and Safety Act.
23	(3) All Cultivation activities must not be visible from the public right-of-way.
24	(4) A Cannabis Cultivation Facility must have weighing and measuring devices used in
25	connection with the Sale or Distribution of Cannabis that meet state standards.

- 12 (1) A Cannabis Manufacturing Facility may Manufacture Cannabis Products only; it
   13 may not Manufacture products that do not contain Cannabis.
- 14 (2) A Cannabis Manufacturing Facility may engage in Cannabis oil extraction, subject
- 15 *to any limitations imposed by the Planning Code, the Planning Department or the Planning*

- 17 (3) A Cannabis Manufacturing Facility may not produce or Sell Edible Cannabis

- 20 *thereto*.
- 21 (4) A Cannabis Manufacturing Facility may use Volatile Solvents only if the operator
- 22 <u>holds a State Cannabis License authorizing their use.</u>
- 23 (5) A Cannabis Manufacturing Facility using Volatile Solvents for Manufacturing
- 24 *Cannabis Products must operate in a manner to reduce the risk of explosion or danger to public health,*

4	SEC. 1625. CANNABIS TESTING FACILITIES.

8	(b) <b>Operating Standards.</b> In addition to the operating requirements set forth in Section 1618 of
9	this Article 16, a Cannabis Testing Facility shall:
10	(1) Notify the Department of Public Health and Office of Cannabis of any tests
11	performed on Cannabis or Cannabis Products Cultivated or Manufactured by a Cannabis Business
12	located in San Francisco where the Cannabis batch fails the testing requirements established by state
13	regulation within five business days of conducting such test. Such notification shall include the name,
14	State license number and local Permit number of the Manufacturer that provided the Cannabis to be
15	tested, and information related to the test results, reason for failure, and any applicable track and trace
16	information;
17	(2) Notify the Office of Cannabis within 24 hours of conducting a test if a sample that
18	was Cultivated, Manufactured, or supplied by a Cannabis Business located in San Francisco is found
19	to contain levels of a contaminant not allowable by the State that could be injurious to human health if
20	Consumed. The Office of Cannabis shall provide this information to appropriate City and state
21	departments, including but not limited to the Department of Public Health;
22	(3) Notify the Office of Cannabis within one business day after receipt of notice that
23	accreditation as a Cannabis Laboratory has been denied, suspended or revoked; and
24	(4) Employ at least one full-time employee responsible for quality control.

1	SEC. 1626. CANNABIS DISTRIBUTORS.
2	(a) Authorized activities. A Cannabis Distributor Permit authorizes the Permittee to engage in
3	the Commercial Distribution of Medicinal Cannabis and Adult Use Cannabis, provided that the
4	Permittee is both an A-licensee and an M-licensee. A Cannabis Distributor that holds only an A-
5	license may engage in the Commercial Distribution of Adult Use Cannabis and Cannabis Products
6	only. A Cannabis Distributor that holds only an M-License may engage in the Commercial
7	Distribution of Medicinal Cannabis and Cannabis Products only.
8	(b) <b>Operating Standards.</b> In addition to the operating requirements set forth in Section 1618 of
9	this Article 16, a Cannabis Distributor shall comply with the following operating standards:
10	(1) A Cannabis Distributor shall inspect all Cannabis and Cannabis Products received
11	by it for quality assurance prior to Distribution.
12	(2) A Cannabis Distributor shall Distribute Cannabis and Cannabis Products by
13	Commercial Vehicle only. Distribution by non-Commercial Vehicles, drones, human powered vehicles,
14	and unmanned vehicles is prohibited.
15	
16	SEC. 1627. CANNABIS MICROBUSINESSES.
17	(a) Authorized activities. A Cannabis Microbusiness Permit authorizes the Permittee to
18	engage in the Commercial Cultivation, Manufacture, Distribution, and Sale of Medicinal Cannabis and
19	Cannabis Products and Adult Use Cannabis and Cannabis Products, provided that the Permittee is
20	both an A-licensee and an M-licensee. A Cannabis Microbusiness that holds only an A-license may
21	engage in the aforementioned Commercial activities relating to Adult Use Cannabis and Cannabis
22	Products only. A Cannabis Microbusiness that holds only an M-License may engage in the
23	aforementioned Commercial activities relating to Medicinal Cannabis and Cannabis Products only.
24	
25	

1	(b) <b>Operating Standards.</b> In addition to the operating requirements set forth in Section 1618, a
2	Cannabis Microbusiness shall comply with the operating standards set forth in Sections 1623, 1624,
3	1626, and 1628 of this Article 16, and shall comply with the following additional operating standards:
4	(1) A Cannabis Microbusiness shall conduct all four categories of Commercial activity
5	(Cultivation, Manufacture, Distribution, and Sale) on the same Premises.
6	(2) The area on which a Cannabis Microbusiness Cultivates Cannabis must be less than
7	<u>10,000 square feet.</u>
8	(3) The use of Volatile Solvents by a Cannabis Microbusiness is prohibited.

10	SEC. 1628. STOREFRONT CANNABIS RETAILERS.
11	(a) Authorized activities.
12	(1) A Medicinal Cannabis Retailer permit authorizes the Permittee to engage in the

21	the Delivery of Cannabis or Cannabis Products to Customers unless the Director has authorized the
22	Permittee to engage in deliveries, as set forth in Section 1622 of this Article 16.
23	(b) <b>Operating Standards.</b> In addition to the operating requirements set forth in Sections 1618,
24	a Storefront Cannabis Retailer shall comply with the following additional operating requirements:
25	(1) A Storefront Cannabis Retailer must be operated from a fixed place of business. It

1	may not be operated out of a bus, truck, car, van, or any other mobile location or location that is
2	capable of being mobile.
3	(2) A Storefront Cannabis Retailer shall post staff at the point of entry to the Premises
4	to confirm that all Customers who enter are not underage, as set forth in Section 1619 of this Article
5	<u>16.</u>
6	(3) A Storefront Cannabis Retailer must distribute to each Customer at the time of Sale,
7	a fact sheet relating to safe Consumption of Cannabis and Cannabis Products, to be produced by the
8	Department of Public Health.
9	(4) A Storefront Cannabis Retailer shall not employ or enter into any agreements with
10	any physicians who recommend Medicinal Cannabis or with any third party that employs physicians
11	who recommend Medicinal Cannabis.
12	(5) A Storefront Cannabis Retailer licensed to sell Adult Use Cannabis may not Sell
13	more than 28.5 grams of non-concentrated Adult Use Cannabis or eight grams of concentrated Adult
14	Use Cannabis Products to a Customer in the same business day.
15	(6) A Storefront Cannabis Retailer licensed to sell Medicinal Cannabis may not Sell
16	more than 28.5 grams of non-concentrated Medicinal Cannabis or eight grams of concentrated
17	Medicinal Cannabis Products to a Customer in the same business day, unless the Customer provides a
18	Physician's Recommendation requiring a greater amount.
19	(7) A Storefront Cannabis Retailer may not:
20	(A) Allow Customers on the Premises during hours of closure;
21	(B) Store Cannabis or Cannabis Products in any location other than on the
22	permitted Premises;
23	(C) Sell Cannabis or Cannabis Products through a drive-up window;
24	(D) Give away or Sell pressurized containers of butane or other materials that
25	could be used in the home production of Cannabis extract.

1	(8) A Storefront Cannabis Retailer may accept returns of Cannabis and Cannabis
2	Products that were previously sold by the Storefront Cannabis Business, but shall not resell Cannabis
3	or Cannabis Products that have been returned. A Storefront Cannabis Retailer shall treat any
4	Cannabis and Cannabis Products that are abandoned on the Premises as a return. A Storefront
5	Cannabis Retailer shall destroy all Cannabis and Cannabis Products that have been returned as
6	required by the State of California.
7	(9) A Storefront Cannabis Retailer must maintain an electronic age verification device
8	to determine the age of any individual attempting to purchase Cannabis or Cannabis Products, which
9	device shall be used for the Sale of the Cannabis or Cannabis Products to the Customer. The device
10	shall be maintained in operational condition and all employees shall be instructed in its use. Cannabis
11	and Cannabis products shall not be sold to a Customer if the electronic age verification device is not
12	functioning.
13	(10) All operating standards applicable to Sales of Cannabis and Cannabis Products that
14	are made on the Premises of the Cannabis Business shall apply equally to Sales that are made by Delivery
15	pursuant to Section 1622.

17	SEC. 1629. DELIVERY-ONLY CANNABIS RETAILERS.
18	(a) Authorized Activities.
19	<u>A Delivery-Only Cannabis Retailer permit authorizes requires the Permittee to engage in the</u>
20	Delivery and Sale of both Medicinal Cannabis and Cannabis Products and Adult Use Cannabis and
21	Cannabis Products, provided that the Permittee is both an A-licensee and an M-licensee. A
22	Delivery-Only Cannabis Retailer Permittee that holds only an A-license may engage in the
23	Delivery and retail Sale of Adult Use Cannabis and Cannabis Products only. A Delivery-Only
24	Cannabis Retailer Permittee that holds only an M-License may engage in the Delivery and
25	retail Sale of Medicinal Cannabis and Cannabis Products only.

1	(b) <b>Only Delivery Authorized.</b> The Premises of a Delivery-Only Cannabis Retailer must be
2	closed to the public and all Sales must be conducted exclusively by Delivery. A Delivery-Only
3	Cannabis Retailer may not permit entry on to its Premises by Customers.
4	(c) <b>Operating Standards.</b> In addition to the operating requirements set forth in Sections 1618,
5	a Delivery-Only Cannabis Retailer shall comply with the following additional operating requirements:
6	(1) A Delivery-Only Cannabis Retailer licensed to sell Adult Use Cannabis may not
7	Sell more than 28.5 grams of non-concentrated Adult Use Cannabis or eight grams of concentrated
8	Adult Use Cannabis Products to a Customer in the same business day.
9	(2) A Delivery-Only Cannabis Retailer licensed to sell Medicinal Cannabis may not Sell
10	more than 28.5 grams of non-concentrated Medicinal Cannabis or eight grams of concentrated
11	Medicinal Cannabis Products to a Customer in the same business day, unless the Customer provides a
12	Physician's Recommendation requiring a greater amount.
13	(3) All inventory must be stored on the Premises.
14	(4) A Delivery-Only Cannabis Retailer may not employ or enter into any agreements
15	with any physicians who recommend Medicinal Cannabis or with any third party that employs
16	physicians who recommend Medicinal Cannabis.
17	(5) A Delivery-Only Cannabis Retailer must provide to all Delivery personnel a remote
18	electronic age verification device to determine the age of any individual attempting to purchase
19	Cannabis or Cannabis Products, which device shall be used upon the Delivery of the Cannabis or
20	Cannabis Products to the Customer. The device shall be maintained in operational condition and all
21	employees shall be instructed in its use. Cannabis and Cannabis products shall not be Delivered to a
22	Customer if the electronic age verification device is not functioning.
23	
24	SEC. 1630. INSPECTIONS.
25	(a) Any member of the Office of Cannabis, the Police Department, the Department of Public

13	revocation of Cannabis Business Permit(s);
14	(4) That the Cannabis Business, owner of real property, and/or any other Person
15	deemed responsible for causing the violation(s) has the right to request a hearing before the Director
16	within 15 days after the Notice of Violation is mailed, and that the written request for hearing must
17	state facts demonstrating that:
18	(A) If the violation is disputed, the Cannabis Business was operating in
19	compliance with this Article 16 and/or the rules and regulations adopted pursuant to this Article; and
20	(B) Whether or not the violation is disputed, the Cannabis Business is currently
21	operating in compliance with this Article 16 and/or the rules and regulations adopted pursuant to this

22	(5) The Director finds good cause to suspend or revoke the permit in accordance with
23	Business and Tax Regulations Code Sections 24 and 26;
24	(6) An Owner or manager of the Cannabis Business willfully violated this Article;
25	(7) An Owner or manager of the Cannabis Business willfully made a false statement to

- 1 *the Office, or discovered a false statement made to the Office by any employee or agent of the Cannabis*
- 2 <u>Business and failed to promptly correct such statement; or</u>
- 3 (8) An Owner has been convicted of a controlled substance felony subsequent to the
  award of a Cannabis Business Permit;
- 5 (b) The Director may not suspend or revoke a Cannabis Business Permit under this Article 16

6	(a) Order to Cease Operations Without Permit. Upon a determination by the Director that

8	Article 16, the Director shall issue an Order to Cease Operations Without Permit, which shall be
9	posted prominently on the Premises and mailed to the Cannabis Business. Such Order shall state:
10	(1) The required permits which are lacking;
11	(2) That the Cannabis Business has 72 hours from the time of posting to demonstrate to
12	the Director's satisfaction that the Cannabis Business has the required valid, effective, and current
13	<u>permits;</u>
14	(3) If the Cannabis Business has not made such demonstration within 72 hours, that the
15	Cannabis Business must immediately close until such time as it demonstrates to the Director's
16	satisfaction that the Cannabis Business has the required permits; and
17	(4) If the Cannabis Business fails to close as required by this subsection (a), that the
18	Director shall issue an Immediate Closure Order and close the Premises.
19	(b) Order to Cease Operations without a Permit Inapplicable to Permit Suspensions and
20	<b>Revocations.</b> As set forth in subsection (b) of section 1633, a Cannabis Business whose permit has
21	been suspended or revoked must cease operations within 24 hours of the suspension or revocation
22	order being final. The Director is not required to issue an Order to Cease Operations without a Permit
23	to a Cannabis Business whose Cannabis Business Permit is subject to a final order of suspension or
24	revocation.
25	(c) Immediate Closure Order. The Director shall issue an Immediate Closure Order ordering

1	closure of a Cannabis Business under the following circumstances:
2	(1) 72 hours after the issuance of an Order to Cease Operations Without Permit, the
3	Cannabis Business has not demonstrated to the Director's satisfaction that the Cannabis Business has
4	the required permits, and the Cannabis Business nevertheless continues to operate;
5	(2) 24 hours after the suspension or revocation of a permit becomes final, the Cannabis
6	Business continues to operate;
7	(3) Without delay, after issuance of a summary suspension.
8	(d) <b>Enforcement.</b> It is the duty of a Cannabis Business and any person owning or managing a
9	Cannabis Business, to obey all orders issued under this Section 1634. To enforce an Immediate
10	Closure Order, the Director shall take such steps as the Director views as reasonable and necessary to
11	enforce such order, including but not limited to securing and barricading the Premises. The Director
12	is hereby authorized to call upon the Police Department and other departments and bureaus to aid and
13	assist the Director in such enforcement, and it shall then be their duty to enforce the provisions of this
14	Article and to perform such duties as may come within their respective jurisdictions.

22	"Preparing" or "Preparation" means the heating, re-heating, or serving of Cannabis Products,
23	and does not include cooking or infusing.

25	SEC. 8A.2. PERMITS FOR THE ON-SITE CONSUMPTION OF CANNABIS.

1	It shall be unlawful to allow the Consumption of Cannabis or Cannabis Products on the
2	Premises of a commercial business without obtaining and maintaining:
3	(a) A permit therefor issued by the Department of Public Health; and
4	(b) A Medicinal Cannabis Retailer, Cannabis Retailer, or Cannabis Microbusiness permit
5	issued by the Office of Cannabis; and
6	(c) A State Cannabis License.

8	SEC. 8A.3. CANNABIS CONSUMPTION PERMIT TYPES.
9	<u>There are twothree types of permits available for the purpose of legalizing and regulating the</u>

11	(a) Cannabis Consumption – Prepackaged Cannabis Products – No Preparation. A
12	Permittee in possession of this permit type may allow the on-site Consumption of Pre-Packaged

14	(b) Cannabis Consumption – Limited Preparation of Cannabis Products. A Permittee in
15	possession of this permit type may allow the on-site Consumption of Pre-Packaged Cannabis Products,
16	and may also Prepare and allow the Consumption of Cannabis Products.
17	(c) Cannabis Smoking. A Permittee in possession of this permit type may allow the
18	on-site Smoking of Cannabis, and may also allow the Consumption of Pre-packaged
19	Cannabis Products, and/or the Consumption of prepared Cannabis Products, subject to
20	approval by the Director.
21	
22	SEC. 8A.4. PERMIT APPLICATIONS AND AWARDS.
23	(a) Every applicant for a Cannabis Consumption Permit shall file an application with the
24	Director upon a form provided by the Director and provide such additional information as may be
25	required by the Director, in the exercise of his or her discretion. Every applicant shall pay a non-

1	refundable application fee, unless the applicant is eligible for a fee waiver or reduction, as
2	authorized by ordinance.
3	(b) A person may not file and the Director may not accept an application for a Cannabis
4	Consumption Permit until after the Director has adopted rules, regulations, and/or guidelines to
5	establish the minimum health and safety standards applicable to Permittees, as set forth in Section
6	<u>8A.8.</u>
7	(c) Upon receipt of a complete application, the Director shall refer the application to the
8	Planning Department, the Department of Building Inspection, and Fire Department (the "Referring
9	Departments). The Referring Departments shall determine whether an inspection of the premises is
10	warranted in light of the type of Cannabis Consumption Permit sought and any inspection history at the
11	premises, and shall conduct inspections as may be required. Said departments shall advise the
12	Director in writing whether they recommend approval or denial of the application for the Cannabis
13	Consumption permit, and the basis for that recommendation.
14	(d) Upon review of a complete application and consideration of the recommendations of the
15	Referring Departments, the Director shall either grant or deny a permit, as specified in more detail in
16	subsections (e) and (f) of this Section 8A.4.
17	(e) In granting a permit, the Director may impose conditions as are, in his or her judgment,
18	necessary to protect the health and safety of the Permittee's employees and customers.
19	(f) No Cannabis Consumption permit shall be issued if the Director finds that:
20	(1) The applicant has provided materially false information or documents (which
21	includes omitting material information or documents) in support of the application.
22	(2) The applicant failed to submit a complete application and/or did not provide all of
23	the information required in connection with the application.
24	(3) The applicant has not demonstrated that it can meet the health and safety standards
25	adopted by the Director under Section 8A.8.

5	(4 <u>5) A Referring Department recommends that the application be denied and states a</u>
6	sound basis for such recommendation.
7	(56) The on-site Consumption of Cannabis or Cannabis Products, if permitted, would
8	not comply with all applicable laws, including but not limited to the Building, Planning, Housing,
9	Police, Fire, and Health Codes, and the Medicinal and Adult Use Cannabis Regulation and Safety Act,
10	2017 Cal. Legis. Serv. Ch. 27 (S.B. 94), and its implementing regulations, as may be amended from
11	time to time.
12	(g) Notwithstanding anything in this Article 8A, a Medicinal Cannabis Retailer,

14	Consumption Permit ("Cannabis Smoking Permit Applicant") may allow Smoking on the
15	Premises until such time as its application for a Cannabis Consumption permit has been

17	(1) The Cannabis Smoking Permit Applicant previously held a permit to operate
18	a Medical Cannabis Dispensary at the same location, issued by the Director under Article 33
19	of the Health Code, or demonstrates to the Director's satisfaction that it had operated in
20	compliance with the Compassionate Use Act of 1996, and was forced to discontinue
21	operations as a result of federal prosecution or threat of federal prosecution;
22	(2) The Cannabis Smoking Permit Applicant was not prohibited by the Planning
23	Department, the Planning Commission, or the Director from allowing smoking on the premises
24	of the formerly permitted Medical Cannabis Dispensary; and

1	(3) The Cannabis Smoking Permit Applicant submits its application for a
2	Cannabis Smoking Consumption Permit not less than 30 days after such applications are
3	made available by the Director-; and
4	(4) The Cannabis Smoking Permit Applicant demonstrates that it provides
5	adequate ventilation within the structure such that doors and/or windows are not left open for
6	such purposes resulting in odor emission from the premises.
7	
8	SEC. 8A.5. PAYMENT OF ANNUAL LICENSE FEE.
9	The license fee for a Cannabis Consumption Permit shall be paid annually on or before March
10	31, in accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.
11	
12	SEC. 8A.6. OPERATING STANDARDS.
13	(a) No Permittee shall allow the on-site Consumption of Cannabis or Cannabis Products in a
14	manner inconsistent with any permit condition imposed by the Director, or inconsistent with any rules,
15	regulations, or guidelines promulgated by the Director under Section 8A.8.
16	(b) Any employee or agent of the Department of Public Health may enter and inspect the
17	Premises of a Permittee during business hours, without notice.
18	(c) No Permittee shall authorize the on-site Consumption of Cannabis or Cannabis Products
19	outside of the business' operating hours, as such hours may be established by law or regulation or
20	required as a condition of the permit.
21	(d) Permittees shall post one or more notices of sufficient size, lettering, and prominence to
22	advise customers that the Consumption of Cannabis Products on the sidewalk or in other areas
23	adjacent to the Premises is prohibited.
24

1	(e) Access to the area where the Consumption of Cannabis Products is allowed shall be
2	restricted to persons 21 years of age and older, or persons 18 years of age and older if the Permittee is
3	authorized to Sell Medicinal Cannabis Products.
4	(f) Cannabis Consumption shall not be visible from any public place or any nonage-restricted
5	area on the Premises.
6	(g) The sale and Consumption of alcohol or tobacco products are not allowed on the Premises.
7	(h) A Permittee shall comply with laws governing Cannabis Businesses and retail food
8	establishments, including but not limited to the California Retail Food Code and Article 8 of the Health
9	Code, where applicable.
10	(i) A Designated Smoking Room must meet the following ventilation standards:
11	(1) The Designated Smoking room must have a separate heating, ventilation,
12	and air-conditioning (HVAC) system such that none of the air in the Designated Smoking
13	Room will be recirculated into other parts of the Cannabis Business' Premises.
14	(2) The air from a Designated Smoking Room must be directly exhausted to the
15	outdoors by a filtration system that, at a minimum, eliminates all odor and smoke.
16	(3) Smoke from the Designated Smoking Room must not drift to other portions
17	of the Premises.
18	(4) The Designated Smoking Room must be completely separated from the
19	remainder of the Premises by solid partitions or glazing without openings other than doors,
20	and all doors leading to the Designated Smoking Room must be self-closing. All doors to the
21	Designated Smoking Room must be installed with a gasket to provide a seal where the door
22	meets the stop.
23	(5) The Designated Smoking Room must meet such other health and safety
24	standards as are adopted by the Director under Section 8A.8 of this Article 8.
25	

1	(j) A Permittee with a Cannabis Smoking permit may not require employees to enter
2	the Designated Smoking Room as a condition of their employment.
3	
4	SEC. 8A.7. ADMINISTRATIVE PENALTIES; PERMIT SUSPENSIONS AND
5	<b><u>REVOCATIONS;</u></b> <i>NOTICE OF VIOLATIONS; HEARING AND APPEAL.</i>
6	(a) Any Person who violates this Article 8A (which is deemed to include a violation of
7	the rules, regulations, and guidelines adopted pursuant to this Article 8A) shall be subject to
8	an administrative penalty imposed by order of the Director, not to exceed \$1,000 for each
9	violation, for each day such violation occurs.
10	(b) The Director may revoke or suspend a Cannabis Consumption permit if the Director
11	finds that the Permittee has engaged in conduct that violates this Article 8A or its
12	implementing rules, regulations, and guidelines, or if the Director finds that the Permittee is
13	being managed, conducted, or maintained in a way that threatens the health or safety of
14	Customers, employees, or the public at large.
15	(ac) If the Director determines that a Cannabis Business is operating in violation of this Article
16	8A or rules, regulations, or guidelines adopted pursuant to this Article, the Director shall issue a
17	Notice of Violation to the Permittee. The Notice of Violation shall include the following information:
18	the alleged act or failure to act that constitutes the basis for the Director's determination; that the
19	Director intends to take enforcement action against the Permittee, and the nature of that action,
20	specifically, the administrative penalty to be imposed, additional permit conditions to be imposed,
21	and/or suspension or revocation of the permit; and that the Permittee may request a hearing before the
22	Director within 15 days after the Notice of Violation is mailed, to challenge the Director's
23	determination and/or the proposed enforcement action.
24	(bd) If no request for a hearing is timely filed with the Director, the right to request a hearing
25	shall be deemed waived, and the Director's determination shall become final and effective 15 days

8	(eg) An order after hearing to suspend or revoke a permit, or to impose additional permit
9	conditions, may be appealed to the Board of Appeals in the manner prescribed in Article 1 of the
10	Business and Tax Regulations Code; and such an order shall inform the recipient of this right to
11	<u>appeal.</u>

13	SEC. 8A.8. RULES AND REGULATIONS.
14	(a) The Director shall adopt rules, regulations, and/or guidelines to establish the minimum
15	health and safety standards that businesses must maintain to be eligible to receive and maintain a
16	Cannabis Consumption permit. Such health and safety standards shall be sufficient in the Director's
17	judgment to, among other things: protect the health and safety of consumers and employees of the
18	cannabis business, prevent the ingestion of adulterated Cannabis Products, promote sanitary
19	conditions in the Consumption and Preparation areas, and prevent food-borne diseases that might
20	occur through unsafe food or Cannabis Product handling procedures.
21	(b) The Director may adopt rules, regulations, and guidelines that are not inconsistent with this

1	(18) Facilities used to conduct charity bingo games pursuant to <u>California</u> Penal
2	Code Section 326.5, during such times that persons are assembled in the facility in

8	The following places shall not be subject to this Article <u>19F</u> :

14	(2) A Cannabis Consumption Permit that authorizes the smoking of cannabis,
15	issued by the Director of Health under Article 8A of the Health Code, unless the smoking of
16	cannabis is authorized under subsection (g) of Section 8A.4, pending the approval or denial of
17	an application for such permit. permitted by the Office of Cannabis under Article 16 of the
18	Police Code that submit to the Director all documents required by the Director to demonstrate
19	that the Medicinal Cannabis Retailer or Cannabis Retailer: previously held a valid permit to
20	operate a Medical Cannabis Dispensary, issued by the Director under Article 33 of the Health
21	Code prior to September 26, 2017, at the same location; was not prohibited by the Planning
22	Department or the Planning Commission from allowing smoking on the premises of the
23	Medical Cannabis Dispensary; and meets such ventilation standards as may be established
24	by the Director to protect the health and safety of the Medicinal Cannabis Retailer's or
25	Cannabis Retailer's employees, neighbors, and customers.

1	(1) A Medicinal Cannabis Retailer or Cannabis Retailer that qualifies for an
2	exemption under this subsection (f) may allow the smoking of medicinal cannabis and adult
3	use cannabis in such indoor area(s) within its premises as may be approved by the Director,
4	but may not allow the smoking of tobacco products or adult use cannabis.
5	(2) A Medicinal Cannabis Retailer or Cannabis Retailer that seeks to allow the
6	smoking of medicinal cannabis or adult use cannabis on its premises pursuant to this
7	subsection (f) shall have three months from the date of receipt of its Cannabis Business
8	Permit to demonstrate compliance with the ventilation standards established by the Director.
9	(3) This exemption is nontransferable and immediately expires if any of the
10	following occur:
11	(A) There is a change in the ownership interest(s) in the Medicinal
12	Cannabis Retailer or Cannabis Retailer, meaning the aggregate change of 50% or more of the
13	ownership of the business;
14	(B) There are structural alterations made to the area where smoking is
15	approved that are not approved by the Director;
16	(C) The Medicinal Cannabis Retailer or Cannabis Retailer is no longer
17	located in the original permitted commercial building; or
18	(D) The Medicinal Cannabis Retailer or Cannabis Retailer found to have
19	permitted smoking of tobacco or nicotine products or adult use cannabis, or to have allowed
20	the smoking of medicinal cannabis or adult use cannabis in places or by persons not
21	authorized by the Director.
22	
23	Section 6. Article 33 of the Health Code is hereby amended by revising Sections 3301
24	and 3308, and adding new Sections 3322 and 3323, to read as follows:

"Medical cannabis dispensary" means a cooperative or collective of ten or more 4 (f) 5 qualified patients or primary caregivers that facilitates the lawful cultivation and distribution of 6 cannabis for medical purposes and operates not for profit, consistent with California Health & 7 Safety Code Sections 11362.5 et seq., with the Guidelines for the Security and Non-diversion 8 of Marijuana Grown for Medical Use issued by the California Attorney General in August 9 2008, and with this ordinance. A cooperative or collective shall be deemed to be of 10 or more qualified patients or primary caregivers if it distributes cannabis to more than 10 persons during any 10 consecutive 30-day period. A cooperative must be organized and registered as a Consumer 11 12 Cooperative Corporation under the Corporations Code, Sections 12300, et seq., or a 13 Nonprofit Cooperative Association under the Food and Agricultural Code, Sections 54002, et 14 seq. A collective may be organized as a corporation, partnership, or other legal entity under 15 state law but must be jointly owned and operated by its members. As set forth in Section 16 3308(q), a medical cannabis dispensary may purchase or obtain cannabis only from members 17 of the cooperative or collective and may sell or distribute cannabis only to members of the 18 cooperative or collective. As set forth in Section 3308(c), a medical cannabis dispensary may operate only on a not-for-profit basis and pay only reasonable compensation to itself and its 19 20 members and pay only reasonable out-of-pocket expenses.

1	(bb) A medical cannabis dispensary must be operated from a fixed place of business. It may
2	not be operated out of a bus, truck, car, van, or any other mobile location or location that is capable of
3	<u>being mobile.</u>

5	SEC. 3322. TRANSITION PROVISION.
6	(a) Terms not defined in this Section 3322 shall have the meaning attributed to them in
7	Section 1602 of the Police Code.
8	(ab) Notwithstanding any provision in this Article 33, starting January 1, 2018, a person may
9	not file and the Department of Public Health may not accept an application for a medical cannabis
10	dispensary permit.
11	( <b>b<u>c</u>)</b> Notwithstanding any provision in this Article 33, starting April 1, 2018, a medical
12	cannabis dispensary is not authorized by this Article 33 to engage in the cultivation of cannabis.
13	(d) Notwithstanding any provision in this Article 33, starting January 1, 2018, a medical
14	cannabis dispensary that meets the eligibility criteria set forth in subsection (e) of this Section
15	3322 may Sell Adult Use Cannabis and Cannabis Products for a period of 120 days, provided
16	the medical cannabis dispensary:
17	(1) Applies for and receives a State Cannabis License authorizing the retail
18	Sale of Adult Use Cannabis:
19	(2) Receives a determination from the Planning Department that the Sale of

5	(2) A medical cannabis dispensary that is awarded a permit under this Article 33

8	permit to the Department of Public Health prior to July 20, 2017; and
9	(B) Demonstrates to the satisfaction of the Director that it operated a

16	applications for Cannabis Business Permits under Article 16 of the Police Code.
17	(ceg) For purposes of Section 26050.1 of the California Business and Professions Code, a
18	valid medical cannabis dispensary permit shall serve as a valid license, permit, or other authorization
19	<u>to engage in the retail sale of medicinal cannabis, and medicinal cannabis products, adult use</u>
20	cannabis, and adult use cannabis products at the permitted location, but shall not serve as a valid
21	license, permit, or other authorization to engage in the retail sale of adult use cannabis or
22	cannabis products, or the commercial cultivation of cannabis of any kind.

24	SEC. 3323. SUNSET PROVISION.

1	This Article 33 shall expire by operation of law on December 31, 2018, at which time all
2	permits authorizing the operation of a Medical Cannabis Dispensary issued under this Article 33 shall
3	be rendered invalid. Upon expiration of the Article, the City Attorney shall cause it to be removed from

6	Section 7. The Business and Tax Regulations Code is hereby amended by revising

Existing Sections 1600-14 15 1618 of Article 23 of the Police Code shall be renumbered as new Sections 2300-2318, respectively, and any cross-references in the Municipal Code to existing Sections 1600-1618 16 17 shall be renumbered accordingly. These changes are not made for any substantive reason 18 and shall have no substantive effect. The City Attorney shall direct the publisher of the Municipal Code to take all appropriate steps to effectuate this provision. 19 20 21 Section 10. The Administrative Code is amended by adding new Section 10.100-162 to Chapter 10, Article XIII, to read as follows. 22 23 SEC. 10.100-162. Office of Cannabis Equity Operator Fund. 24 25

1	(a) Establishment of Fund. The Equity Operator Fund ("the Fund") is established as
2	a category six fund to receive any monies appropriated or donated for the purpose of assisting
3	Cannabis Businesses that are owned or managed by individuals who meet the criteria for
4	Equity Applicants set forth in Section 1604 of the Police Code, and Equity Applicants who
5	have been awarded a Cannabis Business Permit by the Office of Cannabis ("Equity
6	<u>Operators").</u>
7	(b) Use of Fund. The Fund shall be used exclusively by the Director of the Office of
8	Cannabis or his or her designee ("Director") to provide the following types of assistance to
9	Equity Applicants and Equity Operators:
10	(1) Providing access to technical assistance, mentoring, and business
11	consulting services:
12	(2) Financing capital improvements, construction, renovations, and leasehold
13	improvements; and
14	(3) Providing access to legal services relating to the operation of the Cannabis
15	Business.
16	(c) <b>Disbursement.</b> The Director shall authorize disbursements to eligible Equity
17	Applicants and Equity Operators on a case-by-case basis in accordance with the policy
18	adopted pursuant to subsection (d).
19	(d) Administration of Fund. By no later than April 1, 2018, the Director shall adopt a
20	policy for implementation of this Section 10.100-162, which the Director may modify from time
21	to time as the Director deems necessary or appropriate.
22	(e) Annual Report. The Director shall submit an annual written report to the Mayor,
23	the Board of Supervisors, and the Controller within the first two weeks of July, showing for the
24	prior fiscal year donations or appropriations received, the nature and amount of such
25	

1	donations or appropriations, and the disposition thereof, together with a description of the
2	individual payments made from the Fund.
3	
4	Section 101. Effective Date. This ordinance shall become effective 30 days after
5	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
6	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
7	of Supervisors overrides the Mayor's veto of the ordinance.
8	
9	Section 142. Scope of Ordinance. In enacting this ordinance, the Board of
10	Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections,
11	articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the
12	Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board
13	amendment additions, and Board amendment deletions in accordance with the "Note" that
14	appears under the official title of the ordinance.
