In 2014, the Board of Supervisors approved Ordinance 71-14, creating Planning Code Section 219.1 (later changed to 210.3C). This section allows new development for certain non-residential uses—such as office and institutional—in Production, Distribution, and Repair (PDR) Districts if those projects also include a significant amount of new PDR space. The legislation includes a "sunset" provision, whereas the program would expire on December 31, 2017 without Board action.

The legislation included a requirement (Planning Code Section 210.3C(f)(2)) that Planning Department staff submit a report to the Planning Commission and the Board of Supervisors. The purpose of the report is to provide relevant information about the program to support development of new PDR space and a recommendation on whether the Board should extend or modify the program, or whether it should be allowed to expire.

#### BACKGROUND

The Eastern Neighborhoods Area Plans (EN Plan), adopted in 2008, designated certain industrial areas within their boundaries as Production, Distribution, and Repair (PDR) districts. The creation of PDR Districts was motivated by the recognition that industrial activity is an important source of employment for San Francisco's working class as well as an important part of the city's economic diversity. PDR Districts limit or prohibit the development of uses—such as housing or office—that are able to pay much more for land than industrial activities, thereby protecting PDR businesses from being priced out of neighborhoods where they have grown and thrived.

Since the adoption of the EN Plan, PDR zones have successfully achieved their goal of protecting PDR activity. However, demand for PDR space in the city has outstripped supply, resulting in low vacancy and quickly increasing rents. Accommodating this demand is possible on underutilized or vacant parcels in PDR Districts. Unfortunately, given construction costs, the relatively low rent paid by PDR businesses, and lack of government subsidies, it is not economically viable to construct stand-alone PDR buildings – as witnessed by the fact that the City has not received applications for the development of new stand-alone PDR space in several decades.

#### LEGISLATION

To try to facilitate the creation of new PDR space, in 2014, the Board of Supervisors approved Ordinance 71-14 (sponsored by the Mayor and Supervisors Cohen, Campos, Chiu, Wiener, and Mar). This Ordinance created Planning Code Section 219.1 (later changed to 210.3C) to allow new development for certain non-residential uses—such as office and institutional—in PDR Districts if those projects also include a significant amount of new PDR space. Specifically, the legislation:

- Applies to large parcels (greater than 20,000 square feet) in PDR-1-D and PDR-1-G Districts north of 20<sup>th</sup> Street that do not contain significant PDR space or activities (existing floor-to-area ratio must be less than 0.3);
- Requires that the new developments dedicate at least 1/3 of its net new space to PDR activities;
- Requires that projects present a "PDR Business Plan" conveying how their project will be designed and priced to be suitable for PDR businesses; and

Requires Conditional Use authorization from the Planning Commission.

The legislation includes a "sunset" provision—that it would expire on December 31, 2017 unless the Board of Supervisors acts to continue, extend, or modify it by Ordinance. It also requires that, "Prior to the sunset date of this Section, the Planning Department shall submit a report to the Planning Commission and the Board of Supervisors that provides information the Planning Department determines to be relevant in determining whether to continue, expand or limit the allowances for new construction of PDR addressed in this Section" (Planning Code Section 210.3C(f)(2)). This memorandum fulfills the legislation's requirement that Planning staff complete a report outlining relevant information about the program's implementation.

#### ANALYSIS

The Office-PDR cross-subsidy program enabled by Planning Code Section 210.3C has been successful at achieving its policy objective—facilitating the development of new PDR space in underdeveloped parcels in PDR Districts. Since the program was launched in 2014, the Planning Department has received two applications for projects proposing to build a substantial amount of net new PDR space under the provisions of Planning Code Section 210.3C:

- 100 Hooper: Entitled by the Planning Commission in 2015, the project is under construction and expected to be completed in 2018. When completed, this development will provide more than 140,000 square feet of new PDR space, 56,000 of which will be leased at below market rates by a non-profit provider (PlaceMade), as well as 280,000 square feet of office development. The property had previously sat unimproved and contained no PDR use, and was used primarily for household storage in stackable shipping containers and for open-air truck rentals.
- 1 De Haro: Under review by Planning staff, this project proposes 47,000 square feet of PDR and 94,000 square feet of office space. The site presently includes 12,000 square feet of open storage sheds and warehouse facilities that were formerly occupied by the San Francisco Gravel Company. The existing facilities are not currently in operation. The project is likely to seek entitlement from the Planning Commission in 2018.

Aside from these two projects, the Planning Department has not received any other applications proposing to utilize Section 210.3C. The Planning Department has not received any complaints about misuse of this program.

#### RECOMMENDATION

Planning staff recommends the renewal of Planning Code Section 210.3C with some modest modifications that are likely to enable more new PDR space to be built while avoiding unintended consequences. First, we recommend that the parcel size threshold in the legislation be reduced from 20,000 square feet to 15,000. Second, the maximum existing FAR on the parcel should be increased slightly from 0.3 to 0.33. These modifications would be in keeping with the intent of the program, and would result in three new sites being eligible for the program.

Dear Members of the Board:

I understand that your offices have received many emails regarding Turo operations at San Francisco International Airport (SFO).

Between October 2013 and August 2017, RelayRides (now Turo) operated under an Off-Airport Rental Car Business Permit at SFO. In August, Turo canceled its permit on the representation that it was no longer operating at SFO but that is not the case. Its website currently offers some 200 vehicles to rent at SFO.

Turo has requested that the Airport categorize the company as something other than a rental car company; change the fee structure from a rental car structure (customer-paid AirTrain Fee plus 10% of gross on revenues over \$1 million) to a "trip fee" arrangement such as that required by vehicles providing commercial transportation; and allow Turo to use Airport property for customer pick-ups/drop-offs.

Granting Turo's requests would not only negatively impact the rental car companies currently operating under and complying with SFO's leases/permits, but would negatively impact SFO's already congested roadways and curb. It would also circumvent the \$19 Transportation Fee applied to all rental car contracts which pays for the debt service on the AirTrain system.

On October 30, 2017, Turo was provided 30 days to either (a) remove all reference to SFO from its website, online platforms, and promotional materials, and disallow the use of Airport property for vehicle transfers or (b) execute and comply with the terms of an off-airport rental car permit.

Turo markets itself as "Not your typical rental car... Bypass the rental counter and rent unforgettable cars from friendly locals" (https://turo.com)

Between October 2013 and August 2017, RelayRides (now Turo) operated under an Off-Airport Rental Car-Business Permit at San Francisco International Airport (SFO).

On October 26, 2016, Turo requested a change in its permit on the premise that it no longer be categorized as a rental car company. In a November 2, 2016 letter, the Office of the City Attorney, Airport Legal Division, denied Turo's by stating the factual bases for the permit category and reiterated that Turo is not acting as a "Personal Vehicle Sharing Program" as it claims since it earns revenue from renting cars.

SFO has limited roadway and curb space due to current construction activities and increased passenger loads. Roadway congestion presents a critical challenge to operating a safe and efficient airport and part of the solution is diverting all rental car customers to the Airport Rental Car Center where there are shuttles to off-Airport rental car companies. Turo refuses to transport its customers to and from the Airport's designated locations and is adding to the roadway and curbside congestion and undercutting permitted Airport rental car companies by offering a service (curbside terminal drop-off/pick-up) which its competitors cannot.

On October 30<sup>th</sup> Turo was provided 30 days to either (a) remove all reference to SFO from its website, online platforms, and promotional materials, and disallow the use of Airport property for vehicle transfers or (b) execute and comply with the terms of an off-airport rental car permit.

- In the six months prior to Turo's termination of its permit, Turo had on average 166 rental transactions per month at SFO, which generated approximately \$3,000 in revenue per month for SFO through payment of the AirTrain Fee (a customer-paid transaction fee). At the meeting, Turo expressed that the number of transactions at SFO is currently lower than this figure.
- Arriving passengers at SFO who have rented a car through Turo can pick up the vehicle in one of three ways: (1) the vehicle owner meets the passenger curbside for the exchange and the vehicle owner takes alternative transportation home; (2) the passenger takes transportation to the vehicle owner's home or other location where the exchange takes place; or (3) the passenger takes transportation to Turo's valet lot at 965 San Mateo Avenue in San Bruno where the vehicle/keys are waiting.
- Turo engages in the following activities to support its car rentals: provides liability insurance, roadside assistance, and a 24/7 customer service line; screens and verifies the identities of prospective renters who fill out profiles on Turo's website; sets minimum rental durations; sets car prices with owner consent based on an algorithm designed to maximize profits; enforces a series of policies governing all rentals, including a gas policy, cancellation policy, extension and late return policy, and late fees; processes all bookings and payments through its website; and retains a portion of the rental fees as profit.

Title and Summary The City Attorney has prepared the following title and summary of the chief purpose and points of the proposed measure:

TERM LIMITS FOR THE MAYOR AND MEMBERS OF THE BOARD OF SUPERVISORS

The City's Charter limits the terms that persons serving as the Mayor and members of the Board of Supervisors ("Board") may be in office.

A full term as mayor is four years. A person may not serve as mayor for more than two consecutive terms. The Charter does not limit the non-consecutive terms that a non-consecutive terms that a person may serve as mayor.

A full term on the Board is four years. Board members may not serve more than two consecutive four-year terms. A Board member who serves two consecutive four-year terms may not serve on the Board again unless at least four years have passed since the end of the second term.

The proposed Charter amendment would prohibit any person from ever serving as mayor for more than two four-year terms. The proposed Charter amend-ment would apply to current and former mayors.

The proposed Charter amendment would also prohibit any person from ever serving on the Board for more than two four-year terms. This prohibition would apply to current and former Board members, with two exceptions.

The first exception is for any current Board member who: (1) served two consecutive terms on the Board; and (2) was re-elected to the Board before the adoption of this proposed Charter amend-ment. A current Board member who meets these conditions could serve the remainder of the four-year term and, if re-elected, serve an additional consecutive four-year term.

The second exception is for any person who: (1) served two consecutive terms on the Board more than four years ago; and (2) is elected to an additional term on the Board at the same election that this proposed Charter Amend-ment is on the ballot.
