

1 [Agreement Amendment - Transbay Joint Powers Authority - Municipal Transportation Agency  
2 - Transbay Transit Center Program Services - No Additional Cost]

3 **Resolution approving the Third Amendment to Contract No. CS-159 between the**  
4 **Municipal Transportation Agency and the Transbay Joint Powers Authority for**  
5 **Transbay Transit Center Program Services pursuant to Charter, Section 9.118, for the**  
6 **period of July 21, 2009, through June 30, 2018, at no additional cost.**

8 WHEREAS, The Municipal Transportation Agency (SFMTA) is a governmental entity  
9 which is comprised of the San Francisco Municipal Railway (Muni) and former Department of  
10 Parking and Traffic (DPT); and

11 WHEREAS, On July 21, 2009, the SFMTA and the Transbay Joint Powers Authority  
12 (TJPA) entered into Contract No. CS-159, SFMTA Transbay Transit Center Program  
13 Services, under which the TJPA agreed to reimburse the SFMTA for engineering services  
14 related to re-routing of Muni's trolley coach service to accommodate the new TJPA temporary  
15 bus terminal; and

16 WHEREAS, On August 9, 2010, the SFMTA and the TJPA entered into a First  
17 Amendment to the Contract No. CS-159, for additional SFMTA services, including SFMTA  
18 Parking Control Officer services, for the operation of the Temporary Transbay Terminal during  
19 key commute hours, increased the agreement amount by \$997,698, for a total not to exceed  
20 amount of \$3,280,677, and extended the agreement term through December 15, 2015; and

21 WHEREAS, On May 17, 2013, the SFMTA Board of Directors and the TJPA entered  
22 into a Second Amendment to provide additional services associated with the bus storage  
23 facility and Transbay Transit Center, as well as the Beale Street temporary traffic bridge, Muni  
24 traction power duct bank, and bus ramp, increase the agreement amount by \$2,113,000,  
25 resulting in a not-to-exceed agreement amount of \$5,393,677, and extend the term of the

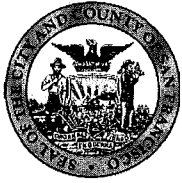
1 Agreement through December 31, 2017; and

2 WHEREAS, The Third Amendment to the Contract No. CS-159 adds additional  
3 services related to the installation of ticket vending machines in the new Transbay Transit  
4 Center, reallocates task budgets, and extends the term of the Agreement from December 31,  
5 2017, through June 30, 2018, at no additional cost, and

6 WHEREAS, On October 17, 2017, the SFMTA Board of Directors adopted Resolution  
7 No. 171017-129, to authorize the SFMTA Director of Transportation to execute the Third  
8 Amendment to the Contract No. CS-159; now, therefore, be it

9 RESOLVED, That the San Francisco Board of Supervisors approves the Third  
10 Amendment to Contract No. CS-159, SFMTA Transbay Transit Center Program Services,  
11 pursuant to Charter, Section 9.118 and authorizes the Director of Transportation of the  
12 SFMTA, on behalf of the City, to execute the Third Amendment; and, be it

13 FURTHER RESOLVED, That within 30 days of the Third Amendment to the Contract  
14 No. CS-159 documents being fully executed by all parties, the final documents shall be  
15 provided to the Clerk of the Board for inclusion in the official file.




