

The Human Services Agency (HSA) of the City and County of San Francisco announces its intent to seek proposals from organizations of individuals interested in providing housing subsidies to seniors and adults with disabilities in order to assist them in stabilizing current housing, leveraging additional resources and/or accessing more affordable housing.

Seniors and adults with disabilities face an ongoing struggle to maintain stable housing in San Francisco due to increasing rents and a limited supply of safe, affordable housing. These services are intended to prevent homelessness through identifying seniors and adults with disabilities in unstable housing situations and assisting them in stabilizing that housing through the use of subsidies and other resources or services.

The total available funding for these services is estimated to be \$750,000 annually. The source of funding for these services is local funds. Payment for all services provided in accordance with provisions under this grant shall be contingent upon the availability of funds. The City shall not be required to provide any definite units of services nor does the City guarantee any minimum amount of funding for these services.
