[Settlement of Lawsuit - Lai King Tam - \$142,500]

Ordinance authorizing settlement of the lawsuit filed by Lai King Tam against the City and County of San Francisco for \$142,500; the lawsuit was filed on June 13, 2016, in San Francisco Superior Court, Case No. CGC-16-552527; entitled <u>Lai King Tam v. City and County of San Francisco</u>; the lawsuit involves personal injury allegedly caused by the dangerous condition of a City sidewalk.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Lai King Tam v. City and County of San Francisco</u>, San Francisco Superior Court, Case No. CGC-16-552527 by the payment of \$142,500. The lawsuit involves personal injury allegedly caused by the dangerous condition of a City sidewalk.

Section 2. The above-named action was filed in San Francisco Superior Court on June 13, 2016, and the following parties were named in the lawsuit: Lai King Tam, plaintiff, City and County of San Francisco; California Department of Transportation (CALTRANS), a department of the State of California, and DOES 1-40, inclusive, defendants.
