

Resolution determining that the premise-to-premise transfer of a Type-42 on-sale beer and wine public premises liquor license to City Beer Store, LLC, located at 1148-1150 Mission Street (District 6), will serve the public convenience or necessity of the City and County of San Francisco, in accordance with California Business and Professions Code, Section 23958.4; and recommending that the California Department of Alcoholic Beverage Control impose conditions on the issuance of the license.

WHEREAS, City Beer Store, LLC, doing business as City Beer Store located at 1148-1150 Mission Street (District 6), is seeking the premise-to-premise transfer of a Type-42 on-sale beer and wine public premises liquor license; and

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

WHEREAS, The Police Department has filed zero (0) protests and zero (0) letters of support with the Department of Alcoholic Beverage Control under California Business and Professions Code, Section 24013, and recommends that the Department of Alcoholic Beverage Control issue the liquor license with conditions; and

WHEREAS, The conditions recommended by the Police Department are the following: 1) sales, service, and consumption of alcoholic beverages shall be permitted between the hours of 10:00 a.m. and 12:00 a.m. Sundays through Wednesdays, and 10:00 a.m. through 2:00 a.m. Thursdays through Saturdays; 2) no noise shall be audible at any nearby residences; 3) petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to

the licensed premises as depicted on ABC-253; 4) sales, service, and consumption of alcoholic beverages shall be permitted in or on the patio area only between the hours of 10:00 a.m. and 10:00 p.m. each day of the week; 5) sales and service of alcoholic beverages on said patio area shall be restricted to waiter/waitress service and only to patrons seated at a table; and 6) when the said outdoor patio area of the premises is being utilized for the sales, service, and consumption of alcoholic beverages, a premise employee shall be in attendance and maintain continuous supervision at all times of said area; now, therefore, be it

RESOLVED, That in accordance with California Business and Professions Code, Section 23958.4, the Board of Supervisors of the City and County of San Francisco hereby determines that the premise-to-premise transfer of a Type-42 on-sale beer and wine public premises liquor license to City Beer Store, LLC, located at 1148-1150 Mission Street (District 6), will serve the public convenience or necessity of the City and County of San Francisco; and, be it

FURTHER RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby endorses and adopts the recommendations of the Police Department listed above and recommends that the Department of Alcoholic Beverage Control issue the license with those conditions.

To Whom It May Concern:

As you know, City Beer Store, LLC ("City Beer Store") currently operates a beer tasting room and retail shop located at 1168 Folsom St., Unit 101, San Francisco, CA (the "Folsom Street Location"), and is seeking to transfer its Type 42 ABC license from the Folsom Street Location to a location just two blocks away at 1148-1150 Mission Street (the "Mission Street Location"). Per your request, we are sending you this Letter of Intent to describe City Beer Store's current operations as well as its plans for operations at the new Mission Street Location.

When it was established in 2006, the vision for City Beer Store was to create a friendly community gathering spot similar to a wine bar that allows patrons to sip and purchase high-end craft beer made by artisan brewers from Northern California and throughout the world.

Off-premises sales are an integral part of City Beer Store's business model, representing between 50% - 60% of total revenues. Below are just a few of the hundreds of brands that are offered:

- Brouwerij St. Bernardus

- The Rare Barrel

City Beer Store has successfully operated its business for approximately 11 years now and has developed a loyal following for patrons of the growing craft beer movement. During this time, City Beer Store has never had any complaints filed against it with the California ABC or the San Francisco Police Department. Furthermore, City Beer Store has received a number of awards and accolades from both local and national publications, such as:

The coolers bear over 400 brews arranged by style, from sours and Belgian darks to single, double, and triple IPAs. Customers can mix cans and bottles to create their ideal six-pack. Over the years, owners Craig and Beth Wathen have developed a relationship with many California breweries, resulting in collaboration bottles with Sante Adairius Rustic Ales, the Bruery, and Cellarmaker Brewing. The spot is known for its sours and IPAs, which the store strives to receive directly from bottling for peak freshness. In addition to the bottle shop, there are 15 rotating beers on tap at the adjacent bar. Added incentive to drink instore: The store's so-called magic cooler is stocked with rare, aged, and limited edition collaboration beers, offered on the premises only.

The Mission Street Location is a commercial space located at the base of the SOMA Grand residential tower. It was last occupied by a restaurant owned and operated by Charles Phan (owner of Slanted Door), but it has remained vacant for over two years and suffers from litter and crime as a result. When it was first proposed to move City Beer Store to the Mission Street Location, we had to seek approval for an amendment to the CC&R's from the Board of Directors of the SOMA Grand Center Association, representative of the residents (the "SOMA Board"), in order to facilitate the move. The SOMA Board enthusiastically (and unanimously) endorsed the amendment.

With respect to operations, similar to the model at the current Folsom Street Location, the Mission Street Location will have a bar counter located on the west side of the shop where it will serve beer for on-premises consumption from 30+ different taps. It will also have refrigerated cases and multiple stock shelves for high-end craft beer that can be purchased for off-premises sales. As noted above, this is a critical and distinguishing component of City Beer Store's business model. In addition, with this new location, City Beer Store will now have a dining area and will be able to provide full meals to patrons. We are attaching several pictures of our current store location to provide an idea of what we offer and the positive effect we currently have (and expect to have when we move to the Mission Street Location) on the neighborhood.







Dear Mr. Carroll:

City Beer Store, LLC ("City Beer Store") currently operates a beer tasting room and retail shop located at 1168 Folsom St, Unit 101, San Francisco, CA and holds an ABC Type 42 License at that location. When it was established in 2006, our vision was to create a friendly community gathering spot to sip craft beer in a laid back environment. Since opening, City Beer Store has become a neighborhood fixture as the go-to place for interesting craft beers from around the world.

City Beer Store has an opportunity to move their successful business to a new location just two short blocks away, at the SOMA Grand building located at 1148-1150 Mission Street, San Francisco, CA 94103 (the "SOMA Grand"). We have submitted a Premise to Premise Transfer application to the Alcohol Beverage Control to move the current Type 42 license to the new location, a copy of which is attached.

As part of the licensing process, it is our understanding that this move to the SOMA Grand requires us to apply for a public convenience and necessity resolution (the "PCN Resolution") from the San Francisco Board of Supervisors per Cal. Bus. & Prof. Code §23958.4. We understand that these requests are handled by the Public Safety Neighborhood Services Committee (the "Committee").

It is our intention to provide any information or documentation needed by the Committee to secure the PCN Resolution in connection with our proposed move. To that end, please consider the following;

- City Beer Store was established in 2006 and is privately owned and operated by my wife, Beth Wathen, and I. We have been residents of San Francisco since 2000.
- City Beer Store has no records of liquor law violations at its current location and intends to continue conducting its business in such a manner.
- The ABC's public comment period expired on October 1st and it has not received any negative responses to date.

- We spoke with Edgar Oropeza with the San Francisco Planning Department and received his confirmation that the location is zoned properly for the business. Attached please find a copy of our email correspondence with Mr. Oropeza confirming the same.
- We have contacted Lieutenant Nelly Gordon with the San Francisco Police Department and are currently working with her to obtain clearance from SFPD.
- The business that previously occupied the space at the SOMA Grand held a California ABC license that permitted sales of liquor in addition to wine and beer, but our understanding is that they will be cancelling their license. Therefore, our move will not result in an addition to the total number of ABC licenses in the neighborhood; rather it will actually result in a net *decrease* in the total number of ABC licenses as well as the number of licenses permitting the sale of liquor.
- In connection with this proposed move, we have been in contact with Judith P. Roddy, a representative of CitiScape Property Management Group, LLC (the building manager for the SOMA Grand; <u>iroddy@citiscapesf.com</u>, (415) 863-4894) and Jane Weil, president of the homeowners association for the SOMA Grand (jane@janeweil.com). They have both confirmed their support.
- In addition, the Board of Directors of the SOMA Grand Center Association approved an amendment to the building's covenants, conditions and restrictions for the purpose of facilitating City Beer Store's move to the SOMA Grand. We believe that this is indicative of the local support for City Beer Store and its business.
- City Beer Store has been nationally recognized for its contributions to the vibrant California beer scene. We are big supporters of local beer producers and are committed to operating a successful small business in San Francisco for the long term by providing employment opportunities and contributing to the local community as fun, social location. In sum, we believe City Beer Store serves the public convenience and necessity both in the neighborhood and citywide.

Based on the foregoing, we respectfully request that the San Francisco Board of Supervisors provide the PCN Resolution required for City Beer Store's move to the SOMA Grand. We are confident that this move will allow City Beer Store to continue to function as important fixture for the neighborhood and the city of San Francisco.



Dear Mr. Carroll:

City Beer Store, LLC ("City Beer Store") currently operates a beer tasting room and retail shop located at 1168 Folsom St, Unit 101, San Francisco, CA and holds an ABC Type 42 License at that location. When it was established in 2006, our vision was to create a friendly community gathering spot to sip craft beer in a laid back environment. Since opening, City Beer Store has become a neighborhood fixture as the go-to place for interesting craft beers from around the world.

City Beer Store has an opportunity to move their successful business to a new location just two short blocks away, at the SOMA Grand building located at 1148-1150 Mission Street, San Francisco, CA 94103 (the "SOMA Grand"). We have submitted a Premise to Premise Transfer application to the Alcohol Beverage Control to move the current Type 42 license to the new location, a copy of which is attached.

As part of the licensing process, it is our understanding that this move to the SOMA Grand requires us to apply for a public convenience and necessity resolution (the "PCN Resolution") from the San Francisco Board of Supervisors per Cal. Bus. & Prof. Code §23958.4. We understand that these requests are handled by the Public Safety Neighborhood Services Committee (the "Committee").

It is our intention to provide any information or documentation needed by the Committee to secure the PCN Resolution in connection with our proposed move. To that end, please consider the following;

- City Beer Store was established in 2006 and is privately owned and operated by my wife, Beth Wathen, and I. We have been residents of San Francisco since 2000.
- City Beer Store has no records of liquor law violations at its current location and intends to continue conducting its business in such a manner.
- The ABC's public comment period expired on October 1st and it has not received any negative responses to date.

- We spoke with Edgar Oropeza with the San Francisco Planning Department and received his confirmation that the location is zoned properly for the business. Attached please find a copy of our email correspondence with Mr. Oropeza confirming the same.
- We have contacted Lieutenant Nelly Gordon with the San Francisco Police Department and are currently working with her to obtain clearance from SFPD.
- The business that previously occupied the space at the SOMA Grand held a California ABC license that permitted sales of liquor in addition to wine and beer, but our understanding is that they will be cancelling their license. Therefore, our move will not result in an addition to the total number of ABC licenses in the neighborhood; rather it will actually result in a net *decrease* in the total number of ABC licenses as well as the number of licenses permitting the sale of liquor.
- In connection with this proposed move, we have been in contact with Judith P. Roddy, a representative of CitiScape Property Management Group, LLC (the building manager for the SOMA Grand; <u>jroddy@citiscapesf.com</u>, (415) 863-4894) and Jane Weil, president of the homeowners association for the SOMA Grand (jane@janeweil.com). They have both confirmed their support.
- In addition, the Board of Directors of the SOMA Grand Center Association approved an amendment to the building's covenants, conditions and restrictions for the purpose of facilitating City Beer Store's move to the SOMA Grand. We believe that this is indicative of the local support for City Beer Store and its business.
- City Beer Store has been nationally recognized for its contributions to the vibrant California beer scene. We are big supporters of local beer producers and are committed to operating a successful small business in San Francisco for the long term by providing employment opportunities and contributing to the local community as fun, social location. In sum, we believe City Beer Store serves the public convenience and necessity both in the neighborhood and citywide.

Based on the foregoing, we respectfully request that the San Francisco Board of Supervisors provide the PCN Resolution required for City Beer Store's move to the SOMA Grand. We are confident that this move will allow City Beer Store to continue to function as important fixture for the neighborhood and the city of San Francisco.
