Ordinance authorizing settlement of the lawsuit filed by Greg Blatman against the City and County of San Francisco for \$225,000; the lawsuit was filed on August 19, 2014, in San Francisco Superior Court, Case No. CGC 14-541248; entitled <u>Greg Blatman v. City and County of San Francisco, et al.</u>; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Greg Blatman v. City and County of San Francisco, et al.</u>, San Francisco Superior Court, Case No. CGC 14-541248 by the payment of \$225,000. The lawsuit involves an employment dispute.

Section 2. The above-named action was filed in San Francisco Superior Court on August 19, 2014, and the following parties were named in the lawsuit: Plaintiff Greg Blatman; Defendants City and County of San Francisco, and Lorrie Kalos.
