## ORDINANCE NO.

[Settlement of Lawsuit - Patricia Burley - \$100,000]

Ordinance authorizing settlement of the lawsuit filed by Patricia Burley against the City and County of San Francisco for \$100,000; the lawsuit was filed on October 18, 2016, in San Francisco Superior Court, Case No. CGC-16-554887, and removed on November 22, 2016, to United States District Court, Case No. 16-cv-06762 JCS; entitled <u>Patricia</u> <u>Burley vs. City and County of San Francisco, et al.</u>; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1.
