Ordinance authorizing settlement of the lawsuit filed by Mikaela Anna Merchant against the City and County of San Francisco for \$50,000; the lawsuit was filed on November 29, 2016, in San Francisco Superior Court, Case No. CGC-16-555561; entitled Mikaela Anna Merchant v. City and County of San Francisco, et al.; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Mikaela Anna Merchant v. City and County of San Francisco, San Francisco Superior Court, Case No. CGC-16-555561 by the payment of \$50,000. The lawsuit involves an employment dispute.

Section 2. The above-named action was filed in San Francisco Superior Court on November 29, 2016, and the following parties were named in the lawsuit: Plaintiff Mikaela Anna Merchant; and Defendants the City and County of San Francisco, Barbara Garcia and Ricardo Duarte.
