Be it ordained by the People of the City and County of San Francisco:

[Settlement of Lawsuit - David Zeller (Deceased) - \$290,000]

Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>David Zeller v. San Francisco General Hospital</u>, et al., San Francisco Superior, Case No. CGC-13-529554 by the payment of \$290,000 and UC Regents to pay \$200,245 and upon approval by the probate court and Plaintiff's acceptance of the probate court's allocation of funds, California Department of Health Care Services to disgorge \$65,300 paid for MediCal lien to be paid to plaintiff. The lawsuit involves alleged medical malpractice.

Section 2. The above-named action was filed in San Francisco Superior Court on March 14, 2013, and the following parties were named in the lawsuit: Plaintiffs: David Zeller, Michael T. McCowan, as Personal Representative of the Estate of David Zeller, Deceased; Defendants: City and County of San Francisco and Regents of the University of California.
