4 **Motion calling from the Budget and Finance Committee, pursuant to Board Rule 3.37,**
5 **the proposed Ordinance (File No. 180001) - the Anti-Corruption and Accountability**
6 **Ordinance - amending the Campaign and Governmental Conduct Code to institute**
7 **various campaign finance and conflict of interest reforms; and scheduling the Board of**
8 **Supervisors to sit as a Committee of the Whole on April 3, 2018, at 3:00 p.m., in a joint**
9 **meeting with the San Francisco Ethics Commission, to hold a public hearing to**
10 **consider the proposed Ordinance (File No. 180001).**

12 MOVED, That the Board of Supervisors does hereby order the proposed Ordinance
13 (File No. 180001) be called from the Budget and Finance Committee, pursuant to Board Rule
14 3.37, and returned to the Board of Supervisors for consideration during a Committee of the
15 Whole joint meeting on April 3, 2018, at 3:00 p.m., with the Ethics Commission; and, be it

16 FURTHER MOVED, That the Board of Supervisors shall convene to sit as a Committee
17 of the Whole on April 3, 2018, at 3:00 p.m., in a joint meeting with the San Francisco Ethics
18 Commission, to hold a public hearing to consider the proposed Ordinance (File No. 180001) –
19 the Anti-Corruption and Accountability Ordinance – amending the Campaign and
20 Governmental Conduct Code to 1) prohibit earmarking of contributions and false identification
21 of contributors; 2) modify contributor card requirements; 3) require disclosure of contributions
22 solicited by City elective officers for ballot measure and independent expenditure committees;
23 4) require additional disclosures for campaign contributions from business entities to political
24 committees; 5) require disclosure of bundled campaign contributions; 6) extend the prohibition
25 on campaign contributions to candidates for City elective offices and City elective officers who

1 must approve certain City contracts; 7) require committees to file a third pre-election
2 statement prior to an election; 8) remove the prohibition against distribution of campaign
3 advertisements containing false endorsements; 9) allow members of the public to receive a
4 portion of penalties collected in certain enforcement actions; 10) permit the Ethics
5 Commission to recommend contract debarment as a penalty for campaign finance violations;
6 11) create new conflict of interest and political activity rules for elected officials and members
7 of boards and commissions; 12) specify recusal procedures for members of boards and
8 commissions; 13) establish local behested payment reporting requirements for donors and
9 City officers; 14) require disclosure by major donors of their financial interests; and 15) modify
10 disclaimer requirements in audio and video campaign advertisements.
