3 **Ordinance authorizing settlement of the lawsuit filed by Nicholas Kafkas against the**
4 **City and County of San Francisco for \$45,000; the lawsuit was filed on**
5 **February 3, 2016, in San Francisco Superior Court, Case No. CGC-16-550258; entitled**
6 **Nicholas Kafkas v. City and County of San Francisco, et al.; the lawsuit involves**
7 **alleged personal injury from vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Nicholas Kafkas v. City and County of
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-16-550258 by the
13 payment of \$45,000. The lawsuit involves alleged personal injury from vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 February 3, 2016, and the following parties were named in the lawsuit: plaintiff: Nicholas
16 Kafkas; defendants: City and County of San Francisco, Shawn Conner Imhoff.


