[Settlement of Lawsuit - Mark Johnson, Franco S. Calzolai, Michael Bryant - \$175,000]

Ordinance authorizing settlement of the lawsuit filed by Mark Johnson, Franco S. Calzolai, and Michael Bryant against the City and County of San Francisco for \$175,000; the lawsuit was filed on November 20, 2009, in the United States District Court for the Northern District of California, Case No. CV 09-5503 JSW; entitled <u>Mark</u> Johnson, et al. v. City and County of San Francisco, et al.; the lawsuit involves an employment dispute.
