[Settlement of Lawsuit - Lynette White - \$300,000]

Ordinance authorizing settlement of the lawsuit filed by Lynette White against the City and County of San Francisco for \$300,000; the lawsuit was filed on January 29, 2016, in San Francisco Superior Court, Case No. CGC-16-550136; entitled <u>Lynette White v.</u> <u>Blake Cunningham et al.</u>; the lawsuit involves alleged injury from a collision with a Police Department vehicle; other material terms of the settlement include a waiver of the Zuckerberg San Francisco General Hospital lien.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Lynette White v. Blake Cunningham et al.</u>, San Francisco Superior Court, Case No. CGC-16-550136 by the payment of \$300,000 and a waiver of the Zuckerberg San Francisco General Hospital lien. The lawsuit involves personal injury from a collision with a San Francisco Police Department vehicle.

Section 2. The above-named action was filed in San Francisco Superior Court on January 29, 2016, and the following parties were named in the lawsuit: Plaintiff: Lynette White; Defendants: Blake Cunningham and the City and County of San Francisco.
