9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Janet Silk v. Robert J. Franko, City
12 and County of San Francisco, et al., San Francisco Superior Court, Case
13 No. CGC-16-554864 by the payment of \$135,000. The lawsuit involves alleged personal
14 injury from a vehicle collision.
