Ordinance authorizing settlement of the lawsuit filed by Mark Johnson, Franco S. Calzolai, and Michael Bryant against the City and County of San Francisco for \$175,000; the lawsuit was filed on November 20, 2009, in the United States District Court for the Northern District of California, Case No. CV 09-5503 JSW; entitled <u>Mark</u> <u>Johnson, et al. v. City and County of San Francisco, et al.</u>; the lawsuit involves an employment dispute.

Be it ordained by the People of the City and County of San Francisco: Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Mark Johnson, et al. v.
