Ordinance authorizing settlement of the lawsuit filed by William Watkins against the City and County of San Francisco for \$30,000; the lawsuit was filed on June 27, 2016, in San Francisco Superior Court, Case No. CGC-16-552748; entitled William Watkins v. Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled William Watkins v. City and County of San Francisco, San Francisco Superior Court, Case No. CGC-16-552748 by the payment of \$30,000. The lawsuit involves an employment dispute.

Section 2. The above-named action was filed in San Francisco Superior Court on June 27, 2016, and the following parties were named in the lawsuit: William Watkins, City & County of San Francisco.


