5 **Alex Petrolino against the City and County of San Francisco for \$100,000; the lawsuit**
6 **was filed on June 2, 2016, in United States District Court, Northern District, Case**
7 **No. 16-cv-02946 RS; entitled Fabio Petrolino, et al. v. City and County of San Francisco,**
8 **et al.; the lawsuit involves alleged wrongful death; other material terms of the**
9 **settlement are co-defendants to pay an additional total of \$500,000.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled Fabio Petrolino, et al. v. City and
14 County of San Francisco, et al., United States District Court, Northern District, Case
15 No. 16-cv-02946 RS by the payment of \$100,000 and co-defendants to pay an
16 additional \$500,000. The lawsuit involves alleged wrongful death.

17 Section 2. The above-named action was filed in United States District Court on
18 June 2, 2016, and the following parties were named in the lawsuit: Plaintiffs: Fabio Petrolino;
19 M. P., a minor, through her guardian ad litem, Ana Petrolino; Andrelina Silva; Angela Petrolino
20 and Alex Petrolino. Defendants: City and County of San Francisco; Eve Zeff; Kevin O’Shea;
21 Andrew Martinez; Michael Mohn; Rudy Zamora; HealthRight 360; Lauren Erickson; Nick




