9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Elizabeth A. Loomis v. City and
12 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-16-550880 by
13 the payment of \$275,000. The lawsuit involves alleged personal injury due to a trip and fall.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 March 9, 2016, and the following parties were named in the lawsuit: plaintiff: Elizabeth
16 Loomis; defendant: City and County of San Francisco.






