9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Lanett Bush v. City and County of San
12 Francisco, San Francisco Superior Court, Case No. CGC-15-549620 by the payment
13 of \$600,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 December 28, 2015, and the following parties were named in the lawsuit: Plaintiff: Lanett
16 Bush; Defendant: City and County of San Francisco.




