Resolution approving a transfer up to \$4,000,000 to the General Fund for overpayments and duplicate payments received by the City for parking and transit violations issued between January 1, 1994, and June 30, 2016.

WHEREAS, In November 2017, the San Francisco Municipal Transit Agency (SFMTA) identified and publicly noticed approximately \$600,000 in unclaimed funds for overpayments and duplicate payments received by the City for parking and transit violations issued between January 1, 1994, to June 30, 2014, that are currently held in SFMTA's Municipal Transportation Fund, to the General Fund for the City and County of San Francisco; and

WHEREAS, Accounts less than \$15 or with no corresponding name are eligible for escheatment within one year and are not required to be posted; and

WHEREAS, SFMTA identified approximately \$13,000 in overpayments less than \$15 and without a corresponding name through June 30, 2016; and

WHEREAS, Approximately \$3,400,000 in unclaimed funds has been carried forward from 2016 due to a higher than expected amount for overpayment accounts than was originally approved by the Board of Supervisors for transfer to the City's General Fund; and

WHEREAS, California Government Code, Sections 50050, et seq. authorize the San Francisco Board of Supervisors to transfer unclaimed funds, that have remained unclaimed for three or more years, to the City's General Fund after required notice is posted, indicating that the money will become the property of the City on a designated date not less than 45 days nor more than 60 days after the first publication of the notice; and

WHEREAS, Unclaimed funds in accounts with no corresponding customer name or in an amount less than \$15 can be transferred after one year by the San Francisco Board of Supervisors to the City's General Fund; and

WHEREAS, SFMTA, under the authority delegated by the City Treasurer as provided by state law, posted the required notice on November 16, 2017, and November 23, 2017, in the City's official newspaper to provide an opportunity for the public to claim a refund of any identified overpayment or duplicate payment made between January 1, 1994, to June 30, 2014, and notice to the public that any remaining unclaimed money would become the City's property on December 14, 2017; and

WHEREAS, Additional announcements were made in various social media and news outlets; and

WHEREAS, Claim forms to request a refund were made available on the SFMTA website or by phone; and

WHEREAS, The deadline to file a claim to request a refund expired on December 14, 2017; and

WHEREAS, On January 17, 2018, SFMTA, under authority delegated by the Planning Department, determined that the transfer of an amount of unclaimed overpayments from parking and transit violations to the General Fund of the City and County of San Francisco is not defined as a "project" under the California Environmental Quality Act pursuant to Title 14 of the California Code of Regulations, Sections 15060(c) and 15378(b).

WHEREAS, The San Francisco Municipal Transportation Agency Board of Directors approved Resolution No. 180403-050 on April 3, 2018, requesting Board of Supervisors approval to transfer these funds, on file with the Clerk of the Board of Supervisors in File No. 180458, which is hereby declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

RESOLVED, That the Board of Supervisors approves the transfer of up to \$4,000,000 in unclaimed funds for overpayments and duplicate payments received by the City for parking and transit violations issued between January 1, 1994, and June 30, 2016, that are currently held in the SFMTA's Municipal Transportation Fund to the General Fund for the City and County of San Francisco.
