[Public Works Code - Waiver of Temporary Street Space Occupancy Permit Fee for Small Business Week Sidewalk Sales]

Ordinance waiving the fee required by Public Works Code, Section 724.1(b), for temporary street space occupancy permits on certain designated City streets on Saturday, May 19, 2018, to promote Small Business Week.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Section 2. All other provisions of Public Works Code Sections 724 et seq. shall remain in full effect.

Section 3. Effective and Operative Dates; Retroactivity.

(a) This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

(b) If this ordinance becomes effective after May 19, 2018, this ordinance shall be retroactive to that date.
