

[Settlement of Lawsuit - Juan Perez and Margarita Lopez Perez - \$275,000]

Ordinance authorizing settlement of the lawsuit filed by Juan Perez and Margarita Lopez Perez against the City and County of San Francisco for \$275,000; the lawsuit was filed on April 24, 2015, in United States District Court, Case No. 15-cv-1846; entitled <u>Estate Of Amilcar Perez Lopez, by and through successors in interest, et al. v. Chief of</u> <u>Police Greg Suhr, et al.</u>; the lawsuit involves a fatal officer involved shooting on February 26, 2015; Plaintiffs are Juan Perez and Margarita Lopez Perez and estate of Amilcar Perez-Lopez; the settlement involves an alleged civil rights violation.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter, Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Estate Of Amilcar Perez Lopez, et al. <u>v. Chief of Police Greg Suhr, et al.</u>, United States District Court, Case No. 15-cv-1846 by the payment of \$275,000. The lawsuit involves a fatal officer involved shooting on February 26, 2015.
