

[Settlement of Lawsuit - Angel Nguyen - \$1,350,000]

Ordinance authorizing settlement of the lawsuit filed by Angel Nguyen against the City and County of San Francisco for \$1,350,000; the lawsuit was filed on December 22, 2015, in San Francisco Superior Court, Case No. CGC-15-549555; entitled <u>Angel</u> <u>Nguyen v. City and County of San Francisco</u>; the lawsuit involves an alleged personal injury at SFGH Wellness Center.
