9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Luis Adolfo Marquez v. Jimmy Denis
12 Ford, City and County of San Francisco, San Francisco Superior Court, Case No. CGC-16-
13 554676 by the payment of \$150,000. The lawsuit involves an alleged personal injury on a
14 City street.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 October 5, 2016, and the following parties were named in the lawsuit: Plaintiff: Luis Adolfo
17 Marquez; Defendants: Jimmy Denis Ford, City and County of San Francisco.




