

Modification Number 01 to Memorandum of Agreement Number MYOSESS001 Between

City and County of San Francisco
San Francisco Public Utilities Commission

and

National Park Service Yosemite National Park

for

Comprehensive Management of Watersheds Supplying the San Francisco Regional Water System within Yosemite National Park

GENERAL

This Memorandum of Agreement (MOA) is modified to extend the end date of the agreement from July 1, 2018 to July 1, 2020. The end date extension modifies the term of the agreement from 2 years to 4 years. Appendix D is replaced to reflect the funding request submitted to the San Francisco Public Utilities Commission (SFPUC) for fiscal year (FY) 2018-19 through FY 2019-2020.

MODIFICATIONS:

1. ARTICLE IV - E. - CALENDAR, paragraph 3 on pages 20-21 of 37 currently reads:

Quarterly reports for each program are due to the SFPUC January 15, April 15, July 15, and October 15 of each year. The NPS Program Managers and HHWP Division Manager (or designee) meet in Yosemite National Park in March and November, and in Moccasin in May and August for program coordination.

Paragraph 3 is modified to:

Quarterly reports for each program are due to the SFPUC on January 31, April 30, July 31, and October 31 of each year. The Annual Report shall be due on February 28 of each year. The NPS Program Managers and HHWP Division Manager (or designee) shall meet in Yosemite National Park in March and November, and in Moccasin in May and August for program coordination.

2. ARTICLE V – NPS BUDGET REQUEST, paragraph 4 on page 22 of 37 currently reads:

The total agreement cost shall not exceed \$12,326,507 (twelve million three hundred twenty six thousand five hundred seven) for the two-year term. Significant capital improvement projects, unanticipated projects, or other incurred costs may also be developed and entered into during this time period under separate written agreements.

Paragraph 4 is modified to read:

The total agreement cost shall not exceed \$26,904,364 (twenty six million, nine hundred thousand, three hundred sixty four) for the four-year term. Significant capital improvement projects, unanticipated projects, or other incurred costs may also be developed and entered into during this time period under separate written agreements.

3. ARTICLE VII - TERM OF AGREEMENT, paragraphs 3 and 4 on page 23 of 37 currently reads:

This MOA shall become effective on the date of the last signature and extend through July 1, 2018. If signed after July 1, 2016, the agreement will be retroactive to July 1, 2016.

The NPS shall have three months beyond the end date of July 1, 2018 of the MOA to reconcile all expenditures incurred on or before June 30, 2018. No additional funds are authorized to be spent or received, nor expenses incurred, after June 30, 2018. The three month reconciliation grace period, with an end date of October 1, 2018, allows for full reconciliation of expenditures incurred before July 1, 2018.

Paragraphs 3 and 4 are modified to read:

This MOA shall become effective on the date of the last signature and extend through July 1, 2020.

The NPS shall have six months beyond the end date of July 1, 2020 of the MOA to reconcile all expenditures incurred on or before June 30, 2020. No additional funds are authorized to be spent or received, nor expenses incurred, after June 30, 2020. The six month reconciliation grace period, with an end date of December 31, 2020, allows for full reconciliation of funds and all expenditures incurred before July 1, 2020.

- 5. All other terms and conditions remain the same.

Year 1 through Year 2 (FY 2016-17 to FY 2017-18) are included in the current MOU Agreement. Years 3 and 4 are included in Modification 1 to the Agreement. The FY 2018-20 amounts match the funding request submitted to the SFPUC as part of the FY 2018-19 and FY 2019-20 two-year budget request. Administrative costs are rolled into budgets at 5% and are not a line-item.
