

Ordinance authorizing settlement of the lawsuit filed by Robert Brown against the City and County of San Francisco for \$119,909; the lawsuit was filed on August 13, 2016, in United States District Court, Case No. 16-CV-04671; entitled <u>Robert Brown v. City and</u> <u>County of San Francisco et al.</u>; the lawsuit involves claims of alleged civil rights violation.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Robert Brown v. City and County of San Francisco, et al.</u>, United States District Court, Case No. 16-CV-04671 by the payment of \$119,909, which includes attorney's fees. The lawsuit involves alleged civil rights violations.
