#### RODNEY A. FONG

Rodney Fong is a native San Franciscan and was a third generation operator/owner of the Wax Museum at Fisherman's Wharf. He is the President of Fong Real Estate Company, overseeing the 100,000 square foot Wax Museum Entertainment Complex in the heart of Fisherman's Wharf. He is Director of the Fong Family Foundation, a philanthropic organization which benefits many worthwhile social services in San Francisco.

Rodney has been active and held office in a wide variety of civic, tourist and travel related organizations including the Fisherman's Wharf Community Benefit District (in which he was a founding member), Fisherman's Wharf Merchant's Association, The Bay Institute, Angel Island Immigration Station Foundation, SF Travel Association and CA Travel Industry Association.

Rodney has served for over four years on the San Francisco Port Commission, and voted its President in 2009.

Since 2010, Rodney has served on the San Francisco Planning Commission, including as President from 2012-2013 and 2015-2016 and Vice President in 2014. Currently, he serves as one of its seven Commissioners.

In 2012, as part of the Asian Pacific American Heritage Month, Rodney was honored by the City & County of San Francisco Board of Supervisors.

In 2013, negotiated a multi-year business and real estate lease transaction with Merlin Entertainments, the 2nd largest entertainment attraction in the world. Merlin invested \$35 million to develop the world famous Madame Tussauds Wax Attraction and SF Dungeon at the Wax Museum Entertainment Complex in Fisherman's Wharf.

In June of 2013, the Fisherman's Wharf Jefferson Street Public Realm Plan completed its phase one efforts with a ribbon cutting ceremony attended by Mayor Edwin Lee. This project started in 2005, with Rodney's leadership and coordination of over two hundred stakeholders in a community-driven private public partnership. Today, tens of millions of visitors to Fisherman's Wharf can enjoy these newly improved streets, which create a pedestrian and bicycle friendly area for all to enjoy.
