15 Section 1. The Board of Supervisors hereby adopts and implements Amendment No. 4  
16 to the 2014-2019 Memorandum of Understanding between the City and County of San  
17 Francisco and the International Federation of Professional and Technical Engineers, Local 21,  
18 to update the Union Security provision.

19 Amendment No. 4 to the MOU so implemented is on file with the Clerk of the Board of  
20 Supervisors in Board File No. 180614.


21 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
22 Resources to make non-substantive ministerial or administrative corrections to the MOU.

23 Section 3. Effective Date. This ordinance shall become effective upon enactment.  
24 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance

2 Supervisors overrides the Mayor's veto of the ordinance.


