No. 2 (Hoedown Yard, Pier 70) - Not to Exceed \$91,900,000] 2 Resolution authorizing issuance of bonds for City and County of San Francisco 3 4 Infrastructure and Revitalization Financing District No. 2 (Hoedown Yard, Pier 70) 5 therein in an aggregate principal amount not to exceed \$91,900,000; affirming the 6 Planning Department's determination and making findings under the California 7 Environmental Quality Act; and approving other matters in connection therewith. 8 9 WHEREAS, Under Chapter 2.6 of Part 1 of Division 2 of Title 5 of the California 10 Government Code commencing with Section 53369 ("IRFD Law"), the Board of Supervisors is 11 authorized to establish an infrastructure and revitalization financing district and to act as the 12 legislative body for an infrastructure and revitalization financing district; and WHEREAS, The Board of Supervisors has conducted proceedings under and pursuant 13 14 to the IRFD Law, to (a) form "City and County of San Francisco Infrastructure and 15 Revitalization Financing District No. 2 (Hoedown Yard, Pier 70)" ("IRFD"), pursuant to the 16 IRFD Law, (b) approve an infrastructure financing plan for the IRFD ("Infrastructure Financing" 17 Plan"), (c) provide a process for the future annexation of territory to the IRFD, (d) establish an 18 annual appropriations limit, as defined by subdivision (h) of Section 8 of Article XIII B of the 19 California Constitution, for the IRFD, and (e) authorize issuance from time to time of bonds or 20 other debt in one or more series for the IRFD for the purpose of financing certain facilities 21 ("Facilities") in the maximum aggregate principal amount of (i) \$91,900,000 (in 2017 dollars) 22 plus (ii) the principal amount of Bonds approved by the Board of Supervisors and the qualified 23 electors of the annexation territory in connection with the annexation of the annexation 24 territory to the IRFD, so long as the Board makes the finding specified in IRFD Law, Section 25

[Authorizing Issuance of Bonds Related to Infrastructure and Revitalization Financing District

1 53369.41(f), all as described in those proceedings; and

WHEREAS, The Board of Supervisors now wishes to provide for the issuance of one or
more series of bonds to finance the Facilities; and

WHEREAS, All conditions, things and acts required to exist, to have happened and to 4 5 have been performed precedent to and in the issuance of the bonds as contemplated by this 6 Resolution, have happened and have been performed in due time, form and manner as 7 required by the laws of the State of California, including the IRFD Law; now, therefore, be it 8 RESOLVED, That pursuant to the IRFD Law and this Resolution, the bonds entitled 9 "City and County of San Francisco Infrastructure and Revitalization Financing District No. 2 (Hoedown Yard, Pier 70) Tax Increment Revenue Bonds" ("Bonds") are hereby authorized to 10 be issued by the IRFD or by the City on behalf of the IRFD in one or more series, with a series 11 12 designation (such as "Series 20 A") to be appended to the designation thereof in an 13 aggregate principal amount not to exceed \$91,900,000 (in 2017 dollars); provided, that (i) the 14 aggregate principal amount does not include the principal amount of (A) any bonds or other 15 debt issued or incurred for the sole purpose of refunding the Bonds, funding a reserve fund for 16 such refunding bonds and paying related costs of issuance and (B) any bonds or other debt 17 issued or incurred for the sole purpose of refunding such refunding bonds, funding a reserve 18 fund and paying related costs of issuance, (ii) the Board of Supervisors may increase the 19 maximum aggregate principal amount described above by adopting a resolution modifying this 20 Resolution, (iii) the Bonds may be issued by IRFD or by the City on behalf of the IRFD; and, 21 be it

FURTHER RESOLVED, That the terms of the Bonds shall be as follows: (i) each Bond shall be dated its date of issuance, (ii) the maturity date of each Bond shall be a date not to exceed 30 years from the date of its issuance or such later date as is permitted by the IRFD Law and approved by the Director of the Office of Public Finance ("Director"), (iii) the Bonds

1 shall be issued in denominations of \$5,000 or any integral multiple of \$5,000 or such other 2 denomination determined by Director, (iv) the form of the Bonds shall be substantially the form 3 attached hereto as Appendix A, (v) the Bonds shall be executed by the Director, (vi) the principal of and interest on the Bonds shall be payable in lawful money of the United States of 4 5 America, (vii) the Bonds shall be registered with the trustee or fiscal agent for the Bonds 6 identified by the Director and shall be payable at the principal office of or by check or wire of 7 the trustee or fiscal agent for the Bonds and (viii) the Bonds shall be subject to redemption 8 prior to maturity at the times and subject to the premiums approved by the Director; and, be it 9 FURTHER RESOLVED, That the Board of Supervisors hereby approves the sale of one or more series of Bonds, provided, however, that the Bonds shall not be issued until such 10 time as (i) the Board of Supervisors has approved the terms of the sale to the investor(s) and 11 12 (ii) an Authorized Officer (as defined below) has caused the legal documents relating to the

13 Bonds and any related disclosure document describing the Bonds and the security for the

14 Bonds to be prepared and caused such documents to be submitted to the Board of

15 Supervisors for its approval; and, be it

16 FURTHER RESOLVED, That all actions heretofore taken by the officers and agents of 17 the City (including, but not limited to, the Mayor, the Controller, the Director of the Office of 18 Public Finance, the City Attorney, or such other official of the City as may be designated by 19 such officer (each, an Authorized Officer)) with respect to the establishment of the IRFD and 20 the sale and issuance of the Bonds are hereby approved, confirmed and ratified, and the 21 appropriate officers of the City are hereby authorized and directed to do any and all things and 22 take any and all actions and execute any and all certificates, agreements and other 23 documents, which they, or any of them, may deem necessary or advisable in order to consummate the transactions described in this Resolution; all actions to be taken by an 24 25 Authorized Officer, as defined herein, may be taken by such Authorized Officer or any

designee, with the same force and effect as if taken by the Authorized Officer; and, be it FURTHER RESOLVED, That the Director and the City Attorney are hereby authorized and directed to initiate a judicial validation action with respect to the IRFD and the Bonds pursuant to Code of Civil Procedure, Section 860 et seq.; and be it

FURTHER RESOLVED, That in the "Resolution of Intention to establish City and 5 6 County of San Francisco Infrastructure and Revitalization Financing District No. 2 (Hoedown 7 Yard, Pier 70) on land within the City and County of San Francisco commonly known as the 8 Hoedown Yard to finance the construction of affordable housing within Pier 70 and Parcel K 9 South; to provide for future annexation; to call a public hearing on September 11, 2018, on the formation of the district and to provide public notice thereof; determining other matters in 10 connection therewith; and affirming the Planning Department's determination, and making 11 12 findings under the California Environmental Quality Act," the Board of Supervisors made 13 certain findings under the California Environmental Quality Act about the Final Environmental 14 Impact Report for the Pier 70 Mixed-Use District Project, and those findings are incorporated 15 in this Resolution as if set forth in their entirety herein; and, be it

16 FURTHER RESOLVED, That if any section, subsection, sentence, clause, phrase, or 17 word of this Resolution, or any application thereof to any person or circumstance, is held to be 18 invalid or unconstitutional by a decision of a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions or applications of this resolution, the 19 20 Board of Supervisors hereby declaring that it would have passed this Resolution and each 21 and every section, subsection, sentence, clause, phrase, and word not declared invalid or 22 unconstitutional without regard to whether any other portion of this Resolution or application 23 thereof would be subsequently declared invalid or unconstitutional; and, be it FURTHER RESOLVED, That each of the Authorized Officers and any and all other 24 25

1	do any and all things and take any and all actions, including execution and delivery of any and			
2	all documents, assignments, certificates, requisitions, agreements, notices, consents,			
3	instruments of conveyance, warrants and documents, which they, or any of them, may deem

9	approved and confirmed by the Board of Supervisors; and, be it			
10	FURTHER RESOLVED, That this resolution shall take effect from and after its			
11	adoption. The provisions of any previous resolutions in any way inconsistent with the			
12	provisions hereof in and for the issuance of the Bonds as herein described are hereby			
13	repealed.

2 Principal of and interest on the Bonds (including the final interest payment upon 3 maturity or earlier redemption), is payable on the applicable Interest Payment Date by check of the Trustee (defined below) mailed by first class mail to the registered Owner thereof at 4 5 such registered Owner's address as it appears on the registration books maintained by the 6 Trustee at the close of business on the Record Date preceding the Interest Payment Date, or 7 by wire transfer made on such Interest Payment Date upon written instructions of any Owner 8 of \$1,000,000 or more in aggregate principal amount of Bonds delivered to the Trustee prior 9 to the applicable Record Date. The principal of the Bonds and any premium on the Bonds are payable in lawful money of the United States of America upon surrender of the Bonds at the 10 Principal Office of the Trustee or such other place as designated by the Trustee. 11

12 This Bond is one of a duly authorized issue of bonds in the aggregate principal amount 13 of \_\_\_\_\_ approved by resolution of the Board of Supervisors of the City, in its capacity as legislative body of the IRFD, on \_\_\_\_\_, 20\_\_ (the "Resolution"), under Chapter 2.6 of Part 1 14 15 of Division 2 of Title 5 of the California Government Code commencing with Section 53369 (the "IRFD Law") for the purpose of funding certain facilities authorized to be financed by the 16 17 IRFD and is one of the series of bonds designated "City and County of San Francisco 18 Infrastructure and Revitalization Financing District No. 2 (Hoedown Yard) Tax Increment Revenue Bonds, Series \_\_\_\_\_ " (the "Bonds"). The issuance of the Bonds and the terms and 19 20 conditions thereof are provided for by an Indenture of Trust, dated as of \_\_\_\_\_ 1, 20\_\_ (the 21 "Indenture of Trust"), between the City and the (the "Trustee") and this reference incorporates the Indenture of Trust herein, and by acceptance hereof the owner of this Bond 22 23 assents to said terms and conditions. The Indenture of Trust is authorized under, this Bond is issued under and both are to be construed in accordance with, the laws of the State of 24 California. 25

Pursuant to the IRFD Law, the Resolution and the Indenture of Trust, the principal of and interest on this Bond are payable solely from certain funds held under the Indenture of Trust and the "Tax Revenues," as defined in the Indenture of Trust. Any revenues for the payment hereof shall be limited to the Tax Revenues, except to the extent that provision for payment has been made by the IRFD, as may be permitted by law.

6 The Bonds are not a debt of the City or the State of California or of any of its political 7 subdivisions, other than the IRFD to the limited extent described herein, and none of those 8 entities, other than the IRFD to the limited extent described herein, shall be liable on the 9 Bonds, and the Bonds shall be payable exclusively from the Tax Revenues and the specified 10 funds held under the Indenture of Trust. The Bonds do not constitute an indebtedness within 11 the meaning of any constitutional or statutory debt limitation.

Optional Redemption. All of the Bonds are subject to redemption prior to their stated
 maturities, on any Interest Payment Date, in whole or in part, at a redemption price
 (expressed as a percentage of the principal amount of the Bonds to be redeemed) as set forth

- Notice of redemption with respect to the Bonds to be redeemed shall be given to the
  registered owners thereof, in the manner, to the extent and subject to the provisions of the
  Indenture of Trust. Notice of redemption may be conditional and may be rescinded as set
  forth in the Indenture of Trust.
- This Bond shall be registered in the name of the owner hereof, as to both principal and
  interest. Each registration and transfer of registration of this Bond shall be entered by the
  Trustee in books kept by it for this purpose and authenticated by its manual signature upon
  the certificate of authentication endorsed hereon.
- No transfer or exchange hereof shall be valid for any purpose unless made by the registered owner, by execution of the form of assignment endorsed hereon, and authenticated as herein provided, and the principal hereof, interest hereon and any redemption premium shall be payable only to the registered owner or to such owner's order. The Trustee shall require the registered owner requesting transfer or exchange to pay any tax or other governmental charge required to be paid with respect to such transfer or exchange. No transfer or exchange hereof shall be required to be made (i) fifteen days prior to the date

- The Indenture of Trust and the rights and obligations of the City thereunder may be
  modified or amended as set forth therein. The principal of the Bonds is not subject to
  acceleration upon a default under the Indenture of Trust or any other document.
