AMENDMENT No. 2 TO AGREEMENT FOR MAINTENANCE OF STATE HIGHWAYS IN THE CITY OF SAN FRANCISCO

This second amendment ("AMENDMENT No. 2") is dated ________, 2018 and is made to the Agreement for Maintenance of State Highways in the City and County of San Francisco dated July 2, 2009, and its First Amendment thereto dated October 27, 2011 ("AGREEMENT"), and entered into by and between the State of California, acting by and through the Department of Transportation, hereinafter referred to as ("STATE"), and the City and County of San Francisco, a municipal corporation, hereinafter referred to as ("CITY"), acting by and through its Public Works Director. CITY and STATE together are hereafter referred as ("PARTIES").

RECITALS:

"WHEREAS, the High-Intensity Activated Crosswalk pedestrian beacon system ("HAWK System") has been or will be installed on Sloat Boulevard (SR 35) at: Forest View Drive, 23rd Avenue, 36th Avenue, Constanso Way, El Mirasol Place, 26th Avenue, 21st Avenue; and on San Jose Avenue (SR 82) at: Goethe Street, Rice Street;

WHEREAS, Contract No. 1294, M-Ocean View Track Replacement Project at 19th Avenue (SR1) and Rossmoor Drive installed signals, low profile speed bumps, steel bollards, pedestrian barrier rail, signage, red concrete;

WHEREAS, Contract No. installed a trench for water, sewer and Auxiliary Water Supply System utilities; compliant with CITY standards, as shown in Exhibit C ("CITY Trench Details"), but not compliant with STATE standard specifications;

WHEREAS, PARTIES hereto now agree to amend AGREEMENT to specify the allocation of maintenance responsibilities, liability and indemnity regarding the construction and use of the CITY Trench Details.

NOW, THEREFORE, PARTIES agree to amend AGREEMENT as follows:

- 1. The AGREEMENT; page 3, dated May 4, 2009 is hereby deleted and replaced by page 3a and page 3b (REVISED).
- 2. EXHIBIT "A"; page 5, dated July 2, 2009 of AGREEMENT is hereby deleted and replaced by EXHIBIT "A" (REVISED); page 5.
- 3. EXHIBIT "A"; page 8, dated July 2, 2009 of AGREEMENT is hereby deleted and replaced by EXHIBIT "A" (REVISED); page 8.
- 4. EXHIBIT "B"; page 1, dated July 2, 2009 of AGREEMENT is hereby deleted and replaced by EXHIBIT "B" (REVISED); page 1.
- 5. EXHIBIT "B"; page 4, dated July 2, 2009 of AGREEMENT is hereby deleted and replaced by EXHIBIT "B"; page 4a and 4b (REVISED).
- 6. EXHIBIT "B"; page 5, dated July 2, 2009 of AGREEMENT is hereby deleted and replaced by EXHIBIT "B"; page 5a and 5b (REVISED).

- 7. New EXHIBIT "C" is hereby added to and made a part of AGREEMENT.
- 8. All other terms and conditions of AGREEMENT shall remain in full force and effect.
- 9. AMENDMENT No. 2 is hereby deemed to be included and is made a part of AGREEMENT.

- XI. Neither CITY nor any officer or employee thereof is responsible for any injury, damage or liability occurring by reason of anything done or omitted to be done by STATE under or in connection with any work expressly conferred upon STATE by this Agreement. It is understood and agreed that STATE shall fully defend, indemnify and save harmless CITY and all its officers and employees from all claims, suits or actions of every name, kind and description brought forth under, including, but not limited to tortious, contractual, inverse condemnation and other theories or assertions of liability occurring by reason of anything done or omitted to be done by STATE under or in connection with any work expressly conferred upon STATE by this Agreement.
- XII. STATE costs and expenses pledged to pay CITY under the terms of this Agreement are conditioned upon the passage of the Annual State Budget Act by the Legislature, the allocation of funding by the California Transportation Commission as appropriate, and the encumbrance of STATE funding to pay CITY's invoices.

XIII.

- A. This Agreement shall remain in full force and effective until amended by the mutual consent of the parties thereto or terminated by either party upon thirty (30) days' notice to the other party.
- B. Notwithstanding, paragraph XIII (A), all provisions of this Agreement relating to SPECIFIED STATE ROUTES, including but not limited to, any duties under paragraphs III, VI, X, XI, XV, XVI, and XVII, shall remain in full force and effect, until amended or terminated upon mutual consent of the CITY and STATE.
- XIV. Pursuant to Board of Supervisors Resolution No. 380-15, the CITY executed that certain Operations and Maintenance Agreement with the City and County of San Francisco for Bus Rapid Transit Facilities on State Route 101 (the "BRT Operations and Maintenance Agreement"). As acknowledged in the BRT Operations and Maintenance Agreement, this Agreement is separate from, and does not modify the terms of the BRT Operations and Maintenance Agreement.

XV.

A. CITY will not accept STATE standard slurry cement backfill requirements for water, sewer, and Auxiliary Water Supply System (AWSS) utilities ("STATE Trench Detail") due to concerns that the material is not compatible with CITY's future maintenance and servicing of new connections. The STATE Trench Detail will cost utility companies more to perform maintenance and service new connections and will cause more disruption to the public due to longer lane closures needed to remove and replace slurry concrete.

Pursuant to the terms of the applicable encroachment permits issued by the STATE and the terms of this agreement the CITY may use CITY Water, Sewer, and AWSS Trench Detail ("CITY Trench Details"), attached as Exhibit C, as specified on projects 04-3A270, 04-4J790, 04-0G350, on SPECIFIED STATE ROUTES.

B. Notwithstanding any other provision of this Agreement, the CITY shall be responsible for performing the maintenance and repair of SPECIFIED STATE ROUTES for all failures or defects of the roadway infrastructure resulting from the construction and use of the CITY- Trench Details (Exhibit C).

STATE shall provide reimbursements for routine maintenance of SPECIFIED STATE ROUTES as provided for in Exhibit A, but shall not reimburse CITY for maintenance and repair of conditions resulting from the construction and use of the CITY Trench Details.

- XVI. Notwithstanding any other provision of this Agreement, the CITY shall be solely responsible for all costs for the reconstruction of SPECIFIED STATE ROUTES for all failures or defects resulting from the construction and use of the CITY Trench Details, attached as Exhibit C, including but not limited to sinkholes, failure of compacted soils, and structural failure of the roadway resulting from the construction and use of the CITY Trench Details.
- XVII. CITY shall fully defend, indemnify, and save harmless, STATE its officers, directors, agents, and employees for any injury, claim, damage, or liability occurring as the result of any condition or defect of SPECIFIED STATE ROUTES, resulting from the construction and use of the CITY Trench Details (Exhibit C), including but not limited to, failures of the compacted soils, sinkholes, potholes, cracking, and structural failure of the roadway resulting from the construction and use of the CITY Trench Details. It is understood by and between CITY and STATE that the CITY's duty to defend, indemnify and save harmless under this section extends to any injury, claim, damage, or liability whether said injury, claim, damage, or liability is alleged to have been caused by a failure to maintain or a failure of design and construction.
- XVIII. SPECIFIED STATE ROUTES shall be defined as the locations identified on Exhibit C. For all locations listed on Exhibit C, this agreement shall apply to all portions of the STATE's right-of-way between the listed post miles.






