AMENDED IN COMMITTEE 6/21/18 ORDINANCE NO. **191-18**

[Park Code - Golf Course Fees]

Ordinance amending the Park Code to permit the Recreation and Park Department General Manager to set all golf course fees and charges other than resident rates and certain tournament rates by flexible pricing based on certain factors; increase the allowable flexible pricing discount that is available to residents; establish a resident rate for the Gleneagles Golf Course <u>equal to the current rate plus \$2 per nine holes</u>; authorize automatic annual cost of living increases for all resident rates and tournament rates; create a \$2 per nine hole fee for each golf course <u>except Gleneagles</u> <u>Golf Course</u> to fund <u>special maintenance repairs or</u> course improvements; expand the Harding Park advance booking fee to all other golf courses; and, further, affirming the Planning Department's determination under the California Environmental Quality Act.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 180582 and is incorporated herein by reference. The Board affirms this determination.

Section 2. The Park Code is hereby amended by revising Sections 12.12, 12.12.1, 12.12.2, 12.12.3, 12.12.4, 12.12.5, 12.12.6, and 12.20 to read as follows:

SEC. 12.12. GOLF FEES – GENERAL.

(a) **Authorization.** The Recreation and Park Department (the "Department") is hereby authorized to charge fees at the San Francisco municipal golf courses at Harding Park, Fleming, Lincoln Park, Sharp Park, Golden Gate Park, and McLaren Park (collectively, the "Golf Courses") in the manner and in conformance with the standards set forth herein. The Department and the Controller shall adjust golf fees in accordance with Section 12.20 of this Article <u>12</u>.

(b) Discount Fee Categories.

(1) Bay Area Rates shall apply to residents of the following Bay Area counties who provide proof of residency: San Francisco (for residents without a valid Resident Golf Card), Alameda, Contra Costa, Marin, Napa, San Mateo, Santa Clara, Santa Cruz, Solano and Sonoma.

(1)(2) <u>Resident</u> Junior Rates shall apply to persons 17 years of age and under holding Resident Golf Cards.

(2)(3) Resident Rates shall apply to persons holding Resident Golf Cards *per subsection (c) below*.

(3)(4) Resident Senior Rates shall apply to persons 65 years of age and above holding Resident Golf Cards-*per subsection (c) below*.

(4)(5) Tournament Rates. Tournament Rates.

(A) <u>Tournament Rates shall apply to persons playing in the Family Tournament</u> <u>held at Golden Gate Park, the City Championship held at Lincoln Park and Harding Park, and any</u> <u>other City-sponsored tournament approved by the Department General Manager or his or her</u> <u>designee.</u> Residents shall pay Tournament Rates, not Resident Rates, for tournament play.

(B) *A*-Junior Tournament Rate<u>s are equal to</u>, applicable to a group of 16 or more players aged 17 years and under, shall be 50% percent of the regular Tournament Rate, andfor the applicable course. The Junior Tournament Rate shall apply to <u>all players aged 17 years</u> and under who are juniors participating in the Family Tournament <u>held at Golden Gate Park, and</u> or the City Championship-held at Lincoln Park and Harding Park, and to all groups of 16 or more players aged 17 years and under with respect to any other City-sponsored tournaments that the Department may approve pursuant to subsection (b)(4)(A).

(5)(6) <u>Resident</u> Twilight Rates shall apply to rounds <u>by persons holding Resident</u> <u>Golf Cards that</u> commenc<u>eing</u> no earlier than four hours before sunset, as determined by the Department.

(c) Resident Golf Cards.

(1) The Department shall charge a fee of \$90.00 for a San Francisco Resident Golf Card, entitling the holder to discounts (Resident Rates) on the Golf Courses for two years from the date of issuance. Cards shall be available to San Francisco residents and/or San Francisco property owners only upon presentation of valid proof of residency or ownership.

(2) The Department shall charge a fee of \$60.00 for a Pacifica Resident Golf Card entitling the holder to discounts (Resident Rates) at the Sharp Park Golf Course only, for two years from the date of issuance. Cards shall be available to Pacifica residents only upon presentation of valid proof of residency.

(3) The Department shall charge a fee of \$25.00 for replacement of San Francisco <u>Resident Golf Cards</u> and Pacifica Resident Golf Cards.

(4) If a San Francisco or Pacifica resident <u>*golf*</u> card application is returned to the applicant because the information on the application is incorrect or incomplete, there shall be an additional administrative fee of 5.00.

(d) Flexible Pricing.

	(2) There shall be no fee for a motorized golf cart for

	(B) persons paying either Standard or Tournament Rates at Harding Park.			
	(e)(f) Reservations. _A \$1.00 per person fee shall be charged for reservations made by phone			
	or online seven days or less in advance of the reserved tee time for any of the Golf Courses. <u>The</u>			

Department may charge persons holding any category of Resident Golf Cards an additional reservation fee of \$15 per reservation for any advance reservation made between 8 and 30 days before the reserved tee time, and may charge persons who do not hold a Resident Golf Card an appropriate reservation fee based on the flexible pricing standards set forth in subsection (d)(1).

(f) <u>Special Projects</u> Maintenance Fee. The Department shall require each player at Harding Park, Fleming, Lincoln Park, Sharp Park, and Golden Gate Park who is above the age of 17 to pay an additional fee for that Golf Course of \$2 per nine holes, which the Department shall set aside in a separate fund for that Golf Course to pay for <u>special maintenance repairs or</u> course improvements.

(b) **Replay Rate.** A same-day replay rate is available to golfers <u>holding a Resident Golf</u> <u>Card</u> who complete an 18-hole round <u>for the following fee categories only: Standard, Bay Area and</u> <u>Resident</u>. The replay rate shall be 30<u>% percent</u> of the originally purchased round. The replay round must be used by the purchaser of the full price round. Replay rounds may not be reserved in advance.

(c) Reservation Premiums. A \$10.00 per person fee shall be charged for advance tee times scheduled eight days or more in advance of the tee time.

(d) Practice Range. The following fees shall be charged for a bucket of balls for use at the Driving Range:

Small bucket (25-30 balls)	\$7.00
Medium bucket (45-50 balls)	\$9.00
Large bucket (70-75 balls)	\$12.00

(e) Shotgun Tournament (120 players or more). The following fees shall apply in addition to the regular Tournament Rate:

(1) Weekday Shotgun (per player) - \$10.00

(2) Weekend Shotgun (per player) - \$15.00

(f) Accompanying Rider Rate. The fee for non-golfers riding in a motorized cart shall be \$25.00 per person.

(b)(c) **The Family Tournament.** The Family Tournament has been hosted at Golden Gate Park Golf Course for over 50 years and is open to everyone. The Family Tournament is a group of 16 or more players composed of two family members alternating shots, playing two rounds of nine holes. The Junior Tournament Rate shall be applicable only to team members 17 years old and younger. The fee per team shall be the sum of the fees for one round of the applicable Tournament Rate per person per day.

SEC. 12.20. ADJUSTMENT OF FEES.

(a) Beginning with fiscal year 2003-2004, fees set forth in this Article 12, unless otherwise specified, may be adjusted each year, without further action by the Board of Supervisors, to reflect changes in the relevant Consumer Price Index (CPI), as determined by the Controller.

No later than April 15th of each year, the Recreation and Parks Department shall submit its current fee schedule to the Controller, who shall apply the price index adjustment to produce a new fee schedule for the following year.

No later than May 15th of each year, the Controller shall file a report with the Board of Supervisors (i) reporting the new fee schedule, and (ii) identifying any fees that produce revenue which is significantly more than the costs of providing the services for which each fee is assessed and describing how such revenue is used by the Department or the City.

(b) <u>Through and until fiscal year 2017-18, all</u> All golf fees for San Francisco residents, juniors, seniors may be increased annually by the CPI, or up to \$1.00, upon approval of the Recreation and Park Commission-<u>; and all</u> All golf fees for non-S.F. residents and tournaments may be increased by two times (2X) the CPI, or up to \$1.00, whichever is greater, upon approval of the Recreation and Park Commission. <u>Beginning with fiscal year</u> 2018-19, all fees or charges specifically listed in Sections 12.12 through 12.12.6 will may be adjusted pursuant to subsection (a) based on the rates most recently approved by the Board of Supervisors or most recently adjusted under this Section 12.20, as applicable.

Section 3. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.


