

1 [2011 Airport Lease and Use Agreement - Air India Limited]

3 **Resolution approving the terms of 2011 Lease and Use Agreement No. 17-0183**  
4 **between the City and County of San Francisco, acting by and through its Airport**  
5 **Commission, and Air India Limited to conduct flight operations at San Francisco**  
6 **International Airport, for the lease term to commence following Board approval through**  
7 **June 30, 2021.**

9 WHEREAS, Air India Limited ("Air India") currently conducts flight operations at  
10 San Francisco International Airport (the "Airport") pursuant to Airline Operating and Space  
11 Permit No. 4488; and

12 WHEREAS, The City and County of San Francisco, acting by and through its Airport  
13 Commission ("City"), has entered into a 2011 Lease and Use Agreement ("2011 Lease")  
14 with 52 airlines effective July 1, 2011, for a term of ten years, to provide for the continuation  
15 of flight operations and terminal rental by such airlines at the Airport; and

16 WHEREAS, Air India now desires to become a signatory to the 2011 Lease, which  
17 grants it the right to conduct flight operations with City under the same terms and conditions  
18 as other signatory airlines, except that the term will be approximately three years and seven  
19 months to commence on the first day of the month following full approval by the City; and

20 WHEREAS, Air India does not rent any exclusive space but will use the International  
21 Terminal Joint Use Spaces and support facilities, as summarized on Attachment A; and

22 WHEREAS, On July 25, 2017, the Airport Commission adopted Resolution  
23 No. 17-0183 approving a 2011 Lease with Air India; and

1           WHEREAS, A copy of the 2011 Lease is on file with the Clerk of the Board of  
2 Supervisors in File No. 171081, which is hereby declared to be a part of this resolution as if  
3 set forth fully herein; now, therefore, be it

4           RESOLVED, That this Board of Supervisors approves 2011 Lease No. 17-0183 with  
5 Air India Limited; and, be it

6           FURTHER RESOLVED, That this Board of Supervisors authorizes the Airport Director  
7 to enter into non-material modifications to the Lease, including changes to the demised  
8 premises of not to exceed ten percent (10%) of the lease square footage, that the  
9 Commission, in consultation with the City Attorney, determines are in the best interest of the  
10 Commission and necessary to effectuate the purposes of the 2011 Lease and are in  
11 compliance with all applicable laws, including the City's Charter; and, be it

12           FURTHER RESOLVED, That within 30 days of the 2011 Lease being fully executed by  
13 all parties, the Airport Commission shall provide a copy of the final 2011 Lease to the Clerk of  
14 the Board for inclusion into the official file.
