

1 [Contract Amendment - InterVision Systems LLC - Technology Marketplace, Tier 1B -
2 \$32,000,000]

3 **Resolution authorizing the Office of Contract Administration to enter into the Fifth**
4 **Amendment of the contract agreement between the City and County of San Francisco**
5 **and InterVision Systems LLC, a Technology Marketplace, Tier 1B Specialist contractor,**
6 **to increase the contract limit from \$30,000,000 to \$32,000,000, with no change to the**
7 **length of term for the period of October 1, 2014, through September 30, 2018, with the**
8 **option to extend for up to one year.**

10 WHEREAS, The Office of Contract Administration, by competitive bidding, developed
11 the Technology Marketplace procurement method for the purchase of products and services
12 related to Information Technology; and

13 WHEREAS, InterVision Systems LLC is one of the vendors who is part of the
14 Technology Marketplace, Tier1B Specialists; and

15 WHEREAS, The original contract with InterVision Systems Technologies, Inc. dated
16 October 1, 2014, has a term of three years through September 30, 2017, with options to
17 extend the term through September 30, 2019, and has an original contract amount of
18 \$12,000,000; and

19 WHEREAS, The Board of Supervisors approved the original contract on October 1,
20 2014 by Resolution No. 362-14; and

21 WHEREAS, The Board of Supervisors approved the First Amendment to the contract
22 on June 14, 2016 by Resolution 238-16 to increase the contract amount from \$12,000,000
23 to \$15,000,000; and

1 WHEREAS, The Office of Contract Administration approved the Second Amendment
2 to the contract on November 30, 2016 to increase the contract amount from \$15,000,000 to
3 \$15,499,000; and

4 WHEREAS, The Board of Supervisors approved the Third Amendment to the
5 contract on February 14, 2017, by Resolution No. 41-17 to increase the contract amount
6 from \$15,499,000 to \$30,000,000; and

7 WHEREAS, The Office of Contract Administration approved the Fourth Amendment
8 to the contract on September 1, 2017, to extend the contract by one year through to
9 September 30, 2018; and

10 WHEREAS, The Office of Contract Administration approved an Assignment and
11 Novation Agreement on March 29, 2018 wherein InterVision Systems Technologies, Inc.
12 transferred its rights and responsibilities under the contract to InterVision Systems LLC.

13 WHEREAS, The Office of Contract Administration estimates that the money
14 projected to be spent with InterVision Systems LLC could reach the contract's limit in the
15 reasonably near future; and

16 WHEREAS, Charter, Section 9.118(b) "Contract and Lease Limitations," requires the
17 Board of Supervisors to approve any contract estimated to exceed \$10,000,000 in
18 expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be it

19 RESOLVED, That the Board of Supervisors authorizes the Purchaser and the Director
20 of the Office of Contract Administration to enter into the Fifth Amendment to the contract with
21 InterVision Systems LLC., in substantially the form attached to increase the contract limit from
22 \$30,000,000 to \$32,000,000; and, be it

23 FURTHER RESOLVED, That within thirty (30) days of the Third Amendment being fully
24 executed by all parties, the Office of Contract Administration shall provide the final Fifth
25 Amendment to the Clerk of the Board for inclusion into the official file.


