Section 2. The above-named action was filed in San Francisco Superior Court on January 26, 2018, and the following parties were named in the lawsuit: Plaintiff Charleen Maghzi, individually and as trustee of the Maghzi Family Marital Trust and Defendant City and County of San Francisco.

Section 3. The source of funding herein appropriated for use by the San Francisco Public Utilities Commission (SFPUC) for purposes of this settlement payment is \$661,738.59 from the SFPUC Water Enterprise fund balance, with the remainder of the settlement to be paid from a prior appropriation for Casitas Properties, PS Project ID 10015445.
