Ike Kwon Biography



Ike Kwon is a native Chicagoan but has returned to San Francisco, the city in which his father first arrived after leaving post-war Korea in the 1950s. He currently serves as the Chief Operating Officer and Head of Government Affairs at the California Academy of Sciences where he oversees the daily functions of the Academy, including public and facility operations, security and safety, information technology, government affairs and community relations.

Ike serves his community through a number of appointments and volunteer activities, including the Inner Sunset Green Benefits District Formation Committee and the San Francisco Travel Association Board of Directors. He is involved with Friends of the Urban Forest as District 4 Front Yard Ambassador, and volunteers at Cornerstone Church in the Mission. Ike provides free martial arts instruction to neighborhood children in the Sunset.

Prior to moving to San Francisco, Ike held leadership positions at the Walt Disney Company; the Museum of Science and Industry; and Starwood Lodging. While in Chicago, he was a homeless advocate for Breakthrough, opening their first homeless shelter in 1997 and eventually serving on their Board of Directors.

Ike was a Cook Scholar at the University of Chicago where he earned a degree in Public Policy. He lives in the Sunset with his wife and two children.
