

Anson Moran Biography



Anson Moran brings more than four decades of experience with the City and County of San Francisco and water, wastewater and power issues, including 17 years of leadership positions within the San Francisco Public Utilities Commission (SFPUC). From 1993 to 2000, he served as General Manager of the SFPUC, overseeing the reorganization of the agency that removed Muni and added the Clean Water Program (Wastewater) to the agency's operations.

From 1988-1993, he held the post of General Manager of Hetch Hetchy Water and Power and previously served as Assistant General Manager for Finance. In his years at the SFPUC and as a founding member of California Urban Water Agencies, Commissioner Moran was instrumental in fostering greater cooperation among Bay Area water agencies and elevating the SFPUC to a position of national utility leadership.

Commissioner Moran has also served as Senior Policy Advisor to U.S. Senator Dianne Feinstein with a focus on San Francisco Bay-Delta issues. Until recently he maintained a consulting practice providing water resource development services. He holds a Bachelor of Science degree in Electrical Engineering from Worcester Polytechnic Institute and a Masters in Urban Studies from Occidental College.
